The nature of these sports, however, makes it impossible to foresee and protect the participant from all conceivable dangers associated with water and water sports. Once the participant leaves the safety of the shore and enters the water, he/she must be prepared to assume all risks associated therewith.

I hereby agree to indemnify and hold harmless Bucerias SUP Experience, and staff from any and all liability for any harm, injury, death, or damages (physical, mental, or monetary), regardless of fault or negligence, which may befall me while participating in this program or while using Bucerias SUP Experience services. This release shall be binding upon my family, heirs, and administrators.
3. The undersigned here by certifies that the Client/Renter is a proficient swimmer and agrees for the Client/Renter to be tested by the Bucerias SUP Experience to determine the Client/Renter's level of swimming proficiency if requested. Client/Renter agrees to wear a life vest.
4. I hereby agree to heed at all times the advice and instructions of Bucerias SUP Experience staff and to practice common sense water safety procedures.

To the extent provided by State Law, I also freely and voluntarily waive all claims for damages or loss to my person or property, or the person or property of third parties, that may be caused by an act, or failure to act, of the Bucerias SUP Experience or its owner and employees, and release the Bucerias SUP experience from any and all claims.
