I will be responsible for any and all cost of medical attention and treatment.

NO SCHOOL SPONSORSHIP: I, the undersigned, hereby acknowledge and understand that Charlotte Fury/LaxTribe.com is a privately run athletic team and is not operated by or through the Fort Mill Schools. The Charlotte Fury/LaxTribe.com is neither sponsored, controlled, nor supervised by the either of those parties, but rather is under the sole sponsorship, control and supervision of Charlotte Fury/LaxTribe.com and the Director/Coach Gregory Allen.

I, the undersigned, for ourselves, our heirs, our executors and administrators, waive, release and forever discharge the any schools, where Charlotte Fury events may take place and Charlotte Fury/LaxTribe.com, its staff, officers, agents, employees, representatives, successors and assigns from any liability, claims, demands, actions and causes of actions whatsoever arising out of or related to any loss, personal injury or property damage that may be sustained or occur watching or during participation in travel team activities or while at tournaments.

I also attest that my player referenced above has had a physical examination in the past 12 months and has been cleared by physician to participate in athletic activities without any restrictions. This physical is on file with his physician, at his high school or at our home.

For the purposes of this document, herein after referred to as "Release," the party intending to participate (or his parent/guardian) in the activity on any school grounds shall hereafter be referred to as "Participant." Any schools, and its trustees, officers, employees and agents, acting within the course and scope of their duties, shall hereafter be referred to as "The School." Charlotte Fury/LaxTribe.com, and its trustees, officers, employees and agents, acting within the course and scope of their duties, shall hereafter be referred to as "The Program". The activity on the schools grounds that the Participant will participate in shall hereafter be referred to as the "Activity."

- 1. Release, Waiver of Liability, and Assumption of Risk:** In consideration of the opportunity afforded Participant to participate in the Activity on the School's grounds Participant hereby releases and forever discharges the School and the Program from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from or in connection with the Activity. Participant understands that this Release discharges the School and the Program from any liability or claim that Participant may have against the School or the Program with respect to any bodily injury, personal injury, illness, death, property loss, or property damage that may result from participation in the Activity. Participant understands and acknowledges that potential risks to health and personal property may be associated with participation in the Activity, and Participant voluntarily assumes those risks.
- 2. Medical Treatment and Preexisting Medical Conditions:** Participant hereby releases and forever discharges the School and the Program from any liabilities, claims, costs and damages that arise or may hereafter arise on account of any first aid, medical treatment, or service rendered to Participant in connection with the Activity. Participant will take for himself/herself any appropriate precautions or medications to treat and/or reduce the likelihood of exacerbating any pre-existing health conditions, or insect, food or medication allergies. Participant also hereby gives permission for the staff of the Activity to seek during the period of the Activity appropriate medical attention for the Participant in the event of

accident, injury, or illness. Participant will be responsible for any and all costs of medical attention and treatment.

3. **Other:** This Release shall be binding and legally enforceable against Participant and Participant's heirs, executors, administrators, and legal representatives. This Release shall be governed by and interpreted in accordance with the laws of the State of South Carolina. In the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.

Waiver & Code of Conduct

- A. **Player's Code Of Conduct.** Purpose: The Charlotte Fury/LaxTribe.com Organization seeks to provide a great lacrosse experience for all its players, parents, and coaches. We believe that how the game is played is even more important than winning itself. In pursuit of this goal, we have adopted this Code of Conduct and Sportsmanship policy. Players: As a member of a team and an organization your actions reflect on your teammates and the rest of our organization. You are expected: To play the game for the game's sake; for the fun of it. To treat your coach, teammates, officials and opponents with respect. To avoid inappropriate behavior during, games. To control your emotions. To attempt to win through your skills, effort and tactics; to always be fair. To take victory modestly and defeat graciously. To adhere to the rules of the game & confirm to the rules established by The Charlotte Fury/LaxTribe.com.
- B. **Medical Treatment.** I hereby consent to my child participating for Charlotte Fury Lacrosse. I consent and grant permission to the coach and / or assistant coach, or any authorized The Charlotte Fury official, to obtain any medical care necessary as a result of injuries sustained by my child in this activity. Photo Release & Waiver. I hereby grant The Charlotte Fury and its successors, assigns and licensees, permission to use pictures taken of my child in publications and other media use, exhibit and display my child's picture in connection with any public materials produced by or for The Charlotte Fury organization. This permission is freely given without remunerative consideration of any kind.
- C. **Armature Athletic Waiver and Release of Liability.** In consideration of being allowed to participate in any way for The Charlotte Fury/LaxTribe.com, the undersigned parent(s) or legal guardian(s): 1. Agree to instruct the minor participant that prior to participating, he/she should inspect the facilities and equipment to be used, and if the participant believes that anything is unsafe, he/she should immediately advise his coach or supervisor of such condition(s) and refuse to participate. 2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which may result not only from their own action, inaction, or negligence, but action, inaction or negligence of others, the rules of play, or condition of the premises or any equipment used. Further, that there may be other risks not known to us or reasonably foreseeable at this time. 3. Assume all of the above risks and accept full personal responsibility for the damages following any such injury, permanent disability, or death. 4. Release, waive, discharge, and promise not to sue and otherwise agree to hold harmless, The Charlotte Fury/LaxTribe.com as well as, sponsors, managers, coaches, participants and other person associated with the program, and owners / lessors of premises used to conduct the event from any and all liability for injuries sustained by my child in this activity.
- D. **Refund Policy.** I hereby verify by my signature that due to the nature and expense of pre-planned events, tournaments, camps, clinics, workshops, and select teams, The Charlotte Fury/LaxTribe.com has a policy of no refunds.
- E. **Parent's Code of Conduct:** The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles: trustworthiness, respect, responsibility, fairness, caring, and good citizenship. The highest potential of sports is achieved when competition reflects

these "six pillars of character." As a parent or spectator: I will remember that children participate to have fun and that the game is for youth, not adults. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures. I will not encourage any behaviors or practices that would endanger the health and well being of the athletes. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of a game or his performance. I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place. I will demand a sports environment for my child that is free from drugs, tobacco, and alcohol and I will refrain from their use at all sports events. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.
