Limited Proxy Voting Instructions

If you are unable to attend the Meeting and wish to vote by limited proxy, please note the following information:

- 1. A limited proxy is for the purpose of appointing another person to vote for you as you specifically direct in the event you are not able to attend the Meeting and for quorum purposes. Your limited proxy must be signed by all owners of the unit or the one among them designated on a voting certificate. If you cannot attend the Meeting, we request that you cast your vote by using the enclosed limited proxy Form.
- 2. Every limited proxy shall be revocable and shall automatically terminate after completion of the Meeting for which the limited proxy was filed, any adjournments thereof, and in no event more than ninety days from the original date of the Meeting.
- 3. The limited proxy can be mailed or hand-delivered. The Association is not responsible for mail-related delays and/or for the timely submission of your limited proxy. Your limited proxy can be submitted at the meeting or the address below *before* the Meeting scheduled on Thursday, October 30, 2025, at the Hilton Garden Inn.
