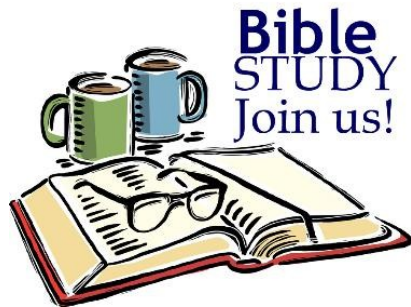

## December 14, 2025 Meeting of the SVLC Council

Council members present: Aiden Mosher, Diane Johnson, Virgil Binkley, Jim Beck, and Rick Arnold

Council members absent: Clint Watson, Dave Rowell, and Julie Mikula

Others attending the meeting: Treasurer Mike Colbert, Assistant Treasurer Lisa Rowell, and Steve Ward, SAM

The meeting was called to order at 11:20 am by President Rick Arnold. Steve Ward led the council in prayer.

### **Church member comments:**

Mike Colbert asked if the children's message presenter could use a microphone. Steve Ward made and Diane Johnson seconded a motion to purchase a second headset wireless microphone. The motion passed.

Steve Ward made a motion to accept the minutes of the November 9, 2025 regular-meeting. The motion was seconded by Virgil Binkley and passed.

### **Treasurer's report:** Mike Colbert reported:

The November offering was \$7082 and other income was \$1204. Church expenses were \$7860, with \$2200 of that for tree removal and \$695 pass through for the Cat/Griz offering and to WELCA.

The monthly rent was \$2660 with expenses of \$1357, with \$1007 of that for taxes

The end of November checking balance was \$6096. The money market balance was \$22,606, with \$3000 of that encumbered. The MIF CD balance was \$250,000, with \$30,000 of that in a plumbing reserve.

Steve Ward moved to accept the treasurer's report, Diane Johnson seconded the motion, and it passed.

Treasurer Colbert presented proposed 2026 church and rental budgets to the council. After adjustments for supply pastors and rent income (see Continuing Business and Council Member Concerns), Steve Ward made and Diane Johnson seconded a motion to present the proposed budgets to the congregation at the annual meeting. The motion passed.

**SAM Report:** Steve Ward noted that there was potential for 4 infant/youth baptisms in the few months.

**Call Committee Report:** Jim Beck said that he, Steve Ward, and several leaders from New Life met with Bishop Quanbeck. According to Bishop Quanbeck, there are not any potential seminary graduates available this year for the New Life/SVLC opening. The Bishop presented a couple of long-term strategies to increase the number of Montana students at seminaries and to recruit more seminary graduates to Montana.

The call committee was asked to explore the possibility of obtaining a pastor from another Lutheran denomination and to determine if there are retired military chaplains with interest in coming to western Montana.

**Committee Reports:** Aiden Mosher presented drawings of the proposed retaining wall and roof cover options for the basement stairwell. It was the consensus of the council that the Property and Maintenance Committee should proceed with the plan without the south and east walls (only support posts for the roof).

**Continuing Business:** It was noted that Beth Ward, Aubra Lewis, and Jim Beck spent an hour working with the Easy Worship software without finding a way of conveniently assembling slides or projecting them. Beth will attempt to get someone she knows who uses the software to present a training session for potential users at SVLC.

Notice has been given to the residents at both rentals of rent increases beginning in February 2026. Rental contracts have been completed and given to the renters, but have not yet been returned to the church representatives.

A congregational survey, and survey explanation, was presented to the council. After discussion and revision of the documents, it was decided to mail out the surveys sometime the week of December 14 with a requested response by January 10, 2026. The survey results would be tabulated for the January 11 council meeting and be available to the congregation before and during the annual meeting.

## New Business:

There was no new business to come before the meeting.

## Council Member Concerns:

Steve Ward asked for a \$200 per month increase in his compensation for his synod approved minister (SAM) work. Diane Johnson made a motion to increase the SAM compensation by \$250 per month (to bring the yearly compensation to \$24,600). Virgil Binkley seconded the motion and it passed.

A bill for \$165 was presented for a clip-on piano light. The configuration of the new piano does not lend itself to a light mounted on a base. Diane Johnson made and Virgil Binkley seconded a motion to authorize reimbursement for the light. The motion passed.

It was noted that there is a file cabinet with at least 150 selections of choir music and numerous other choir books and music. As we add choir music, should there be sorting and indexing of the choir music? President Arnold asked the Worship and Music Committee to consider the situation and provide a recommendation to the council.

Jim Beck noted that the table for the for the monitor computer was not very user friendly and provided no storage for books, manuals, or remotes. This drawback would be even more of a problem if Easy Worship is used and slide shows are created at the computer. President Arnold asked that the Worship and Music Committee consider options for the monitor computer table and convey them to the council.

Jim Beck indicated that, at times, church storage areas are in a condition that does not allow access to the items normally stored there. He asked if there were solutions to this problem. No action was taken at this time.

There being no further business, Steve Ward made a motion to adjourn the meeting. The motion was seconded by Jim Beck and passed at 1:21 pm. The meeting attendees prayed the Lord's Prayer.
