

### August 3, 2025 Meeting of the SVLC Council



Council members present: Clint Watson, Dave Rowell, Aiden Mosher, Diane Johnson, Virgil Binkley, Jim Beck, and Rick Arnold

Council member absent: Julie Mikula

Others attending the meeting: Treasurer, Mike Colbert; Assistant Treasurer, Lisa Rowell; Marcia Bieber; and Steve Ward, SAM

The meeting was called to order at 10:37 am by President Rick Arnold. Rick led the council in prayer.

**Church member comments:** There was no correspondence from a member or a member present at the meeting, except to present for an agenda topic.

Diane Johnson made a motion to accept the minutes of the July 13, 2025 regular-meeting. The motion was seconded by Steve Ward and passed.

### **Treasurer's report:** Mike Colbert reported:

The July offering was \$5321 and other income was \$1449

Expenses for the month were \$3565

July rental income was \$1740, with expenses of \$747

The end of the month checking balance was \$5375

The money market balance was \$29,580, with \$3000 of that encumbered

CDs totaled \$230,000, with \$30,000 of that in a plumbing reserve

Lisa Rowell related that \$528 had been given in the Texas flood assistance offering. It will be combined with the \$500 already designated by the council.

Virgil Binkley moved to accept the treasurer's report. Steve Ward seconded the motion, and it passed.

### SAM Report:

Six students will be attending the first communion instruction, tentatively scheduled for late September

The adult confirmation is ongoing

#### **Committee Reports:**

The Rental Committee reported that the rental notice and agreement had been discussed and signed by the renters of the parsonage. The committee recommended against updating the electrical service at the parsonage as it would likely involve a chain of changes to the home's electrical system. The screen doors and kitchen floor in the rental (307 N Cherry St.) have been replaced. The electrical work is still pending.

The Property & Maintenance Committee explained that the sump pump had been raised about 9 inches, with no apparent problems with basement seepage. Raising the pump reduced the average discharge to 0.8 gpm, about 1/3 of the previous discharge. The general groundwater level has dropped about 8 inches over the past month.

President Arnold said that Alieda Stone is willing to repaint the front doors of the church. Steve Ward made and Diane Johnson seconded a motion to accept Aleida's offer. The motion passed. President Arnold asked the Property & Maintenance Committee to purchase paint for Alieda.

### **Continuing Business:**

Marcia Bieber and Mike Colbert recommended to the council that they pursue an informal appeal for the property assessment for the rental (307 N Cherry St.). Dave Rowell made and Diane Johnson seconded a motion to proceed with the informal property assessment appeal. The motion passed. Lisa Rowell and Mike Colbert will prepare the appeal paperwork for Rick Arnold to sign.

Diane Johnson reported that she had obtained a bid of \$1300 per tree to remove the pine trees and stumps on the east side of the church. The removal of the tree and stump at the southwest corner of the church property would cost \$1500. Steve Ward made a motion to take the tree removal under consideration and have the Property & Maintenance Committee consider landscaping options if the tree(s) are removed. Diane Johnson seconded the motion and it passed.

### **New Business:**

Jim Beck remarked that he had communication from New Life Lutheran Church asking if we would be amenable to having a combined service with New Life, the goal being to allow our congregations to better know each other. Consensus was that we would explain the offer to the congregation and have members offer their opinions.

### **Council Member Concerns:**

The were no council member concerns.

There being no further business, Steve Ward made a motion to adjourn the meeting. The motion was seconded by Diane Johnson and passed at 11:44 am. The meeting attendees prayed the Lord's Prayer.
