SCORE 420 CURRENTLY OPERATES TWO RETAIL STORES IN ALBUQUERQUE

THEN THEY PROVIDED ME WITH A COA FOR THEIR DISTILLATE... WHICH WAS AN EXACT COPY OF DIME INDUSTRIES. AFTER MORE QUESTIONING, CURE INJOY OFFERED TO REIMBURSE ME FOR A TEST OF THEIR PRODUCT AND I AGREED. SO I HAD BOTH DEVICES TESTED AND THE PRODUCTS TURNED OUT COMPLETELY DIFFERENT FROM ONE ANOTHER, BUT ALSO DIFFERENT FROM THE THREE (3) COAS I WAS PREVIOUSLY GIVEN. TO MAKE MATTERS WORSE, ONE OF THEM TESTED FOR EXTREMELY DANGEROUS LEVELS OF PIPERONYL BUTOXIDE, A PESTICIDE USED TO KILL LICE. SO THE DEVICE FAILED MISERABLY. WHEN I INFORMED CURE INJOY, THEY BECAME DEFENSIVE AND TOOK A MUCH DIFFERENT TONE. I SPOKE TO THOMAS WINFREY WHO CLAIMED HE POSSESSED SOME SORT OF AUTHORITY AT SCORE 420 AND HE WAS GOING TO GET ME A RESOLUTION "ASAP". WELL, HE LIED. SO I WENT TO THE STORE IN PERSON AND VERY POLITELY ASKED THE MANAGER JAMES FOR A REFUND FOR THE TAINTED PRODUCTS AT WHICH POINT HE SHOUTED HOMOPHOBIC SLURS AT ME AND MY FRIEND AND TOLD ME TO "GET THE F*CK OUT OF THE STORE". IF YOU AREN'T CONCERNED YET, YOU HAVE NO BUSINESS FOLLOWING THIS PAGE. IT ALL STARTED ONE DAY WHEN INSTAGRAM BECAME FLOODED WITH POSTS FOR A NEW COLORFUL, EXCITING DISPOSABLE VAPE DEVICE BY CURE INJOY. IT SEEMED AS IF EVERY OTHER POST WAS AN IMAGE OF THE NEXT BRIGHT COLOR AND APPEALING FLAVOR OF CURE INJOY. THIS COMPANY COVERED THE ENTIRE SPECTRUM OF THE RAINBOW. SCORE 420 WAS THE ONLY RETAILER IN TOWN WHO CARRIED THESE SO I HEADED OVER AS SOON AS POSSIBLE. FROM THE MOMENT I ENTERED THIS STORE I FELT AS IF I WAS IN A CORRECTIONAL FACILITY. IT IS THE COLDEST, LEAST WELCOMING, DOWNRIGHT GROSS RETAIL STORE IN TOWN. I QUICKLY NOTICED HOW EVERY SINGLE CASE WAS FILLED FROM TOP TO BOTTOM WITH GH LABS PRODUCTS. MY SUSPICIONS HEIGHTENED WHEN I WATCHED AN EMPLOYEE OPEN THE VERY FIRST BOX OF DIME INDUSTRIES, WHICH I RECALL FROM MY DAYS IN CALIFORNIA. BUT DIME WASN'T LICENSED HERE YET. SURELY THIS WAS A MISTAKE. I ASKED THE BUTTENDER, WHO WAS SO HIGH HE COULD BARELY KEEP HIS EYES OPEN. HIS RESPONSE: "WE JUST GOT THOSE STRAIGHT FROM CALI BRO THEY ARE FIRE!" I ASKED A SECOND TIME AND ANOTHER EMPLOYEE VALIDATED THE STORY. MY SUSPICIONS WERE ON LEVEL 10 AT THIS POINT. WHEN I LOOKED AT THE BOXES AND LABELS FOR EACH DEVICE, THERE WAS NO INFORMATION WHATSOEVER: NO MANUFACTURER, NO PRODUCER, NO SOURCE...NOTHING. SO I PURCHASED BOTH DEVICES IMMEDIATELY FOR ALMOST \$150 AND TOOK THEM HOME. I SCRATCHED THE "AUTHENTICITY" CODE FROM THE SIDE OF THE DIME BOX AND TO MY SURPRISE IT WAS VALID!... FROM CALIFORNIA. SO I OBTAINED A COA (CERTIFICATE OF ANALYSIS) FROM DIME.

Oasis Continues To Drop Prices To Remain Least Expensive Dispensary

OASIS CANNABIS COMPANY HAS FOREVER BEEN SYNONYMOUS WITH LOW PRICES. THIS COMPANY HAS NO INTENTION OF SLOWING ITS MOMENTUM EITHER. YOU CANNOT FIND A DISPENSARY IN THE STATE OF NEW MEXICO WITH LOWER PRICES FOR ANY PRODUCT. WHILE THE EXACT COSTS, PRICES, AND WHOLESALE DEALS ARE NOT READILY AVAILABLE TO THE PUBLIC, I HAVE SPOKEN WITH MULTIPLE MANUFACTURERS AROUND THE STATE WHO EACH CONFIRM OASIS DOES NOT RECEIVE SPECIAL "DEALS" OF ANY KIND. IN FACT, ONE EXTRACTOR SPOKE TO ME AT LENGTH AND THE FIRST QUESTION HE POSED WAS "HOW MUCH CHEAPER CAN WE BE FROM THE BACK END?" EVERY DISPENSARY IN THE STATE OF NEW MEXICO IS RESPONSIBLE FOR THE SAME TAXES, FEES, REGULATIONS, OVERHEAD AND COSTS RELATED TO EMPLOYMENT. BUT IS IT FAIR TO ASSUME OASIS IS INVOLVED IN DISHONEST CONDUCT OF ANY KIND BEFORE ITS FAIR TO ASSUME THEIR COMPETITORS ARE GUILTY OF GREED? AFTER SPEAKING TO MANUFACTURERS AND RETAILERS ALIKE, IT IS CLEAR THERE IS AN ABUNDANCE OF GREED AMONG RETAILERS IN NEW MEXICO, PARTICULARLY IN THE SOUTHERN PORTION OF THE STATE WHERE THE PRODUCTS ARE WORTH MORE BECAUSE THEY CAN BE EASILY TRANSPORTED ACROSS STATE LINES FOR BOTH CONSUMPTION AND RESALE. WHEN ASKED ABOUT THEIR PRICING, A REP FOR OASIS ISSUED THE FOLLOWING STATEMENT: "WE CARE ABOUT OUR CUSTOMERS. WE WANT TO GIVE THEM THE BEST POSSIBLE VALUE AND WE INTEND TO STAND BY THAT AS LONG AS OUR DOORS ARE OPEN." OASIS IS CURRENTLY SCHEDULED TO OPEN A NEW WESTSIDE LOCATION ON COORS RD. BY 2024.

WHEN ARE RETAILERS GOING TO BE HELD RESPONSIBLE FOR THE PRODUCTS ON THEIR SHELVES?

We cannot count on the manufacturers to be honest. We cannot count on the State to hold them accountable. But when is the retailer going to bear some responsibility? Golden Roots was the third and most recent company to have their license revoked for illegal practices. There were countless violations; one of which was illegal importation of product from across state lines. No accounting for it whatsoever. Dark Matter, one of the highest priced retailers in New Mexico was making thousands of dollars selling this illegal product for months claiming to be "totally naive" of Golden Roots' misdeeds- however the public saw a report that GR was being investigated all the way back in January of 2023. What took so long to catch them? Good question. But a better question: Why should Dark Matter be let off the hook so easily? I've investigated thoroughly and I spoke with sources: both past and present employees who have personally told me they were "aware". They also provided copies of group text threads where employees stated "hopefully this is the last we get from Golden Roots", right before they got another shipment. So yes, Dark Matter (Top Crop) absolutely knew there was bad business at play...because even the public knew. I heard from quite a bit of angry Dark Matter customers who think I am holding them solely responsible, while they place ZERO responsibility on them.
