

I, _____ (Customer requesting service) agree to the following terms and conditions for rental of described services.

1. Customer agrees to pay \$ _____ for dumpster delivery which includes up to _____ tons of disposal and sales tax. Due to strict weight limitations and associated dump fees any additional materials will be billed at \$ _____ per ton above the _____ tons deposit.
2. Customers are and will be held responsible for any additional fees assessed at the end of the rental period.
3. The container rental includes use for up to _____ days. If the container is kept longer than _____ days there will be an additional fee of \$5.00 a day assessed until a call/text is received from the customer for pickup.
4. Customers will be responsible for all labor and fees associated with any kind of licensing and permits if required from the city.
5. Payment for all base fees will be due upon delivery of the container by credit card NO EXCEPTIONS!. Any additional fees due will be charged automatically to the credit card given prior to dumpster delivery.
6. While refuse dumpsters are in your possession, you will NOT place or allow to be placed into the dumpster:
 - o Substances hazardous to health such toxic or corrosive materials or liquids Such as paints and stains
 - o Vehicle Fluids/Filters
 - o Heavy Materials such as rock,dirt,Concrete
 - o Large Metal Items
 - o Large Appliances
 - o Fluorescent Bulbs/Ballasts
 - o Microwaves
 - o AC Units
 - o TVS
 - o Tires
 - o Medical waste or animal carcasses of any kind.
 - o Any material not listed above however considered unsuitable for containment e.g. asbestos, gas bottle, vehicle batteries,lawn debris/brush

Clean cardboard in any dumpster going to the FMC Landfill or the Landfill tip fee doubles

Any of the following above listed will be subject to extra charges including the labor to remove/handle from the load at the rate of \$100/hr.

2. **Due to DOT and DNR Enforced law all refuse shall remain within the confines of the dumpster and shall not exceed over level and out of the sides of the container. Every attempt shall be taken to equally disperse the weight of the refuse within the dumpster. Any dumpster that is unable to be 100% secure for transport will be subject to a \$35 fee.**
3. **Any items needing to be moved away from dumpster and or dumpster doors opened/left open upon arrival will be subject to extra charges.**
4. Customers shall be liable for any loss or damage to rented equipment in excess of reasonable wear and tear.

The Customer will be responsible for the provision of free and suitable access to and from the delivery site (including the removal and reinstatement of local obstructions) and for ensuring suitable ground conditions for delivery, placement and removal of the dumpster. No responsibility will be accepted for the damage to any surface and you should therefore take steps to protect surfaces (e.g. paving slabs, soft ground) before delivery. Should the container cause any damages to any driveway sidewalk or lawn surfaces during loading or unloading. North Iowa Diesel is not liable for any and all damages caused to any of the homeowner's property and or if the container is placed in City Street if allowed by that city during the loading and unloading process and also any accidents that may occur during the period the container sits on city property. If a homeowner wants a dumpster placed on city property they must have prior authorization by that city before drop off. Customers will pay any extra charges associated with safety devices and or permits needed by the city to place in the street. If said container has to be removed off of the street for any reason the customer will be charged extra costs to do so. Any and all extra trips to the delivery site will be subject to labor charges of \$100/hr. from the time the truck leaves the yard to when it returns back to the yard. North Iowa Diesel will NOT be held liable for any personal property such as materials or tools left inside the container at any time. Should the Customer fail to return the container, North Iowa Diesel maintains the right to enter upon the premises where the container may be without notice and take possession of and remove it at the Customer's expense all without legal process, the Customer hereby waives any claims for damages from any such entry or removal. Customer agrees any additional charges assessed will be charged automatically to the credit card used to pay deposit upon delivery of dumpster. Customer Agrees to all of the above Terms and Conditions. Customer also understands this is a legal and binding document.
