

# James R. McAllister “MAC” Memorial Fishing Tournament

## – RULES & REGULATIONS –

### Eligibility and Registration

1. Each individual or team **MUST** complete, sign and submit the official MAC’s tournament registration form. These forms are available on our website: [macmemorialtournament.com](http://macmemorialtournament.com) and at Schroeder Farm Campground.  
Forms and donation for entry can be submitted at Schroeder Farm Campground, located at 26997 W. River Rd., Perrysburg, OH 43551, anytime before the tournament or at boat check-in on Friday night or Saturday morning.

2. Each team entry donation is non-refundable.
3. All participants **MUST** possess a valid Ohio fishing license.
4. As a condition of participation, each participant **MUST** execute a Release of Liability. The release indemnifies the MAC’s Tournament and sponsors.
5. Each team **MUST** have two (2) persons and **NO MORE** than one (1) team per boat.
6. All boats being used in the tournament **MUST** pass a vessel safety check. This safety check will be held at Schroeder Farm Campground in Perrysburg from 5-8 a.m. Visit ODNR Division of Watercraft at [watercraft.ohio.dnr.gov/required-equipment](http://watercraft.ohio.dnr.gov/required-equipment) for a list of required equipment.
7. Fishing **MUST** take place between Orleans Park and Jerome Rd. (Boundary maps are available at boat check-in.)

### Format/Scoring

1. Fish will be brought to Schroeder Farm Campground and boat launch, (see address above) for “Official Weigh-in.”
2. Weigh-in procedures are as follows:
  - a. Weigh-in begins at 3:15 p.m. All participants **MUST** have checked in by 3 p.m. at the weigh-in station. Failure to check-in on time will lead to disqualification.
  - b. Each team may weigh in seven (7) walleye.
  - c. Each fish **MUST**:
    - be male (jacks)
    - be of minimum legal limit
    - be free of snags and snag marks
    - be caught by means of local and state laws
    - appear of live nature (i.e. not stiff) and cannot be on ice
  - d. The team’s total score will be a combined weight of up to seven (7) legal walleye. Both team members **MUST** be present at weigh-in.
  - e. Any fish altered to enhance the weight **WILL NOT** be allowed and **WILL** warrant disqualification from the tournament – permanently.
3. Any unsportsmanlike conduct during tournament or weigh-in is prohibited and subject to disqualification.

### Awards/Weigh-In

The awards ceremony will be held at Schroeder Farm Campground (see address above). Awards ceremony will also include door prizes and food.

Prize payouts are as follows:

1st Prize – \$1,500 • 2nd Prize – \$800 • 3rd Prize – \$400 • 4th Prize – \$100 • Largest Fish – \$100

*Rules and inspection of fish will be enforced by the tournament weigh-in judge.*
