The possession certificate is one of the supporting documents and cannot act as the sole proof of the owner's ownership over the asset. See also: All about ancestral property What is an occupancy certificate? An occupancy certificate is a crucial document that a builder provides to the buyer, only after he has received a go-ahead from all the authorities that deem the property fit for possession. The authorities' approval would mean that the builder has constructed the project, in line with all the prevalent construction laws and it is safe for the property owners to start living in their respective accommodations. For a builder, the process of obtaining the occupancy certificate is highly time-consuming and costly. It is a document that is issued by the local government body in the area. The authorities make ground-level level surveys and verify every detail to give the occupancy certificate. builder have to mainly submit the following documents to the authority concerned: Also read about NOC format Note that the actual number of documents that the builder will have to provide, to get an occupancy certificate for their project from a competent authority, may be much larger in number. This is only an indicative and not an exhaustive list. As far as a buyer is concerned, they must not move into a property without the developer showing the occupancy certificate. Doing so may jeopardise one's physical wellbeing and the legal status of your property.
