Process

Here's how we work (Personal):

- Introduction/Drop Off**
Drop off tax information and have quick meeting to understand you and your family's tax position
- Preparation**
SGD Prepared tax return(s)
- Signing, Payment & Filing**
Taxes are filed when T183 is signed and payment for taxes have been received
- Final Documents Provided**
Either digitally or printed

Any return provided after 3rd week of April is not guaranteed to be filed by CRA deadline

Here's how we work (Corporate):

- Introduction Meeting or Call**
We start with a session to help SGD understand your business and financial processes and any other financial needs
- Monthly Report Creation * *Bookkeeping Only***
Produce monthly statements for review and asses if there are any changes that need to be made
- Year End Process**
1-2 months following your year-end, an accounting package is provided to SGD. We will set up a pre-engagement meeting to discuss the prior year and have a final presentation once the engagement is completed.
- Performance Review & Optimization**
Annually we will assess how the engagement went and how we can better support you in future years
