Doug Kelley is one proud Worthy Patron, and we're so happy to have Amy as a member!









# 2023 Grand Chapter - Legislation

Here are the results from our 2023 Grand Chapter Session:

- Allows Secretary in one Chapter to be an elected Treasurer for another Chapter, and vice versa. Not adopted; written ballot results - 250 yes, 259 no.
- Currently, the WM can allow the Secretary to read totals only of Dues and Assessments. This would allow for the total of all receipts to be read, rather than itemized bills and receipts. As is the case now with Dues and Assessments, this would be only if there were no objections from the members present. Adopted.
- orol of all receips to be read, Jatner train tentized bills and receipts. As is the case now wint bues and Assessments, this would be only if there were no objections from the members present. Adopted.

  Currently the Secretary must make a Membership report to the Chapter at the first meeting following July 15, and a similar report submitted to Grand Chapter in December. This would allow the Secretary to submit their GC report at but the Chapter report is given. This will prevent them from having to count membership at 2 different times during the year. Additionally, the Secretary will make a year-end report to Grand Chapter regarding budget performance of the Chapter at the first meeting after November 30 of each year. Adopted.
- Permanently appoints the Grand Secretary as a non-member secretary to the Finance Committee. Adopted; written ballot results -482 yes, 40 no.
- Allows the WGM to remove DGMs from office for non-performance of their duties and strike their names from records, as if the appointment were never made. Not adopted.
- Requires Chapter to report the failure to hold a Stated Meeting to Grand Chapter, including the reason the meeting was not held. Adopted.
- Removes the rotating north/south requirement (if the incoming Associate Grand Matron is from the north, the Associate Grand Patron designee is required to come from the south and vice versa) for candidates for the offices of AGP and WGP. Not adopted: written ballot results—137 yes, 567 no.
- Removes the requirement to suspend members who are delinquent in their dues (after 12 months) but allows for that option, or remission of dues. Adopted.
- · Allows Chapters that confer life membership to 50-year members to choose:
- Exempt them from ALL dues, per capita and assessments, or
   Exempt them from dues only, still requiring payment of per capita and assessments. Adopted
- Requires quick deposit of monies received by the Secretary/Treasurer, regardless of the date of the next meeting. Adopted.
- 11. Cleans up the number of copies of proposed Bylaws changes and to whom the copies go. Adopted.
- Allows Chapters not to send required communications to members who have been determined to have mental incaracity. Advanced
- 13. Requires following of Instruction Book written ballot procedure for Consolidation votes. Adopted
- 14. For newly consolidated Chapters, allows them to retain (rather than return and replace) numbered Secret Work, if the same name and number was retained by the new Chapter. Adopted.

- 15. For newly consolidated Chapters, allows existing Bylaws to be used until GC has approved new Bylaws. Adopted
- 16. For newly consolidated Chapters, allows additional time for audit of books. Adopted
- 17. For consolidating Chapters, allows for an expedited form of consolidation: "Consolidation by Absorption".
- Requires addition of "Grand Chapter Consolidation Manual" to be among the materials each Chapter Secretary must have present at every stated meeting, Adopted.
- 19. Maintains 2/3 vote requirement for consideration of consolidation but allows for majority vote on the Chapters to approach and the order in which to approach them. Not adopted; written ballot results 276 yes, 221 no. Because there was a majority yes vote, but not 2/3 majority required, this item will be carried over until next GC.
- Requires WM or Secretary of chapters approached for consolidation to immediately contact the sending Chapter to confirm receipt of the proposal. Allows WM to direct Secretary to send notice of consolidation consideration to all Chapter members before proposal has been read in Chapter. Adopted.
- For newly consolidated Chapters, requires consolidation of Chapter property within 45 days, barring unusual circumstances. Adopted.
- For newly consolidated Chapters, requires change of signatories on financial accounts belonging to the new Chapter to be completed within 30 business days. Adopted.

In General Grand Chapter, the Right Worthy Grand Sentinel is the start of the "line" for the gentlemen, so he would serve with Barbie during the 2030-2033 Triennium. Their 2033 session will be held in Las Vegas, Nevada. California would be the co-host for the session. Members from all over the world of Eastern Star will be there!

The California Miners will assist in many ways, preparing for the 2033 session. Not only will the funds we raise pay for California's part in the facilities and all of the convention needs, but our TALENTS, IDEAS, PARTICIPATION, and ENTHUSIASM will assist Nevada in putting on a fantastic session — one we will be proud of and anxious to attend.

#### WHO CAN JOIN?

All members of the Masonic family are welcome to join in supporting the efforts of the Association. Individuals as well as groups can obtain a membership.

#### HOW MUCH DOES IT COST?

\$100 provides membership for the duration - from now through 2033!

\$25 provides membership "per Triennium". \$75 provides membership for a group with one vote. "per Triennium".

Triennium memberships are: 1) now to 2027, 2) 2027-2030, or 3) 2030-2033.

#### HOW IS IT ORGANIZED? MEETINGS?

There are elected and appointed members who will direct the operations and events and align to the bylaws. Volunteers are needed on a lot of committees, so there is a place for you to contribute your talents. Officially, we will meet at a designated time during Grand Chapter session each year. If other business meetings are needed, you will be notified.

#### **ACTIVITIES**

We anticipate that there will be many social and FUN activities throughout the years as well as merchandise available for us to sell (and purchase). The funds will be used for our financial obligations as the co-hosting jurisdiction in 2033.
