c. Optional KYC Information:

In the event of participation in specific functions requiring compliance (e.g., dividend distribution, jurisdictional access, regulatory requirements), users may be prompted to submit:

- Government-issued identification
- Proof of residence
- Facial recognition verification

3. How We Use Your Information

The information we collect is used to:

- Operate and improve the Thanks Token platform
- Enhance user experience and personalize services
- Conduct analytics and measure user engagement
- Enable secure and transparent token transactions
- Fulfill regulatory obligations such as Know-Your-Customer (KYC) or Anti-Money Laundering (AML) laws
- Detect and prevent fraud, unauthorized access, and other illegal activities
- Manage token-based features such as rewards, transfers, and staking

We do not use your information for profiling or automated decision-making outside the scope of our token utility functions.

4. Sharing Your Information

We do not sell or rent your personal data.

Your information may be shared in limited cases, such as:

- With service providers for secure hosting, analytics, or KYC compliance
- With legal or regulatory authorities if legally required or subpoenaed
- In connection with a corporate transaction, such as a merger or restructuring
