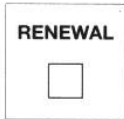

**To License Your Pet By Mail:** Complete the owner and pet information and check which license fee you are paying. Enclose a copy of your pet's current rabies vaccination certificate. Enclose proof of Spay/Neuter if it is not indicated on the rabies certificate or proof of age if required. *Please provide legible copies of any documentation requested. Paperwork is not returned with your tag and license receipt.* Make your check or money order payable to St. Lucie County BOCC. Mail to: St. Lucie County, Attn. Animal Licensing, 15305 W. Midway Road, Ft. Pierce, FL 34945.

- \$10 Annually (**currently spayed or neutered**)
- \$25 Life time (**currently spayed or neutered**)
- \$75 Annually (**unaltered animals**)
- \$100 Annual registration fee for Breeders/Sellers

***(Discounted rate for registering additional pets that are spayed or neutered)***

***\*New residents to St. Lucie County with pre-existing pet tags of other counties will need to register their pets in St. Lucie County.***

***Pet owners who do not register their animals could face fines up to the following:***

**1<sup>st</sup> offense \$100**

**2<sup>nd</sup> offense \$200**

**3<sup>rd</sup> offense Mandatory court appearance**
