Management Report

- Arranged for Tradition Electric to repair spa timer completed on Friday, 9.8.23.
- Met with Superior Water Management to seek competitive quote for lake management and recommended options for a solution to the existing cattail issue.
 - \Rightarrow Arranged for no charge treatment of lake cattails by Solitude Lake Management which was completed on 9.27.23
 - ⇒ Received competitive quote for pond maintenance from Superior Waterways that would save approx. \$1700 per year existing Solitude Waterway contract was renewed in October and requires 30-day notice before auto renewal or we pay balance of year's contract to get out. Will report it to Board but plan no action at this time.
- Reopened Allstate insurance case where check was received for about \$1500 less than actual repair expenses from accident involving an owner who hit an entrance light pole in November 2022. We are seeking either the balance of the damages paid by Tropical Isles from Allstate or reasons why we did not receive it.
- Resolved a concern over water consumption at the clubhouse over the last few months.
- Requested to and did summarize several issues that needed attorney opinion. Forwarded to the Association's attorney to get his opinion.
- Received approval for pool repairs totaling \$3,937- sent signed off quote to vendor. Repairs have been completed.
- Met with Mobility + for 10.2.23 to get quotes for handicapped ramps at the clubhouse.
 - ♦ Looking at potential for 2 ramps
 - *Parking lot to pool area
 - *Access to indoor restrooms from pool deck area.
- Completed several community drive throughs for potential property issues.
- Prepared for and attended BOD meeting on 9.25.23.
- Met with Blackrock Trucking to get quote for potential replacement/upgrading of stone on storage lot parking areas.
- Investigated replacement icemakers for the clubhouse; resolved by Board.

Report from the Board

As you know, the Board has been working on several projects, many of which involve the community center (clubhouse). We are hoping to eventually refresh the entire building. All suggestions will be considered. Please either talk to a Board member or put in writing and bring it to office.

Some recent accomplishments include:

- * Mailbox center refreshed with paint and new numbers.
- * Storage areas were re-organized, cleaned and painted for use by the office (for supplies), by the Social Committee, Bingo committee, Nimble Fingers group and Maintenance team.
- * Refrigerator was purchased for Bingo.
- * Ice Chest for bags of ice has been purchased to use when needed instead of replacing with the much more expensive icemaker.
- * Community Center floor has been cleaned, stripped, and waxed.
- * Shuffleboard area benches have been replaced.
- * Cattails were removed from lakes.
- * Signs throughout the park were replaced where necessary.
- * Community Center parking lot lines were repainted.
- * Culvert was repaired.
- *AED was purchase and installation and training completed.

Some things in the works right now:

- * Rules and Regulations are being updated.
- * Sign replacements continue. (stop signs, warnings: alligator, snakes, swimming)
- * Research into replacement of diseased trees throughout park is ongoing.
- * We are renegotiating contracts with Carlos to include an additional benefit to each resident. Each month, the CAM and I ride through the community looking for areas that need attention, from either the Co-op or the owners. This month, there were 26 needs identified (18 of which were unsightly weeds growing in driveways/paver cracks). I spoke with Carlos, and he has tentatively agreed to apply weed killer to the needed areas as part of his landscaping contract. In exchange, we are considering allowing him to park his RV in our lot, free of charge, which equals \$100/month. In essence, we allow him to use an unrented slot in exchange for his services (\$1200 per year).
- * A resident with a slot in the RV lot has brought to our attention that the gate that closes the lot is essentially useless and is easily opened, even when the lock and chain are engaged. This will be corrected ASAP. Thank you, Pepe!

Some things in the planning stage:

- Shuffleboard court repainting
- * Horseshoe pit border replacement
- * Solar powered security cameras (2023 technology) for the RV lot, front entrance/exit and pool areas.

A couple of suggestions from residents for consideration:

 A recommendation has been made for the area that is outside the card and board rooms (the deck that is never used). There is an outfit that specializes in Tiki huts. It has been suggested

that this would be a perfect spot for one. Pictures and ideas will be forthcoming. Not one dollar of TI money has been expended, nor will it be, until this is presented to the entire community. Of course, all appropriate policies and procedures will be followed.

*Another resident has recommended that we look into the possibility of entering into a contract with the shredding company to occasionally avail residents of their shredding service.

Still in need of:

* Volunteers for Fines Committee. Three (3) members are needed, we only have one (1) volunteer (Eric Lindbloom). Volunteers for Social Committee: contact Linda Young.

We welcome all suggestions for potential improvements/changes to continue to make Tropical Isles the absolute best place to live!


