1. An application is a commitment to the event; however, refunds will be made for cancellation if received by phone or e-mail prior to September 1, 2022.
2. Complete instructions will be e-mailed to all approved exhibitors prior to the event.
3. You must adhere to the hours of the event as stated above. Early breakdown will result in exclusion from ANY future events held with sponsoring organizations.
4. No exhibitor will be allowed to set up unless full payment has been received.
5. The sponsoring organizations reserve the right to reject or accept any exhibitor.
6. You, your staff, and your booth must remain neat, clean and kept in an orderly fashion.

7. Only one exhibitor is allowed per space. Displays must be contained within your booth.
8. Conduct and displays must be appropriate.
 - a. No garbage may be in view. All boxes must be broken down before discarding.
 - b. No handmade signs are allowed. Make sure tables are properly covered.
 - c. Only items listed on this application are allowed to be distributed at the event.
 - d. Styrofoam and plastic straws are prohibited at all city events.
 - e. Playing music in individual exhibitor spaces is prohibited.
9. The event staff, Deerfield Beach Community Cares, and Zion Evangelical Lutheran Church will not be liable for any losses or damages of any kind. (See below)
10. There are no refunds if the event is cancelled due to rain or acts of nature.
