REPRESENTATIVES OF NEPALESE ASSOCIATIONS MEET IN TOLEDO

A conference of representatives of Nepalese associations in North America was held in Toledo, Ohio on November 26, 1988. It was attended by about twenty five individuals from Association of Nepalis in the Americas (ANA), Association of Nepalese in Midwest America (ANMA), and Nepal Association, Indianapolis (NA), including the current Presidents of these associations. The conference was moderated by Prahlad Pant. Pat and Nirakar Thakur were the local hosts.

During the two marathon sessions which took more than six hours, the conference attendees exchanged ideas on many items of interest concerning the Nepalese community in North America. A total of eight resolutions were unanimously passed which, when approved and implemented by the executive committees of the respective associations, will begin a new chapter in the history of cooperation among the Nepalese associations. A full report on the resolutions and the actions taken to implement them will be published in a special joint newsletter of ANMA and ANA to be published in February, 1989. At present, the resolutions have been forwarded to the Presidents of these associations for approval by the respective executive committees.

PASSPORT PROCEDURES

The Royal Nepalese Embassy in Washington D.C. requests you to follow the following procedures when applying for new passports, extensions, or country endorsements.

- 1. For new passport please send:
 - a. present passport
 - b. money order for US\$28.00 passport fee
 - c. self addressed stamped envelope
 - d. a specimen signature on a small piece of paper
 - e. passport application form
- 2. For validity extension please send:
 - a. passport
 - b. self addressed stamped envelope
 - c. US\$7.00 (in money order) renewal fee
- 3. For adding countries only please send:
 - a. passport
 - self addressed stamped envelope
 - c. US\$2.00 for each country to be added
- Lostpassport should be immediately reported to Police and proof of that should be included while applying for new passport.

Applicants are advised to send their application with reason and justification which will help speed up prompt services.

One Man's Efforts: Dr. Tulasi Joshi Raises \$1,300.

We have learned that the Associations of Nepalis in the Americas raised \$3,300 and the America-Nepal Friendship Society of New York raised \$1,500 for the victims of the August 21 earthquake in Nepal. As we reported in the October issue of "The Viewpoints", ANMA raised \$1,900 for the same cause.

Obviously, the fund raising efforts could not have been successful without the generous contributions of many individuals and families The success is also due to in North America. the tireless efforts of many individuals who have worked very hard behind the scene and spent their valuable time and energy. One person's efforts can make a big difference. Consider, for example, the efforts of Dr. Tulasi Joshi who single-handedly raised \$1,300 in the small city of Fairmont, West Virginia (population 23,000). He did so by publicizing several times through the local newspaper, organizing a committee of

State College Fairmont faculty members and students, setting up a Student booth in the Center, and speaking at the meetings of the local Lions Club and Kiwanis Club. The fund was raised as a part of ANA's project to assist the earthquake Tulasi handed victims. over the fund to ANA at a meeting held in Corning, N.Y. on October 29, 1988. Tulasi Joshi, Professor of Fairmont Geography at State College, received undergraduate his education in Nepal, and and Ph.D. degrees from the University of Hawaii and the University of Pittsburgh respectively. He has been on the FSC faculty for over 16 years. Prior to coming to FSC, he taught at Pitt, Arizona State University, Shippensburg State University. Tulasi and Marilyn, who his wife teaches at Dunbar Middle School, have three children.

The Prime Minister also said that the entire amount had already been spent. (Rising Nepal, September 23 and 24)

Meanwhile, there have been conflicting reports of irregularities and corruption in the relief and rehabilitation operations in Nepal.

Another Disaster

In the night of September 20, a total of 106 persons were buried alive by landslides in Myagdi district. Property worth about Rs. 2.5 million was also destroyed. (Gorkhapatra, September 23).

New Visa Regulations

On October 17, the Ministry of Home has published an amendment of the visa regulations. Two new categories of visas were introduced in addition to the usual categories of diplomatic visas, official visas, non-tourists visas, and tourist visas. They were interim visas and residential visas. Interim visas for not more than a week were meant for foreigners

entering into Nepal on their way from one country to another, or who are sent back to Nepal after being denied entry into any other country after departure from Nepal. Residential visas, which were renewable every year, were meant for foreigners of the following categories wishing to spend their life in Nepal: persons of international reputation; (2) persons who have rendered special contribution in the economic, social and cultural fields of Nepal; (3) rendered who have any persons distinct contribution the development of Nepal; (4) persons whom His Majesty's Government deems fit for settlement in Nepal.

The amendments for the tourist visas includes the following: "Any tourist who re-enters into Nepal within less than three months from the date of his last departure from Nepal shall be granted a visa valid for a maximum of one month only. However, tourists shall be allowed to re-enter into Nepal ordinarily only after one month from the date of their departure from

The arrangements regarding nontourists visas have also been amended.

"A foreigner having matrimonial relationship with a Nepali woman shall be granted a non-tourist visa ordinarily valid for a maximum period of four months only during a year."

In an interview to the "Saptahik Bimarsha" on October 6, Ganesh Man Singh, leader of the outlawed Nepali Congress, said, "No one need make arrogant threats of launching revolution or a movement, for every one now realizes the true strength of The outlawed Nepali each group. It has been able to to claim that it is strong only because it has face anyone. had to condition will become pitiable if it contests elections tomorrow. the Nepali Congress (0) has been reduced to such a condition, communist slogan of revolution is a mere day-dream. Panchas are corrupt,

but they have taken roots in every village Panchayat and in every ward."

"Previously, I was under the impression that the people were on our side... But how hollow our position had become became clear during the local Panchayat elections... To our surprise, we found it difficult even to find competent candidates. It was clear that we were deluding ourselves. We were entertaining the illusion of being a strong party only because we had not had to face anyone..."

Royal Audience to Nepali Congress (0) Leader

According to a Press note published by the Central Office of the Nepali Congress (0), His Majesty King a 2-1/2 - hour Birendra granted audience to Ganesh Man Singh in the evening of November 23. The Press note added, "During the audience, Ganesh Man Singh presented his views regarding political change." Singh has described the audience as "very constructive and useful." (Samaj, November 25). This was said to be the first time that Ganesh Man Singh had been granted an audience by His Majesty. Prime Minister Marich Man Singh Shrestha was also present during the audience, according to the Saptahik Bimarsha (November 25).

Govinda Duwal Remanded to Custody

The Bagmati Special Court remanded persons custody sixteen to connection with the murder of ex-National-Panchayat-Member (NPM) Karna Prasad Hyoju in Bhaktapur in August, They included NPM Govinda 1988. Duwal and Narayan Man Bijukchhe (Rohit). Five other persons were released on bail. (Gorkhapatra, November 1).

Lama Gets 6-Year Jail Term

The Central regional special Court has sentenced former Inspector General of Police Dil Bahadur lama to six years imprisonment along with a fine of more than Rs. 34.6 millions on the charge of indulging in corruption. The court found the accused illegally taking money from

contractors in the form of donations for construction of school and the police fund for approving tenders of the Police Headquarters. He was also found misusing funds of the Police Headquarters for personal use. (Rising Nepal, October 5).

Map of the Mt. Everest Region

A topographical map of the Everest-Khumbu area in the eastern region of Nepal was prepared in Switzerland by the Boston Museum of Science under the auspices of the National Geographic Society of the United States and the Department of Survey, Nepal. A copy of the map was to His Majesty presented Birendra at the Royal Palace on October 3 by Dr. Bradford Washburn, Director of the project. (Rising Nepal, October 4).

The map has been published in the November, 1988 issue of the National Geographic Magazine along with five articles related to Nepal.

Subhas Ghising's Statements

Addressing a public meeting Kalimpong, India, on September 30, . Subhas Ghising, leader of the Gorkha National Liberation Front (GNLF), demanded severance of all relations with Nepal on the ground that it had given no support to the " Now that He said, movement. Gorkhaland has been created for the Gorkhalis living in India, all Nepali migrants, that is, Indians of Nepali origin living in Nepal, should return to Darjeeling and become partners in of reconstruction task Gorkhaland under the banners of the Gorkha Hill Development Council, because neither the King of Nepal, nor the Nepal Government, nor the Nepali people have helped us. We will not expect any cooperation from Nepal in the future." Subhas Ghising announced that Nepali

Subhas Ghising announced that Nepali migrants in India would no longer call themselves Nepalis. Instead, they would call themselves Gorkhalis, he said. He informed that there would be no reference to the term "Nepali" in the constitution of the proposed Gorkha Hill Development Council. (Arati Weekly, October 6).

Besides that, I would like to add my own views. Almost for the last two hundred years, untrained young people from the mountains of Nepal have left their country in search of job and food. If these young people could have got better education at home, they could have lived a better life after returning home. Unfortunately, they have to spend their youth outside their homeland and later, they live at home with a meager pension for retirement. It was only after 1960 that many trained people started leaving home for abroad. In one way or the other, they have contributed a lot for the benefit of the home country. A large number of Nepalese are now studying in the U.S.A. than ever before. The people who have settled here are helping their relatives financially. Some of them even have been fortunate to get health care in the U.S. Some of them including myself received the opportunity to visit the U.S. to broaden their outlook. Those who are living in the U.S. should help for the betterment of education in Nepal. In this way, more people will be brain trained and become capable of serving their land either locally or from abroad.
