

ROLLING GREEN COUNTRY CLUB RULES & REGULATIONS

Revised May 2019



1. THE ROLLING GREEN COUNTRY CLUB DRESS CODE IS:

- A) **Shirts and shoes must be worn at all times.**
- B) Shirts shall be appropriate for golf and a private country club. **Tank tops, halter-tops, tube tops and T-shirts, for example, are unacceptable.** Men are required to wear appropriate golf attire (golf mock collars are included), shirts with a collar **and** sleeves; women are required to wear shirts with a collar **or** sleeves.
- C) Shoes shall be appropriate for golf and a private country club. **Metal spikes are not allowed at Rolling Green Country Club.**
- D) Shorts shall be appropriate for golf and a private country club. Tastefully tailored shorts that stop just short of your knees, for example. **Short-shorts, gym shorts, basketball or soccer apparel, jogging shorts, bicycle shorts, cut-offs and swimsuits are unacceptable.**
- E) Pants and slacks should be appropriate for golf and a private country club. Clean, neat, blue jeans in good repair are acceptable attire. **Your boxers showing through holes in your ragged blue jeans is unacceptable. Jogging suits and sweat pants are unacceptable.**
- F) The Pro Shop is responsible for making judgments as to attire appropriate for golf and a private country club, **and is required to refuse access to the golf course for violations of the dress code.**
- G) Members, their families and guests are required to be neat and presentable at all times.

The bottom line is to dress comfortably and look good.

2. ROLLING GREEN COUNTRY CLUB CODE OF CONDUCT:



- A) All golfers are expected to follow the semi-official "rules of courtesy" known as **golf etiquette.**
- B) All golfers are expected to do their part to keep the course in good condition. **Repair ball marks** on the greens, **replace divots** on fairways and tees and **rake the bunker** after you play out of it.
- C) **Golf carts should be parked well away from greens, tees, and bunkers.** To speed up play, golfers should park on the side of the green nearest the next tee. Physically challenged golfers may request that a colored flag be attached to their cart to indicate that they are allowed to drive off of cart paths and are allowed to park close to greens, tees, and bunkers.

RGCC RULES & REGULATIONS

Any infraction of the following rules should be reported to the Pro Shop immediately.

Repeated violations of the following cart rules may result in loss of cart privileges.

- Carts are to be kept on cart paths whenever possible.
- Observe all directional signs.
- No more than two riders are permitted in a cart at any time.
- Avoid sharp turns and steep inclines.
- Avoid all wet areas, newly planted areas, ground under repair, and roped or other designated areas on the golf course.
- No one is allowed to drive a cart without a valid driver's license.
- Operators of golf carts are responsible for damages to the cart or to the golf course resulting from the operation of the cart.

D) Private golf cart owners will pay an annual fee to be determined by the Board of Directors. Due to lack of storage facilities, private carts are limited in number.

E) In the interest of the safety and well being of members, their families and their guests, **drunkenness or belligerent behavior will not be tolerated** on the course or in the clubhouse. Repeated violations may result in the termination of the offender's membership.

F) Dogs belonging to the Golf Course Superintendent are the only dogs allowed on the golf course at any time.

G) **Men's day and Ladies' day are in effect from May 1 to October 1. All Rolling Green facilities are restricted** to men or women as specified below:

- Men's day is from 1:00 p.m. to closing on Wednesday. Men's day is restricted to male golfers age 21 and over.
- Ladies day is from opening to 1:00 p.m. on Thursday. In addition, ladies will be given preference on the first tee from 1:00 p.m. to closing on Thursday.

H) **Kids' golf day is Friday morning and is in effect from the third Friday in June through the second Friday of August.** The kids' lesson is from 9:00 a.m. to 10:00 a.m. The first tee is closed to adults from 10:00 a.m. to 12 noon unless a golfer under the age of eighteen (18) accompanies the adult.. Kid's day dates and times can change at the discretion of the golf professional.



3. USE OF RGCC FACILITIES

A) **Members have use of Rolling Green Country Club facilities as follows:**

- Membership dues shall be payable beginning January 1 of each calendar year. Members may elect to pay dues in one single payment on or before January 31st or in equal monthly installments from January through December, before the last day of each month.
- All unpaid single payment dues are considered delinquent as of May 1st of the current year. All membership privileges are suspended as of May 1st until dues in arrears are paid in full. If dues are not paid by June 1st, the Board of Directors will terminate the membership.

- Unpaid monthly installment dues are considered delinquent on the last day of the month that the monthly payment is due. All membership privileges are suspended when dues are thirty (30) days in arrears.
- When dues are paid on the basis of a family membership, the member's dependents age four (4) and older enjoy use of all Rolling Green Country Club facilities. (Please see *AMENDED BY-LAWS OF ROLLING GREEN COUNTRY CLUB ADOPTED JULY 13, 2008* for the definition of dependents)
- When dues are paid on the basis of a single membership, dependents of the member enjoy use of all Rolling Green Country Club facilities except golf.
- Dependents that are under age four (4) enjoy use of all Rolling Green Country Club facilities except that they are not allowed on the golf course.

B) Non-members may use Rolling Green Country Club facilities as follows:

- All non-members are welcome to play in tournaments that are not restricted to members only. Entry fees, green fees and cart rental fees will be charged as appropriate.
- Tourists and others that live more than one-hundred (100) miles away from Rolling Green Country Club are welcome to play when doing so does not interfere with club activities or when play is not heavy. Green fees and cart rental fees will be charged as appropriate.
- Area resident non-members (those residing within a one-hundred (100) mile radius of Rolling Green Country Club) can play three (3) times per calendar year as the guest of a member or members. Green fees and cart rental fees will be charged as appropriate.

4. JUNIOR GOLF PLAYING PRIVILEGE



Encouraging and supporting beginner golf is critical to the long-term health of the game. Rolling Green Country Club has made golfing privileges available to a limited number of resident, non-member young people. Junior golfers age ten (10) through age eighteen (18) (or through age twenty-one (21) if a full-time college student) may be granted golf privileges on a first-come, first-serve basis subject to the following:

- A) The junior golfer must be sponsored by a current RGCC member in good standing, and must re-apply for junior golfing privileges each year.
- B) The junior golfer must possess sufficient playing and etiquette skills to pass a minimum proficiency test administered by the Golf Professional.
- C) Playing privileges under the junior golfer program are subject to review and/or cancellation at the discretion of the Golf Professional and the Board of Directors.
- D) Fees for junior golfer playing privileges are due and payable prior to use of RGCC facilities. Upon payment of fees, the junior golfer has playing and clubhouse privileges on Monday, Tuesday, Thursday after 1:00 p.m., Friday, Saturday after 3:00 p.m. and Sunday after 3:00 p.m.
- E) Junior golfers are required to observe all RGCC rules and regulations.



5. OTHER IMPORTANT MATTERS

RGCC RULES & REGULATIONS

A) Any debts related to assessments; or, any bar or pro shop charges that are not paid in full within sixty (60) days of those charges will result in suspension of membership privileges until such charges are paid in full.

B) It is expected that these RULES AND REGULATIONS should be a useful reference for some time, but policies and practices can change. Rolling Green Country Club reserves the right to make necessary changes dealing with golf course matters, and the statements in these RULES AND REGULATIONS may change. If and when changes are made, copies of the newly revised RULES AND REGULATIONS will be provided to all RGCC members. If you have questions or if something does not make sense to you, talk with the Golf Professional or with your Board of Directors.

C) In the event of any inconsistency between these RULES AND REGULATIONS and the *AMENDED BY-LAWS OF ROLLING GREEN COUNTRY CLUB ADOPTED MAY 29, 1997*, the By-Laws control in all cases.
