1) CONSIGNMENT is by appointment only. All items must be current in style and no more than two years old, MUST be freshly laundered/dry cleaned, pressed & on hangers. Consignment period (60 days), and pricing is based on mall/designer labels, season, condition, and consumer demand. Any clothing requiring steaming will incur a \$0.50 steaming fee per item to be deducted from consignor account. A 3% credit card fee will be charged to Consignor accounts for all sales involving credit card transactions. Early withdraw of merchandise is not permitted. Upon expiration, all unsold items automatically become the property of Frugalicious. There will be no payment on expired items. Consignors who wish to retrieve unsold items have 3 days after the expiration date and are required to pull their own items off the sales floor. We are not obligated to remind consignors of item expiration date or return rejected items. We WILL NOT hold rejected items for pickup. Items later found to be unsuitable for sale will be rejected and donated to charity.

2) SALE PRICE-Frugalicious will set the prices for all items accepted on consignment. Periodic sales & markdowns will be at the sole discretion of Frugalicious based on condition, season, stock & demand, desirability factor, and length of time on sales floor.

3) ANNUAL CONSIGNMENT FEE -is \$15 and must be paid by cash or check upfront. This charge is non-refundable and good for one year. **(Circle one):** Paid CASH/Paid CHECK# _____. Contract expires _____.

4) PAYMENT/COMMISSION-When items sell, funds will accrue in consignor account based on the commission split selected by Consignor. Please select one of the following options:

(Initials _____) Option 1: (CHECK PAYOUT) This option applies to our standard policy in which consignors may use the funds in their accounts to shop with at any time, and also request a payout check for amounts over \$20. As always, payouts are done per request only, request must be received by the 5th of the month with checks cut on the 10th of the month, for the previous months sales. month (some exceptions may apply depending on unexpected circumstances such as weather, store closures, etc). Checks will not be mailed automatically. All consignor balances/payments not picked, up/checks not cashed, within one year of consignment/check issuance will be considered forfeited to Frugalicious. Commission paid is 30%-50% based on brand and/or label, and price point (60% in some rare cases for couture items).

(Initials _____) Option 2: (STORE CREDIT ONLY) This option is for consignors who will ONLY be using the funds in their accounts to apply to in-store purchases. No checks will be issued on this type of account. Commission paid is 50% on ALL ITEMS consigned regardless of brand/label/price point (and 60% in some rare cases for couture items). This option cannot be changed once selected. All accounts inactive for one year will be closed and balances will be forfeited to Frugalicious.

5) DISCLAIMER- All items are left at owner's risk. While we will do our best to safeguard your items Frugalicious assumes no responsibility for loss or damage to merchandise due to accident, fire, theft, vandalism, or any other cause. I hereby warrant that I have complete title to the merchandise consigned, and I do not hold Frugalicious responsible for any claim of title to it.
