General Information on Grants

- Requests for grants must fit within the stated purpose of the Foundations: to support the cultural, educational, health-related, religious, and civic organizations which serve the people and communities of the town of Litchfield, including Bantam, East Litchfield, Milton, and Northfield Connecticut.
- Grants are intended to provide major support for specific capital projects and will not be made to individuals, annual appeals, or general endowment funds.
 Grants are not made in support of programs, salaries, operating expenses, trips, concerts, events, and the like.
- The present policy gives priority to large capital grants. However, the Foundations accept proposals for smaller requests, from smaller organizations, and for seed money for vital start-up programs.
- The Foundations look favorably upon requests for matching grants.

Grant Application Requirements

- Applicants must be exempt from income taxes under Section 501(c) of the Internal Revenue Code, affiliated with a municipal entity within or associated with the Town of Litchfield, or a recognized religious organization.
- Applications are not accepted from municipalities or departments other than those in Litchfield.

Application contents

- o A completed application form
- o A letter describing and attesting to the application, including how your organization serves the purposes of the Seherr-Thoss Foundations: to support the cultural, educational, health-related, religious, and civic organizations which serve the people and communities of the town of Litchfield, including Bantam, East Litchfield, Milton, and Northfield, Connecticut.
- Projected budget stating the expected sources and amount of needed funds
- Basis of your cost assumptions (i.e. competitive bids, information about the choice of vendor/contractor)
- Copy of the latest annual financial statement, preferably audited
- Any additional information that may be useful for evaluation

Application Deadline

There are two grant cycles, in spring and fall.

Proposals may be submitted at any time.

Deadlines are decided at each board meeting and are posted on the website.

Application Review

Applications are screened for completeness, clarity, and compliance with eligibility requirements, and are acknowledged by return email within one week of the application deadline.

Excessive information is discouraged.

Some applications may require informational queries or site visits by Board Members regarding grant requests.
