#### AGENDA - BOARD MEMBER REPORTS

**A. PTSC 10/18/2026 Board Minutes (See Handout):** Brooke to fix typographical errors in paragraph H and send updated version to Don.

**B. PTSC October 2025 Treasurer's Report: Mark Madeira** - Mark explained several checks cleared at the same time causing an overdraft. The overdraft protection prevented additional charges.

**C. PTSC Membership Report: Just Geary** - We have 128 members. One new member joined to attend next year's regional and one member was dropped.

**D. PTSC Inside Coordinator's Report: John Jeffries** - 3rd Quarter report is filed and PTSC is in good shape for Chapter Top Flight Award. Mark is to send John the canceled checks for the charitable contributions.

**E. PTSC Outside Coordinator's Report: Bob Stokes** - Last year we grossed \$504 from regional and PTSC merchandise sales.

**F. PTSC Newsletter Editor's Report: Jimmy Patitucci** - We are good for technical articles for the year. The winter edition will be published after the holiday banquet. As a reminder, we need to start advertising for a new editor and officers for 2027.

**G. PTSC Judging Chairman's Report: Bill Bryan** - There is still a lot of changes regarding Concourse becoming Open Class. The new class will have two award levels called Emerald and Ruby. These awards are available at Chapter, Regional, and National events. Bill is to purchase two of each award at next year's Regional event for "stock".

**H. 2026 Regional and Discussion:** Due to the increased cost of Emerald and Ruby awards, the board unanimously approved to raise the registration fee for the Open Class to \$100. Don will update the flyer and the flyer provided to Driveline. The schedule has also been updated. Open Class judging will only occur on Friday. National has requested we have time for a memorial for Tom Barr. This will occur after the judging school on Thursday afternoon. National will take care of this. Don and Mike created a Regional sponsorship form. Mike believes the fundraising effort is already in good shape. Don will print another 120 copies to include with the annual member mailing coming up in December. Jimmy is to include it in the next newsletter.

### AGENDA - NEW BUSINESS ITEMS FOR DISCUSSION

**L. Other Ideas for the Good of the Organization: (Board Member's Name/ Topic/ Comments)**

Don mentioned the MAC chapter has proposed they partner with PTSC for a regional in 2028. The board decided to discuss this proposal after the 2026 Regional. Bob Stokes proposed the January board meeting be a virtual meeting. The board decided to only do virtual in case of inclement weather. Jimmy noted this meeting now holds the record for longest PTSC board meeting. Bill proposed the idea of allowing "Pop-up" Chapter judging meets. This topic generated a lot of discussion about favoritism and the possibility of detracting from other Chapter meets. Mark made the following motion: Allow a Pop-up Chapter event at All Collectors Auto on December 14th. Registration fee will be \$100. The judges will be limited to Chapter members only and there will be no judging fees. All Collectors Auto will provide lunch. The topic is to be further discussed at the January 2026 board meeting.
