### O. MISCELLANEOUS PTSC TOPICS FOR DISCUSSION:

Comments: John Kuhns floated the concept of PTSC hosting an open "Corvette" or "Car Show" to be billed as fun event with the monies raised to support a local or nationally-recognized type of charity. Trophies may be awarded to selected show vehicle participants — trophies recognized by titles such as "Chapter's Choice", "Mayor's Choice", "Public's Choice", "Lady's Choice", "Kids Choice", etc. No actual NCRS type of Flight or Concours Judging would take place. This would help to fulfil hosting a charity money raising type of event as well as to help to educate as well as promote NCRS to the public and to those non-NCRS member Corvette owners.

Following a general discussion on this concept, John was asked to develop additional information on:

- NCRS National's view (guidelines?) to host this type of event;
- promotion of the event;
- possible personnel volunteers required (set-up crew, registration/fee collection, parking assistance, trophy presenter, clean-up crew, etc.);
- potential location and field rental fee;
- perhaps allowing independent food vendor(s);
- guesstimate of PTSC expense budget, trophy cost, and show entry fee.

John to provide an update at the next PTSC Board Meeting.

[Note that the NCRS Mid-Atlantic Chapter (MAC) has conducted a similar activity called "Corvette Day" that is open to Corvette owners regardless of NCRS or other automotive club member affiliation for many years. They donated their money raised, minus MAC event expenses, to their own club's designated charity group. Unfortunately, the 2020 event had to be canceled due to the Virginia COVID-19 activity.]
