- A. Camaro Shop Visit, Latrobe, PA on Saturday, May 16th:** Canceled.
- B. B&D Chapter Judged Meet, Latrobe, PA on Friday, June 5th and Saturday, June 6th:** Canceled. Norm Neffield to send a letter to Darlene for her to apply our deposit to our early June (4th-5th?) 2021 judged event.
- C. Pittsburgh Vintage Grand Prix:** Has not been canceled.
- D. PTSC Picnic, North Huntingdon on Sunday, August 9th:** May be our chapter's next event.
- E. Flight 93 & Get Together, Stoystown on Sunday, September 20th:** Has not been canceled.
- F. Westmoreland Food Bank Emergency Donation Request:** Norm Neffield motioned to donate \$1,000 now to the Westmoreland Food Bank and seconded by Jimmy Patitucci – the vote to pass was unanimous.
- G. 2023 PTSC Regional:** Don Geary the Event Planning Chairman had e-mailed proposed facility specification copies to the PTSC Board Members for both the Seven Springs and the Blair County Convention Center locations. Dave Kitch announced that he had contacted the Ramada Greensburg Conference Center, the Hilton Cranberry Convention Center, and the Hilton Garden Inn in Southpointe – Dave was waiting for a call back from these locations to discuss their facilities in greater detail. Dave will follow-up with the Ramada and Hilton Cranberry locations and Bob Stokes will follow-up with the Hilton Garden Inn location. Any proposed location must provide indoor space for 50 Corvettes, attending personnel hotel rooms, tabulators room, team leader discussion room, judging schools presentations, host breakfasts and lunches, as well as accommodate the banquet. As soon as any facility options have been provided to Don, another ZOOM Special Board Meeting or at the next regular May 12th PTSC Board Meeting (should it be held) the site will be presented and forward to National for their approval. **Note that we want to decide on the regional date and venue as soon as possible because other NCRS chapters will be competing for a date due to cancellations this year.**
