Norm Neffield’s son was approved by the PTSC Board Members present to design the 2023 PTSC Regional logo. Bill Bryan would communicate to his Altoona Blair County Convention Center contact of our decision. We will have at least a year to begin the 2023 PTSC Regional detailed planning process.
