This is the story of how our 1954 Corvette has been in the family history for 3 generations and 52 years. My grandfather (Ray) wanted to get my father (Glenn) a car for his 14th birthday back in 1970. My father was in no way a speed demon or reckless but like any good father, Ray wanted to get him a car that wouldn't be tempting. Insert a 6 cylinder, 2 speed automatic Corvette. My grandfather found one for sale. It was a basket case, which he paid \$400 for. \$400 seems insanely cheap now, but back in 1970 finished driving 1954 Corvettes were around \$1000.

My Grandfather also wanted to teach my father the valuable lesson of working hard on something. If my father wanted to drive the car, he had to restore it. They used their one car garage to restore the car (see picture 3). Since reproduction parts weren't a thing, they had to buy another basket case 1954 Corvette and put the parts together to hopefully make one car.

My father used to walk around Carlisle wearing a sandwich board. The front of the board saying "53-55 Parts Needed" and the back saying "53-55 Parts Have".




They painted the car in the driveway of that one car garage. When my father asked what color could they paint it, my grandfather said, "Any color as long as it is Polo White". They finished the car and my father drove it all throughout high school and college all while never leaving his sight.


My father can attest the moment he knew he was going to marry my mother (Laura) is when he left her drive the car. They moved and lived just outside of Washington DC. For a while the 1954 Corvette was their only car. My father used to drive it to work in the mid 1980's. As we moved to Syracuse then back to Pittsburgh, the 1954 was put into the garage and became a glorified shelf. 3 kids were born, careers grow, life happens. Finally in 1999, the car came out of the garage and the 2^{nd} restoration began. This time with I was involved.





Like his father told him, my father said if I wanted to drive the car then I'd better go to work. My father, grandfather and I spent 4 years restoring the 1954. We painted the car ourselves. All of my siblings each got to spray parts of the car. It took another year after paint to assemble the car. It looks just as good now almost 16 years later than it did that day. We drive it everywhere including to Carlisle almost every year.

It always amazes people when they ask a 36-year-old how long have I owned the car, and I respond by saying "52 years". People love the pictures and the story. As I tell everyone, it's more the memories that are special to me. My father was able to restore this car with his father and his kids. It could be a Vega or a Pinto, its more the time wet sanding in a non-heated garage in February with my father that's special.



My Grandfather passed away this past January. 60 days later, his wife (my grandmother) passed away too. They both instilled so many valuable life lessons. Hard work, passion, determination, and humility are just some. Many of these lessons were taught through cars. Today we have restored and own 3 corvettes (1954, 1955, 1956) I know I cherish the time working on all these cars because of the spark my grandfather gave my father.

New IRS Requirements

There are new rules involving income and it has unstated effect on all hobbyist. The new rules force the reporting of transactions over \$600.00. How does that affect our hobby? If you as I recently did, sell something on eBay (or other systems) that is over the threshold or you sell more than the threshold during the year, you will receive a 1099K for that(those) transactions. If you normally file a business return your reported income has to exceed the amounts on the 1099K and all is good. If you do not normally file one you will have to file a schedule C and report that income. You will be able to deduct costs if you have receipts and just report net income or 0 if it is a loss. The problem is most of us don't have receipts for most of our hobby items. If you don't report on a schedule C you will be a prime target for an audit. You can get more information at IRS.GOV but it's a new twist on "buyer beware" now it is also "seller beware". If you used a tax preparer, be sure to make them aware of 1099K's you receive.

How to Set a Fuelie Electric Choke?

On the 58-61 enrichment housings also known as the choke. (*No chokes on FI's until 1962*).

Here is how I do it.

The last part I put on a restoration of the above, is the felt filter. My objective is to "set" the large pin (*aka*) power boost pin so it is depressed about 1/4-1/3 the way in. Not an exact science. To do that, I use my LED flash light to look in the small hole where the felt goes. I have the bake-lite cover on the loose side. I rotate the cover clockwise and watch the power boost pin being depressed. I go back and forth to get a feel of it and when satisfied I gently tighten up the 3 of $8/32 \times 5/16$ cad plated fillister screws. The retainer is under the screws of course.

Then I use my tester and set my timer to see how long it's going to take to go from the high step on the fast idle cam, to "off" the cam which is regular idle. Gail Parsons told me that time period varies. Gail said anywhere from 4 to 6 minutes. I think 6 minutes is too long.

Some of the new covers today do not get hot enough. Hence, the long period of time. The solution is to put the proper insulating material under the toaster like coil of wire.

Typically, I end up with about 4-1/2 minutes. Fast idle to regular idle. Then I put this in my notes for the customer.

Confused gang? I don't blame you. To do the above and learn the above has taken me an eon.

An important step!!! When installing the enrichment (*aka*) the choke cover, <u>make sure</u> the bottom lever of the assembly is in the middle of the two pins, so you don't bend them.

Last of all. If you have the large pin (*aka*) power boost pin depressed too far the car will run rich too long. The same idea applies to the '57's but it's not as easy to

do. '57's do not have a CSV. If you do not have a strong enough power boosts signal the engine will be difficult to start. We blame this on the

cranking signal valve when in fact it could be the setting I attempted to explain above.

After I am done, I use my AC/DC converter and test the operation is using 12.3-12.4 volts.

Hope this information proves to be helpful!

Restorers know that many of the parts on our older Corvettes have acquired a fair amount of rust on them over the years. Here is a product that I like to use to remove surface rust. *Evapo Rust* can be purchased at any local auto parts store. Easy and safe to use. You just soak the part in the product overnight and when you remove it, most if not all the surface rust is gone! Best part is that you can reuse the product over and over a number of times.

The 2022 Indy pace car was the new for 2023 Corvette Z06. Acknowledging the Corvette's 70year history, it is a 70th Anniversary Edition. The Corvette's paint is a special white pearl tri-coat metallic. It has special Corvette cross flags, red brake calipers and with the 70th Anniversary Edition logo on the seats, steering wheel and sill plates. Powered by a 5.5 liter engine that generates 670hp, making it the most powerful naturally aspirated V8 in a US production car. Special features are the carbon fiber rear wing, ground effects and carbon ceramic brakes. This is the 33rd time that a Chevrolet has paced the event field, dating back to 1948. It's the 19th time for the Corvette, the first being in 1978. This year the car was driven by former IndyCar driver and three-time podium finisher Sarah Fisher.


