

'Vette buyer shares ins and outs of finding his '65

hat might a car collector expect to see when he or she "kicks tires" on a sports car? If the car has been stored for a *long* time, buyer beware! That is the message in "My Latest Buy – Finding My 1965 Coupe," an article written by Bob Cirilli and appearing in the spring 2019 newsletter of the Tri-State Chapter of the National Corvette Restorers Society.

After a three-month wait, Cirilli finally made it to the spot where several Corvettes were stored, all in various stages of condition. "I was led back to a plastic cover. As it was pulled off, I saw a '65 Corvette," Cirilli reported. Loaded with extras? Not quite. But it was "loaded with dirt inside and out."

Still, Cirilli liked that model. As he inspected further, it was evident the brake pedal went to the floor and the brakes had to be replaced top and bottom, and "the radiator was shot."" Despite these factors, the car started, ran great and there were no serious leaks evident. Underneath, the car looked like you would expect for a 54 year old. There were little issues with a switch and other factors that Cirilli would have to address.

If you are new to the old car hobby, you might not realize that some makes and models are judged stringently. The topic of Corvette originality was explored later in that issue, as editor Jim Patitucci explained the very fine points of the Corvette valve cover engine suffix code label. Used in late 1966 and later, the tag "was intended for plant personnel to quickly identify the engine to be pulled" from Chevrolet's engine inventory which, back then, was at the St. Louis plant. Those labels were not intended to last much longer than that, but more than a few still survive. This application appears to be the natal stage of "broadcast codes" which trailed parts and matched them with the necessary others. Eventually, tracing and matching codes became a mainstay of automobile assembly plants. It is an interesting bit of history how those paper labels were successors of crayon markings, which are even rarer as survivors.

Condition, originality, completeness and function are factors when buying an old car, but above all, the buyer should really like what's there and, like Cirilli, see the strengths that remain to be enhanced.

The team is available from 9 a.m. to 9 p.m. EDT Mondays through Fridays. The 2020 Chevrolet Corvette Stingray goes into production at GM's Bowling Green Assembly in late 2019.



"TOUCHING UP WITHOUT MAKING A MESS OR DOING A RESTORATION" BY: Bob Cirilli

I have written other articles surrounding the 65 coupe I bought in January and have been working diligently to get it road worthy. To relay the ground work, I located a basic barn find in January of 2019 later in this article you will see a picture of what the engine compartment looked like then and now.


This Corvette looked like what you would expect to find in an unrestored 54 year old car. This article deals only with the engine compartment but great pain was used to do the undercarriage as well. It should be noted that it was never my intent to put this car through NCRS or any other judging. I had never owned a mid-year coupe but this was my chance for my 12th Corvette to be a coupe with side pipes.

We have all used spray cans of paint to do little jobs finding it a mess when trying to detail an engine compartment without pulling the engine and everything else. This little trick may help you. First I pressure washed the compartment down then I used a Task Master by Well-Worth, a general cleaner. In the last picture you will see two quick sprays, the one on the right (the larger one) came from a regular paint can head. The smaller one on the left came from a head that had a tube inserted. The tube is like the ones on a can of WD40. The tube allows you to be very precise with directing the much smaller paint diameter. It should be noted you may have to switch the can head to one that will accept the tube. I did the engine block in orange, the intake and valve covers in cast and the rest in black.

While this isn't show quality it went from ugly to presentable in about two hours. Note also I installed the correct air cleaner between pictures.


Engine before cleaning & repainting.

The 1973-74 TIM&JG 3rd Edition Revision Team Members Design Challenge Coin.....by Jim Patitucci

Getting people to volunteer for a project of this caliber is no easy task as many of you who have worked on a judging manual revision team know all too well. Once you get the group together and your goal is accomplished it now becomes important to figure out a suitable means to thank them for their dedication, contribution and commitment to the project.

That being said, we had a great group of 23 knowledgeable NCRS revision team members who worked on the long overdue 73-74 3rd Edition Revision. It was a project that took approximately 18 months to complete.

Revision team Chairman, Tom Russo came up with the idea to create a unique challenge coin to commemorate this project and use the coin as a token of thanks for team members. He enlisted the help of another team member Richard Ferraro who is an illustrator by trade to design the coin, and work persistently and patiently with the vendor on the project. The front of the coin (Heads) depicts the1973-74 Red Sunburst Cloisonné crossed flags emblem. The rear of the coin (Tails) depicts both rear views of each car, the chrome bumpers on the 73 and the unique "split" rear bumper on the 74. The coin measures 1.25 inches in diameter.

"Challenge coins represent anything from a small unit to the office of top leaders. These are also made for special events, anniversaries and even non-military leaders. If you've been in the military or worked for the Defense Department, you know what a challenge coin is. They've been an American military tradition for a century, meant to instill unit pride, improve spirit, and reward hard work and excellence." (Katie Lange.....Defense Media Activity, August 13, 2019). You may notice that the President has a collection of the coins displayed on the credenza behind him when he sits at his desk in the Oval Office when interviewed.

The 73-74 challenge coins were distributed among the team members with a thank you note from Tom Russo and 73-82 National Team Leader, Brian Pearce. It is rumored that other revision teams may follow suit with this as a way to say thank you. Let's hope this catches on and these coins can be collected and traded among the Corvette community for years to come...JP


