

Did you know?... The 1993 Corvette was the first GM car to feature a passive keyless entry system PKE. It worked with a battery - operated key-fob transmitter that sent a code to a receiver in the Corvette through one its two antennas. In coupes, antennas were in the driver door and rear deck. In convertibles, antennas were in both doors. All the owner had to do was approach the car with the transmitter, it would unlock the doors, turn on interior lights and disarm the anti- theft deterrent.








RPM Feature Article # 1"The Tale of TWO Key Fobs"

On a bright sunny day in November, I drove my 2015 to work and to meet an old friend for lunch. Everything went fine till I got home.

I backed into my driveway as normal and put the transmission in park. Pressed the Engine OFF button and waited maybe 2 seconds for the engine to shut down. I thought that was strange as it has never delayed before. Oh well, I grabbed the Oakmont Bakery treats my friend brought for my wife, got out and closed the door. While walking into the house I heard the car lock down and sound the horn. All is well!

About an hour later I went back out to the car to get the circuit boards my friend gave me. Low and behold, the car would not unlock with the Key Fob. Well, I must have a bad battery in the Fob, correct? Grab the other Fob and the same thing! Now what?

I remembered reading in the owner's manual about an actual KEY in the Fob that can be used in case of a lockout such as this. Found the key receptacle next to the rear hatch button. Inserted the key, turned it and the hatch pops open! Great I`m in. THEN THE ALARM WENT OFF!!

Now I'm fumbling for the door release cable to get into the car. Of course, the KEY FOBS are still inoperative. Get the door open, bang my head on the top getting in and press the start button! Yes, the alarm went off and the car started after inserting the Fob in the slot on the steering column.

On the dash an alert pops up—THEFT ATTEMPTED. Huh, give me a break. Well, that went away after a few seconds replaced by NO REMOTE DETECTED. Now that is easy. Replace the battery in the remote. But wait, BOTH remotes?

Get in another car, go to Walgreens, and buy remote batteries. Put the batteries in but no difference. Getting a little frustrated here. Now the owner's manual says to reprogram the remotes. Well now let's see how this goes.

The Owner's manual starts out with: Insert the special key, open the hatch, turn the key 5 times within 10 seconds then??? Is that 6 times because the first one opens the hatch or 5 times with opening the hatch. Guess I didn't stand on one foot with my tongue out because the alarm went off again!!! Get in the car again, watch your head, Fob in slot of steering column and start the car. Alarm stops, "Theft Attempted" alert replaced by "no remote detected". Back to square two.

It's getting late so I back the car in the garage, open the windows and go in for a Beer.

Before going to bed that night around 10, I went into the garage for something and then said, "what the heck let's see if anything changed"? Yeah, you guessed it, the remotes work just fine. Lock, unlock, hatch, remote start, everything!

RFM Feature Article #2

Everyone knows Don Yenko as the guy who set up a Performance Shop for Chevrolet vehicles at his family's Chevrolet Dealership in Canonsburg, Pa.

My friendship with Don was quite unique in the way that it came about. For the most part it wasn't about Corvettes, or even about racing. Here's a little story about Don that many may not know.

He absolutely loved to play the piano and was very good at it too! His favorite music was Jazz.

Back in the day my brother Tom and I owned a restaurant in Greensburg, Pa. called Caesar's Pub. During winter months at the Pub there was a Saturday afternoon jazz session. My brother played the drums in his own jazz group.

Don Yenko and his attorney friend would come in every other week to listen to my brother's group. Once in a while he would sit in and play the piano. It was obvious by the look on his face that he was in heaven while up there playing.

Back then, he admired my saddle tan 1963 Corvette fuel car that I frequently drove to the restaurant. During this time, I was also having my white '63 Corvette restored and was having an issue with a discontinued part.

One Saturday I went behind the bar to chat with Don and he asked how my white '63 restoration was coming. I told him I had a problem in that the original radiator was leaking "like Niagara Falls", and new GM service replacements were discontinued.

So, Don said to me, "Don't worry about it" as he probably had a stash of new ones in his attic at the dealership.

Wouldn't you know that the very next time he came to the jazz session he brought me a new radiator dated 1976. I was so impressed the he remembered. This all took place in the winter of 1981.

He was quite a fellow. He would drink a beer or two and once in a while order an appetizer. He didn't like it when the bartender told him "No check...it's on the house".

I was honored to be his casual friend and the fact the he drove from Canonsburg to Greensburg just to listen to the jazz group really impressed me.





"Midyear Corvette Turn Signal Switch Testing" By: Dave Kitch...Dave's Corvette Corner

If there is one part in the vintage Corvette restoration process that provides plenty of frustration. It is the turn signal switch. This switch controls the stop lights and the left and right- hand turn signals.

The problem with this switch is because of its fragile design and build. Fig. 1 shows the inside of the switch. Note that all of the external wires come into the switch and are connected to the various contacts in the switch. The lever is pulled down for a left turn and up for a right turn which connects terminal purple to terminals blue and yellow and terminal purple to blue and green, respectively. Should these spring contacts get damaged, or get distorted the lights will not work. Changing a switch typically requires the steering column to be removed. Also note the telescopic steering column switch is different from the standard column switch.







The switch can be tested in the car and with the steering column in place by performing a continuity test on the external wire harness contacts. I use a powered test lamp but a digital voltmeter can be used to measure resistance. Figure 2 at right shows a switch and its different colored wires. First disconnect the battery and separate the turn signal switch accordion connector from the body connector.







This is what the two crescent shaped connectors from the turn signal switch mate with
