All entries will be haul-in/haul-out due to limited space. All haulers must be parked on the race track only!

Draft Horse Hitch Show ......Sunday, August 3 at 1:00 pm

All entries for the Hitch Show will be taken ringside at 11:30 am.

## **Rules and Regulations:**

- 1. No equines showing evidence of any contagious or infectious disease will be permitted entry to the fair.
- 2. All equines to be exhibited at Pennsylvania fairs that are receiving State funds must be accompanied by a health certificate prepared, within 30 days of the opening date of the fair, by an accredited veterinarian.
- 3. The health certificate shall include the negative date of the Coggins Test which must have been conducted within twelve months of the opening date of the fair at which the equine is to be exhibited.
- 4. Mare and foal cannot accompany one another in individual classes except the mare and foal class.
- 5. Limit of two (2) animals per class per exhibitor.
- 6. All animals will be checked in at 11 am on Sunday, August 3.
- 7. No bedding is provided for livestock.
- 8. Park on track only.
- 9. Age requirements for all youth classes are 8-15 years old. Handlers must be 8 years old by January 1, 2025.

- 2. Purity of blood as established by pedigree, symmetry, size, early maturity and general characteristics of the several breeds of animals to be considered; the judges will make proper allowance for age, feeding and other conditions.
- 3. No exhibitor shall be permitted to win more than two prizes in any one class.
- 4. Individual animals shown in all of the group and herd classes listed below must have entered and shown in one of the following classes for single animals.
- 5. All animals must be registered as the property of the exhibitor.
- 6. No bedding will be provided.
- 7. All animals will be checked in 8:30 am 3:00 pm on Sunday, August 3.
- 8. Pens and stalls will be assigned with adequate tack space on the basis of the number of entries by each exhibitor. Each exhibitor's area will be clearly marked. All exhibitors will use the pens or stalls assigned to them. Management will reassign pens or stalls as deemed necessary. - 2. Have completed the fair entry as verified by their FFA Advisor/Ag Teacher prior to the fair.

All entries in this department MUST submit a Greene County Fair Entry Form in the name of the exhibitor postmarked by June 30. In addition, 4-H animal project entries, with the exception of market classes, MUST ALSO submit a completed Penn State Extension 4-H Project Entry Form, available from the Extension Office or from the 4-H club leader, to the Extension Office by June 1.

- All self-determined non-livestock entries must include the project book with entry.
- Any Department 10 classes or sections open solely to 4-H members list "4-H Members Only."
- Any Department 10 classes or sections open solely to FFA members list "FFA Members Only."
- All Department 10 classes based on age use the 4-H age of 8-18 on January 1 of the current year.
- There are NO FEES charged for entries in Department 10.
- Disputes about entries in Department 10 should follow the protest policy listed under general rules and guidelines in Appendixes 1-5.

The Market Beef and Lamb Sale held as a result of the Market Beef and Market Lamb Shows is Thursday, August 7, 2025 at 6:00 pm. In support of the Market Beef and Lamb projects, the Greene County Fair, in cooperation with the Penn State Extension County 4-H Program, provides a venue for and sponsorship of the Market Beef and Lamb Sale. 4-H and FFA members selling animals through the Market Sale retain full responsibility for and ownership of their animals up to and through delivery to and use by the buyer.

Exhibitors in Department 10 must comply with the General Rules and Regulations listed in Appendixes 1-5 of the fair catalog. Additional class specific rules and information are listed under each class.

All youth livestock exhibitors that show and/or sell animals through the 4-H and/or FFA programs MUST complete yearly Quality Animal Management Training (QAM) offered by Penn State Extension.

Registered Breeding Beef Cattle, Dairy Cattle and Rabbit entries must be registered in the name of the 4-H member. Proof of ownership shall be the name on the registration certificate. 4-H members must attach the original registration certificate to the Penn State Extension Project Entry Form due in the Extension Office June 1.

4-H and FFA Sheep and Goat entries in Department 10 do not have to be purebred animals as long as they are good specimens of their breed. To enter and show in OPEN classes, Sheep and Goats must be registered and have registration papers readily available at the fair and at ring side.

## 4-H, FFA & Open Release Time for 2025

## All livestock will be released at 10:00 pm on Saturday, August 9, 2025.

Livestock is not permitted to leave the grounds before 10pm on Saturday, except:

- Livestock entered in the Washington County Fair with proof.
- 4-H & FFA Market Livestock going to slaughter. Livestock will be released by the barn superintendent. Any other not on slaughter list MUST stay.

Premium checks will be distributed the week following the Fair only to exhibitors that remained on the grounds until 10pm on Saturday, August 10. Early removal will result in loss of premium and award. Checks will be mailed to exhibitor's address. Checks are null and void after 60 days and become property of fair if not cashed. Will not be reissued.

## Greene County, PA 4-H & FFA Jr. Livestock Project Rules

**4-H & FFA Department 10 Livestock Project Rules** are for the participation in all competitive breeding and market shows and market sales held as a conclusion to the Greene County 4-H & FFA project year.

Rules and guidelines in this document have been developed and adopted by the Greene County Planning and Development Committee to uphold and adhere to a standard for livestock project [participation to provide an equitable and fair educational project experience for all. The committee will oversee the livestock project rules to ensure the engagement of ethical, sportsmanlike, and safe practices in raising, showing, and selling livestock. Rules will be reviewed and updated annually. The committee will investigate, gather information and statements, if required, regarding and questions brought to their attention about the established rules and in matters of a junior exhibitor, parent, and/ or leader misconduct in relation to the 4-H & FFA Jr. Livestock Rules, the National Code of Show Ring Ethics, PDA animal health requirements. The committee will convene at least three members to hear the issue and, in private, discuss the course of action to be recommended to the 4-H Educator or FFA Advisor. Upon the 4-H Educator's or FFA Advisor's agreement with the recommended course of action, said committees will implement the recommendation and formal protests during fair time.

## Eligibility Rules for Greene County 4-H & FFA Member Participation in State Shows

- PA Farm Show Jr. Market and Breeding Shows: All livestock project members who successfully carry a livestock
  project at the county level are eligible to show market and/ or breeding animals in that species in the Jr. Market Show
  at the Pennsylvania Farm Show the following January. The member must follow the Farm Show Guidelines for tagging
  animals for market shows at the county level and for registering animals for breeding shows found at https://www.
  farmshow.pa.gov/pafarmshow/Pages/default.aspx.
- **Jr. Dairy Show at the All-American:** All dairy project members who successfully carry and show a dairy animal at the county level are eligible to show the animal in a district show as a qualifier for the state Jr. Dairy Show held at the All-American Dairy Show at the PA Farm Show Complex in September. Members must receive a blue award to qualify.

# Eligibility Rules for member participation in Greene County Department 10 Shows and Sales All Members:

- Follow the 4-H & FFA age requirements on January 1 of the current year for traditional members.
- Carry the project for which they wish to make entry in the associated county show in 4-H or FFA and participate in all aspects of the project, including show and/ or sale requirements to show and sell.
- Complete QAM (Quality Animal Management) training annually.
- Show their own project animal entry unless a request for extenuating circumstances has been made to and approved by the Planning and Development Committee in a timely manner. Extenuating circumstances may include but are not limited to: an injury or illness documented by a medical doctor deeming the member unable to show, a military obligation that takes them away from the area, or other extenuating circumstances that must be reviewed by the committee. In these cases, only another 4-H or FF A member can show the animal. For breeding shows, in the case of two entries in the same class, another 4-H or FFA member can show the second animal. Parents or other family members may also assist with the multiple entries in breeding shows.

## 4-H Members:

- · Adhere to the PA 4-H Code of Conduct for Members; and Parents to the PA 4-H Parent Code of Conduct.
- Must follow the state and County 4-H standards for participation including:
  - Enrollment as an active member in the PA 4-H online enrollment system: <a href="https://4h.zsuite.org/">https://4h.zsuite.org/</a> by March 31st.
  - Participate in a Greene County 4-H club and attends a minimum of 60% of the club meetings.
    - Exceptions can be made for college students or unforeseen circumstances with notification and approval to 4-H leaders and Extension Office.
  - Engages in the 4-H project work, including the completion of the project book under the supervision of a Penn State Extension 4-H Educator.
  - Participate in Project Interviews and Skillathon.

## **FFA Members:**

- · Adhere to the FFA Code of Ethics.
- Must be a dues-paying "member in good standing," defined as a member who:
  - Was an Ag Ed student during the currently completed school year and a current FFA member.
  - Is an enrolled approved FFA Member.
  - Engages in an SAE, including the completion of records under the supervision of an FFA Advisor.

<u>County Market Project Member Requirement:</u> It is a county requirement that all 4-H & FFA members engaging in a market rabbit, goat, steer, lamb, and swine livestock project be an active part of all aspects of the project, including participation in the associated Buyers' Appreciation Dinner held as a part of the market livestock show and sale.

Steer, Lamb, Rabbit, and Goat Buyers' Appreciation Banquet - 2nd Saturday after the Greene County Fair

All project members and parents must sign the following forms in acknowledgment they have read and agree to follow the rules for market and breeding livestock projects:

- 1. The National Code of Show Ring Ethics for all shows (2 copies attached; sign and return one copy).
- 2. 4-H & FFA Jr. Livestock Project Rules as listed in the document; sign and return signature page only.

Market Project members and parents must sign the following form to participate in the market sale.

1. The Sale Check Deduction Form: Required for all market projects; sign and return.

Market Steer Project members and parents must sign the following form to register.

- 1. County Owned and Bred Form: Required for market steer project; sign and return.
- 2. Club Rules and/ or Calendar.

## Greene County 4-H & FFA General Livestock Rules for Fairs and Shows

- 1. Read, Understand, and Adhere to the Information contained in this Packet of Jr. Market Livestock Rules: All members and parents must read the packet, complete and sign the acknowledgment page listing projects that will be taken and the location where housed, and agree to adhere to the established Jr. Livestock project requirements defined within for county shows and sales.
- 2. Adhere to Ethical Practices following the National Code of Show Ring Ethics: All members and their parents must agree to adhere to the National Code of Show Ring Ethics for raising, showing, and selling livestock at shows by submitting a signed copy of the form. Market livestock members will submit the document at the meeting before the initial project weigh-in; rabbit and breeding livestock members will submit the signed copy at the May 4-H club meeting or to the FFA Advisor; swine members will submit the signed document at the June 4-H club meeting before the July tag-in/weigh-in. The National Code of Show Ring Ethics names (identifies) the person who will be held accountable for the appearance and condition (health) of the animal as the "absolutely responsible person." This "absolutely responsible person" is defined as the owner/ exhibitor who, ultimately, is liable for any ethical violations regarding the animal.
- 3. <u>Use Safe Grooming Practices:</u> Use only grooming products that are approved for use on meat-producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residue in the meat. **DO NOT PAINT**, use coloring agents or unapproved products. Livestock animals can enter the food chain at any time; market animals will do so a short while after being shown. As the producer, the project member must provide a safe and wholesome product for the consumer. The Planning and Development Committee may adopt and implement various tests designed to monitor this prohibition, including but not limited to a "white glove or towel test." Any exhibitor found to be using color agents will forfeit any ribbons and premiums and will not be permitted to show in Greene County for one year. If uncertain that a product is residue safe and approved for use on meat animals, **do not use it! \*\*IMPORTANT\*\*** All Overall Grand Champion and Reserve Champion market animals will be subject to a **urine test** administered by a veterinarian or Planning and Development Committee member immediately after exhibition. Blood tests will be available upon exhibitor's request. If upon slaughter, treatment with drugs, biologics, or any chemical from fitting products or feed additives is the cause of the condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor.
- 4. House the Project animal(s) within a Proximity to Engage in the Project's Daily Care and Maintenance: All market and breeding livestock youth projects are provided for the education of youth members and require the member to be responsible for the daily care and maintenance of the animal. As such, the project animal must be housed near enough to the member to be taken care of on a daily basis; Parents and others can provide support and mentoring to guide the member's experience but should ensure the member is largely responsible for all aspects of the project work. Breeding project members must have possession of their breeding animals through birth from previously owned stock, purchase, or at least two months before the fair show. If leasing the animal, the lease must be presented to the Extension Office no later than June 1st. The Planning and Development Committee reserves the right to make on-site visits for compliance.
- 5. Submit Declaration/ Fair Entry Forms: A Declaration Form must be completed for all breeding animal projects and submitted by June 1st for the Greene County Fair. Fair Entry Form must be submitted by each fair's entry deadline for all animals (market, breeding, and carcass) entered in department 10 (4-H and FFA). A separate form must be submitted for Open Class Entries. For more information or forms go to the Greene County Fair website. 4-H market project members will complete Market Entry Forms at June meetings; FFA members can attend the June 4-H project club meeting to complete the market form. Members must notify leaders if they cannot attend. Both fair livestock entry forms include a line for the exhibitor to list the name of their veterinarian and a signature line to attest to the vet/ client/ patient relationship defined at: PDA Health Requirements and Recommendations for Animals for Exhibition. This document, developed from the Animal Exhibition Sanitation Law found at 3 Pa. C.S.A. 250 I et seq. is updated annually.
- 6. Secure Health Papers: All animals at exhibition are required to meet state health requirements. As defined in the PDA Animal Health Requirements and Recommendations for Animals for Exhibition, a CVI (Certificate of Veterinary Inspection), known as the health certificate, is required for all animals except rabbits exhibited at county fairs and shows. The health certificate must be dated within the time period designated by each fair as listed in the fair books. The swine CVI must be obtained within one month of the show. The CVI must be presented to the designated health agent upon arrival and before unloading at the fair or show. The CVI must be available at all times during the event to present upon request.

- 7. Participate in Market Show Classes as Scheduled: Each market show divides animals into three divisions: lightweight, middleweight, and heavyweight. When appropriate, the three divisions can be further divided into 6 or 9 classes by the FFA Advisor and 4-H Educator or Leaders. Class splitting will be determined with the discretion to split animals of the same weight into two classes. Class division decisions are final. Members must show their own project animal tagged in at initial weigh-in.
- 8. <u>Follow Showmanship Class Guidelines:</u> Each exhibitor is required to compete in their specific showmanship age group following 4-H age requirements: junior age 8-10; intermediate age 11-14; and senior age 15-18. Members must show their own animal for each market or breeding showmanship class for which they are entered.
  - If a market project does not make weight under the minimum weight allowed or over the maximum weight allowed at the final weigh-in, the member may choose to remain with their animal at the show and must participate in eligible showmanship classes but will not participate in the related market project class or sale.
- 9. Agree to a Sale Check Deduction: for expenses associated with the market sale. Each market sale has associated expenses, including pictures for buyers. Members and parents must sign the sale deduction form for the project sale and banquet.
- 10. Maintain and Complete 4-H or FFA Project Records: To be eligible to show, 4-H project record books and FFA SAE records must be "completed to date" at a minimum of two weeks before the animal project show; preferably at the last meeting held before the associated show "completed to date" is defined as the completion and addition of all information except that which is directly related to the projects show and sale. 4-H members must complete Project Interviews and Skillathon to be eligible to show and sell their project. Books will not be accepted at the final weigh-in. Those who do not do so will not be permitted to weigh in, show, or sell. Directly following the project show and sale, members must complete the remainder of the records by adding show and sale information club leaders or chapter advisors will determine the deadline for final completion and submission.
- 11. Participate in the Buyers' Appreciation Banquets: A county requirement of the market livestock project his member participation and the buyers' appreciation banquet held as a conclusion of the market rabbit, goat, steer, and lamb sale and the market swine sale. Project members must participate in all aspects of the project, including planning, set-up, the dinner, and clean-up. At the banquet, members will visit with buyers and present them with the buyers' pictures. The member must deliver the picture to the buyer and the event they do not attend the banquet. Market sale checks will be distributed at the end of the banquet to members present if payment has been made in a timely fashion. Checks for those not in attendance will be processed and available for pick up the second Monday after the banquet.
- 12. <u>Follow Scheduled Dates for Project Participation:</u> Project members will follow dates established for the current year's project, including weigh-ins and the Buyers' Banquet. A calendar for each project will be distributed at club meetings and made available to FFA Advisors.
- 13. <u>Assume Responsibility for Market Project Animals:</u> the daily feeding, watering, and care of the project animal is the responsibility of the member until the animal is released by the fair or show and loaded. Once loaded, the responsibility lies with the hauler, whether that be the member's family or an independent hauler, who must deliver the animal to the destination requested by the buyer.
- 14. If anything prevents a 4-H or FFA member from abiding by the above rules or if a violation is known, the Planning and Development Committee must be notified in writing immediately by e-mail to <a href="mailto:djc6764@psu.edu">djc6764@psu.edu</a>. All correspondence to the committees must include names of parties involved, name of author sending notification, contact information, description of the issue, and other relevant information/witnesses /evidence. Committee decisions will be delivered with the utmost care regarding individual privacy and confidentiality as situations warrant.

### **Rules and Regulations**

\*Violation of the Rules and Regulations listed below will result in the dismissal of the exhibitor's livestock with forfeit of premium and entry fee.

#### **SUBMITTING ENTRIES AND FEES**

- All entries must be submitted using the entry blank enclosed or online. Please complete in full.
- Entry fees must be included with entries. No entry fees will be refunded. A \$35.00 surcharge will be charged for each returned check. If not paid will not exhibit following year.
- 1.3 All entries must be in the name of the actual owner or authorized agent of the owner.
- No more than two entries may be entered in any one class by the same exhibitor.
- Entries must be postmarked or entered online by July 18th of the current year unless otherwise specified. Entries will not be accepted after that date. This includes market projects.
- 1.6 In addition, all 4-H entries must also submit an Extension 4-H Project Form to the Extension Office by June 1 (with the exception of Market Livestock Project entries made at time of fair weigh-in).
- Space for campers up to and including 34-feet is available for \$150.00 \$200.00 per week. Back row spaces have sewage and water hookup. Spaces will be assigned based on lottery. Please see attached camper application for more details. Camper space will be assigned.

#### **GENERAL ENTRY INFORMATION**

- The Management reserves the right to withhold any premium awarded under false representations or not in accordance with the Rules and Regulations and the premium list.
- 2.2 Where entry or entries are not up to standard, the Judge may award no premium, or may award no First Premium and may award Second Premium, even where there is but one entry.
- 2.3 Any exhibitor attempting to influence a judge's decision shall forfeit all claims to premiums.
- Exhibitors must deliver their stock and articles to the Superintendent of the designated departments. 2.4

#### **LIVESTOCK**

- All animals, including 4-H, must be in their places Sunday, August 3 by 3:30 pm and cannot be removed until. Livestock is not permitted to leave the grounds before 10pm on Saturday August 10, except for livestock entered in the Washington County Fair (with proof) and 4-H & FFA Market Livestock going to slaughter. Livestock will be released by representative doing the slaughter house list. Any other not on the slaughter list MUST stay. Early removal will result in loss of premium and award. Please check with superintendent of the barn on time.
- All animals, their health papers, and the Verification form will be checked by an authorized agent before 3.2 unloading between the hours of 8:30 am to 3 pm Sunday. Please make copy of this form for the fair to
- 3.3 No straw or bedding will be provided for livestock.
- Occupants of stalls are required to keep them open during the hours of Exhibition. See Fair Hours. 3.4
- With the exception of service dogs and carnival animals, only animals registered on a fair entry form with fees paid can be brought into the fair. All animals entered must be shown.
- 3.6 Exhibitors must be ready to show stock at the time designated in the program.
- 3.7 All livestock exhibitors must have health certificates available to show officials if requested and a copy when checking in for the fair to keep.
- 3.8 Exhibitors of purebred stock must have registration certificates available to show judges, other exhibitors, or superintendents if requested.
- 3.9 Individual animals shown in "all of the group" and "herd classes" must have also been entered and shown in a single animal class.
- 3.10 Substitutions will only be accepted in the case of an accident to or sickness of the animal originally entered. For premium to be paid after entries are closed for a substitution, request must be made to the Secretary's Office before noon on Sunday, August 3.

- 3.11 USE CAUTION WHEN FITTING ANIMALS. Be sure to use only grooming products that are approved for use on meat and dairy animals when fitting your animals for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat or milk. If you are not certain that a product is residue safe and approved for use on meat or dairy animals, do not use it!
  - \*\*\*IMPORTANT\*\*\* If upon slaughter treatment with drugs, biologics, or any chemical from fitting products, is the cause of condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor.
- 3.12 Sheep/Goat Blocking stands and Cattle Working Chutes can only be set-up in designated areas. They are not permitted to be set-up and used in wash racks and aisle ways. Department Superintendents can provide guidance on stand placement and indicate the need to relocate the stand or chute.
- 3.13 **RESTRICTION OF MOVEMENT AROUND THE GROUNDS.** Animals are not permitted above the cattle barn for any reason. This restriction includes the carnival area and the bleachers.

#### PROTEST/APPEALS POLICY – Filing a Formal Protest

- 4.1 Concerns about improper or unethical practices, procedures, or behavior in relation to and in violation of the fair rules as stated in this premium book will only be considered and investigated if submitted in the form of a Formal Protest.
- 4.2 Judge's decisions on placings and awards are final and cannot be protested.
- 4.3 A Formal Protest must be presented in writing to the Fair Management office secretary within 24 hours of the alleged violation and must be accompanied by a \$100.00 deposit made Payable to the Greene County Fair by cash, money order, or certified check. The deposit will only be returned if the protest is determined to be valid.
- 4.4 The protest will be reviewed by the Fair's Board of Directors or designees. The Board will make a decision and take appropriate action. If determined to be a 4-H matter, the Board can refer the protest to the 4-H matter, the Board can refer the protest on to the 4-H Extension Office for consideration.
- 4.5 If the protest cannot be resolved by the Board of Directors, legal authorities may intervene.

#### 5 GENERAL FAIR GROUND AND SAFETY INFORMATION

- 5.1 No unauthorized alcoholic beverages are permitted.
- 5.2 No bicycles or motorcycles will be permitted in the Livestock Areas or Carnival Areas.
- 5.3 No Smoking is permitted in any building.
- 5.4 Security will be provided by security personnel on the grounds by day and watchmen by night. Care will be taken for the preservation of stock and articles on exhibition and for the safety of visitors however, the management takes NO responsibility for loss or accident from any cause.
- 5.5 All vehicle parking is at "Your Own Risk." All livestock trailers are to be removed from the grounds on Sunday evening no parking is permitted on the grounds.
- 5.6 No drugs anywhere.
- 5.7 No animals to be above the arena barn leading to the midway at any time!

#### 6 PREMIUMS

- 6.1 All livestock premiums will be mailed out from the fair office. Premium checks will be distributed the week following the Fair only to exhibitors that remained on the grounds until 10pm on Saturday, August 9. Early removal will result in loss of premium and award.
- 6.2 Checks not cashed after 60 days are null and void, will not be reissued, and become property of the fair.

## **Appendix 2**

## **Pennsylvania Code of Show Ring Ethics**

Pennsylvania has developed a Code of Show Ring Ethics to curtail unethical, deceptive and fraudulent show ring practices. The Code is as follows: Exhibitors of animals at the Fair shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at the livestock show. All youth leaders working with junior exhibitors are junior an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible

persons who violate the code of ethics will forfeit premiums, awards and auction proceeds any may be prohibited from future exhibition in accordance with the rules adopted by the Fair Board. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

#### The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1. All exhibitors must present, upon request of show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any fact relating thereto is prohibited.
- 2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by show officials.
- 3. Junior exhibitors are expected to care for and groom their animals while at the show.
- 4. Animals shall be presented to the show or competition event free of unapproved or illegal drug residues. Market animals that will enter the food chain shall only use products that are solely in accordance with the USDA and FDA approved labels, and administered according to label instructions of the product being used for the approved species being shown. Product withdrawals shall be in accordance to all labels, with sale day being the last day of the withdrawal period. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal and state statutes, regulations or rules. The act of entering an animal in a livestock show or contest is giving of consent by the owner, exhibitor, fitter, trainer, and/or absolutely responsible person for show management to obtain any specimen of urine, saliva, blood, or other substances from the animal to be used for testing. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.
  - At any time after an animal arrives on the Fair premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.
- 5. Any drugs or implants injected or used shall be in accordance with USDA or FDA approved labels. All other surgical procedures, non-USDA or non FDA approved substances, or illegal injection of any foreign substance or drug, including drenching and pumping of fluids, or the external application of any substance (irritant, counter-irritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hooves or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7. Direct interference with the judge, show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them. They will be asked to leave!
- 8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics.
- 9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- 10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the Fair Board for violation of this Code of Show Ring Ethics. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the Fair Board may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
- 11. The act of entering an animal in the show is the giving if verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal and state statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

## **Appendix 3**

## **General Rules and Regulations**

- 1. The Fair Board management will exercise every reasonable care in the protection of exhibits but will not be responsible for loss or damage from any cause including fire or theft. All exhibits will be under the direction of the Fair Board but in no case will he or the County of Greene, County Commissioners or its agencies and instrumentality's be responsible for any loss or damage that may occur. Each exhibitor will be solely responsible for any loss, injury, or damage, done or occasioned by or arising from any exhibit entered by him and shall indemnify and hold harmless the Fair Board against such loss, injury or damage in regard thereto. Each exhibitor is required to sign a liability waiver/hold harmless statement as a condition of entry. For exhibitors 17 years of age or under this statement will be signed by his parent or guardian.
- All entries must be postmarked by July 18, 2024.
- 3. All competitive exhibits must have been grown, made or fashioned in Pennsylvania since last year's Fair unless otherwise stated under specific departmental rules. These exhibits must be the bona fide property of the exhibitor residing in Pennsylvania. The Fair Board reserves the right to reject any exhibit that is questionable as to variety or breed, or does not show excellence in its respective classification.
- 4. The Fair Board reserves the right to withhold any premium for lack of merit of exhibits and authorizes judges to award a lower place premium if deemed best. The Fair Board further reserves the right in case of determined ineligibility of an exhibit, following the judgment but prior to the close of the show, to grade up other exhibits of the same class and pay premium on the revised placings. The Show management will not assume responsibility for the payment of premiums offered other than those provided by the Fair Board. All premiums are subject to change by the Fair Board dependent upon funding support.
- Exhibitors are not permitted to bring livestock, other animals, or other items <u>not</u> entered for exhibit to the show building for sale purposes or other purposes.
- 6. All exhibits will be under the direction of the Fair Board. The show management and/or Fair Board reserves the right to interpret all rules and regulations governing the show, make such interpretations, decisions and settle and determine all matters, or differences, in regard thereto, as may be necessary for the proper conduct of the show. All such interpretations and decisions will be final. Protest may be made to the Fair Board by an exhibitor for any violation to the rules. All protests must be made by the protester, addressed to the Fair Board, received within 24 hours of the alleged violation. A \$100.00 fee must accompany any protest requiring an investigative procedure. Fee will be returned in the event the protest is sustained.
- 7. The space for competitive exhibits is limited. The Fair Board reserves the right to limit the number of entries in any department of the Show to those which can be accommodated in the available space. Any exhibitor who removes or tampers with stalling signage or stall charts will be disgualified from participation in the Fair.
- 8. The General Entry Blank should be used in all cases where no special blank is provided.
- Ownership of exhibits. All exhibits remain the property of the exhibitor unless otherwise specified in the Department Rules. All livestock will be released as noted in department rules. All other exhibits may be claimed by the exhibitor or his representative between 12:00 pm and 2:00 pm Sunday, August 10, 2025.
- 10. Any exhibitor violating the release time or other Fair Board rules or regulations may lose the privilege of showing at a future Show or be subject to other appropriate action as deemed necessary by the Fair Board.
- 11. Junior & Youth Division classes eligibility. These classes are open to 4-H Club members and Vocational Agriculture students. Exhibitors must be members of a regularly organized 4-H Club or be Vocational Agriculture Students, carrying a project in the field they wish to make entry and be under the supervision of the Pennsylvania State University Agricultural and Cooperative Extension Service or a Vocational Agriculture Instructor.
- 12. No alcoholic beverages are permitted. Violators will be subject to dismissal from the Show and forfeit all premiums.
- 13. Exhibitors must review and follow department specific rules

#### Livestock Rules

- Exhibitors shall conform to all requests of the management to lead out their animals for parade, exhibition, judging contest, or other purposes. Refusal will result in forfeiture of prizes won and such other penalty as the Fair Board may impose.
- 2. Pens and stalls will be assigned on the basis of the number of entries by each exhibitor. Each exhibitor's area will be clearly marked. All exhibitors will use the pens or stalls assigned to them. These facilities are to be used only to tie or enclose livestock. Entry cancellations will cause forfeiture of entry fees.
- 3. Livestock trucks to be on Fair property during show week shall be parked- under the direction of the Livestock Committee in the area set aside for such trucks as soon as unloaded. All trailers must be removed from the

- grounds Sunday, August 3 in the evening. Livestock trailers are not permitted to be parked on the grounds!
- 4. All applications for entries must be made on printed forms giving class number, age, registration number (in case of purebred animals) and all other necessary information. These forms after being signed by the exhibitor are to be filed with the Fair Secretary on or before closing date of entries.
- 5. To be eligible for competition, whether singly or in groups, animals (horses, sheep, swine, goats, dairy cattle, and beef cattle) must be owned by the exhibitor except where otherwise specified.
- 6. Fees must be paid at time entries are made. No entry fee is charged for Junior exhibits. Any junior exhibit entered into an open show must pay open show fees.
- 7. Exhibitors must have registration certificates available for inspection by management at all times until the judging of the breed is completed. Only original breed registration paper will be accepted when checking in entries. No Photostats, Facsimiles, or copies will be accepted. A copy also must be given to the check-in desk at the time of check-in.
- 8. Any exhibitor found to be showing an animal identified improperly will have the animal removed from the show and sale. All premiums and ribbons will be returned. That individual will not be permitted to show at the Fair for one year in either the Open Show or Junior Show. The name of the exhibitor involved will be sent to all County Extension offices and The State Department of Vocational Agriculture.
- 9. In all cases the right is reserved to reject entirely or accept conditionally, any entry or application for entry if stalls or pens are not available. No outside pens are permitted!
- 10. If a beef, sheep, goat, or horse breed does not have at least three exhibitors with a total of 15 animals exhibited each year for two consecutive years, that breed will be dropped from the show classification the following year.
- 11. No nurse cows will be permitted on the premises.
- 12. All exhibits must be in place as indicated in Department rules.
- 13. No entry fees will be refunded except when an applicant withdraws his entry before closing date for entries or when an application cannot be accepted on date of closing of entries because space is not available.
- 14. No animal will be awarded a prize unless removed from its stall and exhibited in the designated show ring at the scheduled time.
- 15. Substitution, within breed, of animals (horses, sheep, meat goats, dairy goats, dairy cattle, rabbits, and beef cattle) entered for reasons satisfactory to the management will be permitted until the opening day of the show, provided the animal substitution was owned by the exhibitor at the time entries closed. All requests for substitutions of this kind and the reasons therefore, together with a description of the substitution animal shall be filed in writing with the Fair Secretary
- 16. No person other than those holding animals being exhibited will be allowed in the show ring during the time of judging, except the officials.
- 17. Any movement of animals from one place to another within the Fair Show Area must be done with two people controlling the movement, one person to lead or control the animal, the other to position him/herself to provide cautionary warnings to the public.
- 18. Due to limited storage space and to prevent obstruction of aisles and tie areas, livestock exhibitors are not permitted to bring excessive amounts of feed, hay and straw into the barns. Exhibitors who furnish their own feed and forage may bring it into the barn between <u>7:00 am and 3:00 pm.</u> All supplies must be stored subject to the approval of superintendent.
- 19. Exhibitors will be required to maintain their respective areas in a reasonably clean and orderly condition at all times.
- 20. Trimming/Blocking chutes are permitted for beef cattle only, and remain in designated areas or they will be removed from the grounds.
- 21. The displaying of farm signs, banners, etc. over exhibits is encouraged. These displays must not interfere in any way with other exhibitors or with the conduct of the Show. Neither shall they create a safety hazard to animals or spectators.
- 22. Power washers, generators, and other electrical equipment are prohibited in the washrooms and wash rack areas.
- 23. Animal Health Regulations: The base date for computing health rules will be January 1, 2025.
- 24. Beef Cattle Tie Out Time Cattle may be taken to the tie out area at 10:00 pm, but must be in their exhibit area by 8:00 am. No pens are to be used or made for outside tie outs! No tents to be used to house livestock!
- 25. SAFETY: In the event that the show committee determines that the showing or displaying of an animal(s) is potentially harmful to any exhibitor, animal, or the public, Fair Board reserves the right to prevent, dismiss or excuse an exhibitor from showing or displaying his animal(s), and in extreme circumstances ask the exhibitor along with his animal(s) to vacate the premises.
- 26. Guidelines for Care of Animals: It is the responsibility of each exhibitor to care for animals in a manner that is responsible and ethical. Following are some guidelines for the treatment of animals exhibited at the Fair.

#### **Health Rules for Cattle and Steers**

- 1. **Certificate of Veterinary Inspection:** All cattle must be accompanied by a Certificate of Veterinary Inspection signed and dated by an accredited veterinarian with an inspection date within the 30 days prior to tile date of arrival at the show.
- 2. **Cattle Identification Requirements**: (a). All cattle for exhibition must be identified by a USDA-issued metal ear tag; a breed registration ear tag; or an ISO-compliant 15-digit ear tag (including RFID). (b). All market cattle must be identified by an RFID (tag).
- 3. Rabies Vaccination: A current rabies vaccination administered by a licensed veterinarian is recommended for animals three months of age and older (market cattle are exempt from this vaccination requirement). If given, all vaccine label directions must be followed, and all rabies vaccinated cattle must be accompanied by a rabies vaccination certificate or the vaccination information must be included on the Certificate of Veterinary Inspection. If a rabies vaccination certificate is provided, the certificate must contain the name and contact information of tile veterinarian who administered the vaccine and the veterinarian's signature. A copy of tile rabies vaccination certificate is acceptable. A rabies vaccination is not recommended for market steers.
- 4. **Other Vaccination Recommendations:** It is highly recommended that all cattle entering the show be immunized against IBR, PI3, BVD, and BRSV. It is strongly recommended that at least one vaccination against IBR, PI3, BVD, and BRSV be given within the 12 months prior to the date of arrival at the show.
- Influenza A: Dairy animals will be required to be tested for influenza A if there are active cases in Pennsylvania per the rules of the PA Department of Agriculture.
- 6. Out-Of-State Cattle (must also follow rules above)
  - Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases, an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."
  - Tuberculosis Testing Requirements:
     No test is required for animals originating from states or zones designated as accredited free by the USDA.
    - All animals originating from states or zones designated modified accredited advanced by the USDA must be test negative within the 60 days prior to the date of importation. The negative test results and dates must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original report is acceptable).
    - All animals originating from states or zones designated modified accredited by the USDA must originate from herds in which all animals 12 months of age and older are test negative within 12 months prior to the date of importation and the individual animals (all ages) to be imported are also test negative within the 60 days prior to the date of importation and at least 60 days after the negative whole herd test was completed. The negative test results and date of test must be included on the CVI or the animal must be accompanied by a negative test report (a copy of the original test report is acceptable).
  - Influenza A Testing requirements:
    - (a). The dairy animals shall have been part of a biosecure assembled group for a period of at least 30 days prior to the date of sample collection in accordance with subsection (b). below. New animals may not have been added to the herd or group within the 30-day period preceding the date of sample collection, or after the date of sample collection and before movement.
    - (b). Individual dairy animals 18 months of age and older shall be tested within the seven days prior to entry into the exhibition.
    - i. Lactating dairy animals—A milk specimen shall be collected for testing in accordance with the provisions of this section from each lactating animal. Milk specimens shall be collected in a manner that is in accordance with National Veterinary Service Laboratory (NVSL) guidance to the testing National Animal Health Laboratory Network (NAHLN) laboratory.
    - ii. Non-lactating dairy animals—Nasal swabs shall be collected for testing in accordance with the provisions of this section from each non-lactating animal. Nasal swabs shall be collected in a manner that is in accordance with NVSL guidance provided to the testing NAHLN laboratory.
    - (c). Milk specimens and nasal swabs shall be collected and submitted by or under the supervision of an accredited veterinarian (category II). The accredited veterinarian collecting or supervising the collection of the diagnostic specimens shall have a veterinarian-client-patient relationship (VCPR) with the owner or caretaker of the animal.
    - (d). Alternatively, "Monitored Status" for herds enrolled in a federally compliant influenza A dairy herd bulk tank testing program removes the need for individual animal testing.

#### **Health Rules for Cattle and Steers cont.**

- (e). Each specimen or sample collected and submitted under this section shall be tested for influenza A virus using polymerase chain reaction (PCR) testing and protocols approved by NVSL.
- (f). Testing of all specimens or samples collected and submitted under this section shall be performed at a NAHLN laboratory. The individual specimens shall not be pooled by the accredited veterinarian (category II) or any person other than at the NAHLN laboratory testing the samples.
- (g). All dairy cattle arriving at an animal exhibition shall have been tested in accordance with this section and shall have a negative or not-detected test result. The laboratory test report, or a copy of the report, shall accompany each dairy cow to the animal exhibition and shall be made available to the holder or staff of the animal exhibition and any Department employee. Animals enrolled and in compliance with an influenza A dairy herd bulk tank surveillance program in the state of origin and approved by USDA APHIS or the Pennsylvania Department of Agriculture shall be accompanied by proof of program enrollment and
- (h). Exemptions: Dairy cattle less than 18 months of age are not required to be tested for influenza A virus prior to exhibition.

#### Prohibition of exhibition of dairy cattle from influenza-positive, suspect, or high-risk farms:

- 1. Dairy cattle from a premises on which dairy animals are showing clinical signs of infection with influenza A virus are prohibited from entering an exhibition. Clinical signs may include a decrease in feed consumption, with a simultaneous decrease in rumination and rumen motility; respiratory signs including clear nasal discharge; and subsequent acute drop in milk production. Additional clinical signs may include abnormal tacky or loose feces, lethargy, dehydration, and fever. Severely affected cattle may have thicker, concentrated, colostrum-like milk or produce no milk at all. Animals showing clinical signs compatible with infection must be cleared by the State Animal Health Official.
- 2. Dairy cattle which have been on a premises where influenza A virus has been confirmed in dairy cattle are prohibited from entering an exhibition until that premises has been declared free of disease by the State Animal Health Official.
- 3. Dairy cattle which have been on a premises where influenza A virus has been confirmed in domestic birds are prohibited from entering an exhibition until that premises has been declared free of disease by the State Animal Health Official.

#### **Health Rules for Equine Animals**

- 1. **Certificate of Veterinary Inspection:** All equine animals must be accompanied by a Certificate of Veterinary Inspection signed and dated by an accredited veterinarian with an inspection date within the 30 days prior to tile date of arrival at the show.
- 2. Equine Infectious Anemia Test Requirements: All equine animals 6 months of age and older must have tested negative for EIA by an official test within the 12 months prior to the date of arrival at the show. A copy of tile official test results must accompany each animal to its final destination. A foal less than 6 months of age accompanied by a dam which meets the above requirements is exempt from EIA testing requirements. If the foal is less than 6 months of age and is not accompanied by the dam, a copy of the foal's negative test results must accompany tile foal to its final destination. The negative report must accompany the equine and must include an accurate description including age, color, sex, and any other reliable identification such as tattoos, distinctive marks, etc. Solid color animals must be identified by some method of unique identification such as a lip tattoo, brand, or at least two distinctive markings such as whirls. The name of the laboratory conducting the EIA test, and the date of the test and result must be listed on tile Certificate of Veterinary Inspection. A photocopy of the test report must be submitted with the entry form.

- 3. Rabies Vaccination: A current rabies vaccination administered by a licensed veterinarian is recommended for animals three months of age and older. If given, all vaccine label directions must be followed, and all rabies vaccinated equine animals must be accompanied by a rabies vaccination certificate or the vaccination information must be included on the Certificate of Veterinary Inspection. If a rabies vaccination certificate is provided, the certificate must contain the name and contact information of the veterinarian who administered the vaccine and the veterinarian's signature. A copy of the rabies vaccination certificate is acceptable.
- 4. **Other Vaccination Recommendations:** The Pennsylvania Department of Agriculture recommends that exhibitors consult with their veterinarians about the proper vaccination regimen for their animals.

#### **Health Rules for Goats**

- Certificate of Veterinary Inspection: All goats to be exhibited must be accompanied by a Certificate of Veterinary Inspection signed and dated by an accredited veterinarian with an inspection date within the 30 days prior to the date of arrival at the show.
- 2. Goat Identification Requirements: (a). All goats for exhibition must be identified by an official USDA scrapie eartag; a USDA-approved scrapie tattoo (in addition to individual ID); a USDA-approved custom scrapie eartag; an ISO-compliant 15-digit eartag (including RFID); or a breed registration tattoo if the tattoo is legible and the registration certificate accompanies the animal. The animal ID must be included on the Certificate of Veterinary Inspection.
- 3. Out-Of-State Goats (must also follow rules above)
  - a. Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases, an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."

#### **Health Rules for Sheep**

- Certificate of Veterinary Inspection: All sheep must be accompanied by a Certificate of Veterinary Inspection signed and dated by an accredited veterinarian with an inspection date within the 30 days prior to the date of arrival at the fair. All animals must be free of evidence of infectious and contagious diseases and a statement of this should be written in the CVI.
- 2. **Sheep Identification Requirements:** All sheep for exhibition must be identified by one of the following: an official USDA ear tag with a US shield; or a legible tattoo with herd and individual identification recognized in an approved USDA Scrapie database a.k.a. scrapie tattoo (flock ID in the right ear--state postal code and letters/numbers-- and individual animal ID in the left ear); or a breed registration tattoo if the animals are accompanied by a registration certificate (copy acceptable) and the tattoo is legible.
- 3. Rabies Vaccination: A current rabies vaccination administered by a licensed veterinarian is recommended for animals three months of age and older (market sheep are exempt from this vaccination requirement). All vaccine label directions must be followed, and all rabies vaccinated sheep must be accompanied by a rabies vaccination certificate or the vaccination information must be included on the Certificate of Veterinary Inspection. If a rabies vaccination certificate is provided, the certificate must contain the name and contact information of the veterinarian who administered the vaccine and the veterinarian's signature. A copy of the rabies vaccination certificate is acceptable. It is not recommended for market sheep to have a rabies vaccination.
- 7. Out-Of-State Sheep (must also follow rules above)
  - Vesicular Stomatitis (VS): This applies to cattle entering Pennsylvania from states that experienced a Vesicular Stomatitis outbreak in the last 12 months. In these cases, an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been examined and found to be free from VS. During the past 90 days, these animals have neither been exposed to VS nor were located within 10 miles of a site where VS has been diagnosed."

#### **Health Rules for Rabbits**

- Certificate of Veterinary Inspection: All rabbits to be exhibited must be accompanied by a Certificate of Veterinary Inspection signed and dated by an accredited veterinarian with an inspection date within the 30 days prior to the date of arrival at the show.
- Reporting of Disease: While on exhibit or at any time following exhibition, it is an obligation to report all mass mortality events and all rabbits who are ill and bleeding from eyes, nose, mouth, or have bloody stools to the Department's emergency line 717-772-2852, option 1. It is vital to guickly identify and prevent dangerous transmissible diseases such as Rabbit Hemorrhagic Disease (RHD) from spreading.
- Vaccination against RHDV-2: Vaccination of Pennsylvania origin rabbits against RHDV-2 is recommended.
- Out-Of-State Rabbits (must also follow rules above)
  - 1. Rabbits originating from a Commonwealth, State, Territory or Country identified as being affected by RHD within the 12 months prior to the start of the exhibition: No rabbits or their products, such as meat, pelts, hides, carcasses or other items, and no equipment, exposed feed, forages, or conveyances or other items or associated materials may enter the Commonwealth of Pennsylvania from a Commonwealth, State, Territory, or Country where RHD has been diagnosed in the prior twelve (12) months or there is a reasonable suspicion it exists unless they meet the following requirements:
  - (a) All live rabbits must be accompanied by a CVI and must be examined by an accredited veterinarian within the seventy-two (72) hours prior to the date of shipment to the Commonwealth of Pennsylvania. The CVI must include statements by an accredited veterinarian certifying that:
  - (i) All rabbits in the shipment have been examined for and found free of infectious, contagious or communicable diseases;
  - (ii) All rabbits have originated from a single premises that has no signs of infectious, contagious or communicable disease in rabbits;
  - (iii) There have been no movements of rabbits onto the premises of origin within the 90 days prior to the date of shipment; and
  - (iv) The rabbits have had no contact with wild or captive rabbits other than their cohorts in the 90 days prior to the date of shipmen
  - (b) No rabbits or their products, such as meat, pelts, hides, carcasses or other items, and no equipment, exposed feed or conveyances or other items or associated materials may enter the Commonwealth of Pennsylvania from a premises exposed to, contaminated with or known to be affected with RHD, or where there is a reasonable suspicion the disease exists or the rabbits have been exposed to or infected with RHD.
  - (c) Current information on affected states can be found on the USDA's website: www.aphis.usda.gov/ livestock-poultry-disease/rabbit-hemorrhagic

#### **Restraining Animals**

- Animals should be tied or penned in a manner that will not hurt the animal or restrict its breathing in any way.
- · Animals should be tied so that all four feet are firmly on the ground and they have enough room to stand comfortably and lie down.
- Animals should be tied so that they are not able to injure animals tied near them.
- Animals unaccustomed to each other should not be penned together.
- Animals may NOT be muzzled at any time.
- Handling any type of rough handling which could harm the animal is prohibited. The use of whips, canes and show sticks should be restricted to showing only and then should be used only to guide the animals, not punish them. Remember, animals will respond quicker and better to quiet, gentle handling than loud, rough handling.
- Bedding all animals should have bedding which is dry and clean. Pens should be cleaned regularly to keep the animals clean and comfortable. If non-traditional bedding such as carpeting is used, it should be regularly cleaned (at least twice daily) to keep the pen free from manure. Straw, shavings, and corn cobs are permitted. Exhibitors must supply their own bedding.
- Feed and Water animals should be well fed and have access to clean water regularly. Realizing that many market animals must have restricted amounts of feed to maintain the proper weight, animals must be fed adequate amounts of feed to meet the animal's basic requirements. Animals not allowed reasonable access to feed and water will be disqualified from the show.
- Transportation animals should be transported in a way that is both safe and considerate of the animal's well-being. In the winter, animals should be transported in enclosed trucks or trailers to protect them from the cold.
- Blankets/Sweat Collars any type of material such as blankets or sweat collars should be large enough to permit normal body functions such as breathing, eating, drinking or lying down.
- Health it is the responsibility of the exhibitor to provide proper health care for their animals through routine inspection and consultation with health care professionals. The improper or illegal use of drugs or antibiotics is prohibited. If medication is indicated, be sure to follow the label directions and allow more than the stated withdrawal time.
- GENERAL: Note: No animal showing signs of contagious, or infectious disease, or external parasites will be allowed entry to the show. Exhibitors must have all necessary health papers with the herdsman in charge when entries arrive at the show. All show animals should be held in isolation for at least 30 days after return to the herd of origin.
- **GROOMING:** Use only grooming products that are approved for use on meat producing animals when fitting any animal for show. Unapproved products may contain ingredients that result in unacceptable residues in the meat. If it is not certain that a product is residue safe and approved for use on meat animals, don't use it!
- MARKET ANIMALS: Animals consigned for slaughter during or immediately following the show shall not receive any treatment with drugs or biologics within the withdrawal time prior to slaughter. Withdrawal times for drugs and biologics are all stated on the directions for use. Label directions must be followed at all times.
- \*\*Important!\*\* If upon slaughter, treatment with drugs, biologics, or any chemical from fitting products, is the condemnation of a carcass, the loss of the carcass and any other damages will be borne by the exhibitor.

## **Appendix 4**

## **Foreign Animal Disease Alert for Exhibitors at Pennsylvania Fairs**

As a result of heightened awareness of security in the United States, foreign animal disease (FAD) surveillance is being increased nationwide. We encourage each of you to be particularly aware of any indication that could signal the occurrence of a highly contagious disease or any other unusual or unexplained adverse animal health event. No potential cases of foreign animal disease should be ignored.

Potential hoaxes should be treated as real threats until proven otherwise. Special attention should be directed at farms and other areas where there are large number of livestock and poultry.

Be particularly alert to these five signs:

- 1. Sudden, unexplained death loss in the herd or flock
- 2. Severe illness affecting a high percentage of the animals
- 3. Blistering around an animal's mouth, nose, teats or hooves
- 4. Unusual ticks or maggots
- 5. Staggering, falling or central nervous system disorders.

If you see something unusual, alert the Fair Superintendent or fair office.

- 1. If payment is not made prior to the beginning of the fair, the applicant will forfeit their space.
- 2. Payment can be made in person or be mailed to PO Box 806, Waynesburg, PA 15370.
- 3. The renter agrees to not sublet their assigned space. This also includes subletting any part of the premises or assigning this rental agreement to another individual.
- 4. Greene County Fair Board wants children to be safe and enjoy their time at the fair, but always under the watchful eye of a parent or guardian. Renters are solely responsible for the behavior of their child(ren). Greene County Fair Board is not responsible for the safety or welfare of a renter's child(ren) and assumes no liability while renter's children are onsite.
- 5. Only animals being exhibited at the fair are permitted to be on the grounds. No pets.
- 6. Parking will be provided in a designated lot for the duration of the fair. **There will be no parking permitted in the camper area.** Renters will be permitted to load and unload from 7 am to 3 pm daily.
- 7. Water, Sewage, and Electricity are included for the back row. Electricity is included for the front row.
- 8. Greene County Fair Board is not responsible for any electrical components on the renter's camper.
- 9. The renter shall always maintain their assigned RV lot in a clean and sanitary condition. Renters are to keep their assigned lot neat and orderly at all times. At the end of the fair, the renter shall surrender the RV lot in as good as condition as it was when the renter moved in.
- 10. Greene County Fair Board and Greene County Commissioners are *not* responsible to the owners any loss or damage to their property, including, but not limited to, explosion, fire, flood, tornado, windstorms, high water, hail, acts of God, or and other conditions or for damage or theft of trailers, vehicles, contents, equipment, accessories, or any other personal belongings owned by the renter.
- 11. Greene County Fair Board and Greene County Commissioners will *not* accept liability for personal or property damage while the renter is on site. This also includes family or guests of the renter.
- 12. No fireworks or bonfires allowed. No exceptions.
