

BUDGET RE-ADOPTION RESOLUTION  
Budget Year FY 25

A RESOLUTION TO RE-ADOPT THE FY 24 BUDGET AND RE-ALIGN FUNDS WITHIN VARIOUS ACCOUNTS OF THE Eastlake Park Special Dependent District

Upon the motion by Trustee [Name of Trustee], seconded by Trustee [Name of Trustee], the following Resolution was adopted by a vote of \_\_5\_\_, with \_\_5\_\_ Trustees voting \_YES\_ and \_ 1\_\_ Trustees absent.

**WHEREAS**, the Eastlake Park Special Dependent District has adopted a budget for FY 25 which includes appropriations for 389.90, Beginning Fund Balance; and 46.00 Repair and Maintenance, Other Contractual Services; and,

**WHEREAS**, Eastlake Park Special Dependent District desires to re-adopt its FY 25 budget and re-align funds in revenues and expenditures to reflect the correct beginning balance and expenditures; and

**WHEREAS**, Eastlake Park Special Dependent District now desires to increase its FY 25 budget by \$12,430 from \$34,219 to \$46,649; and

**WHEREAS**, Eastlake Park Special Dependent District advertised a public hearing for the purpose of re-adopting the budget and re-aligning accounts in a newspaper of general circulation in compliance with Chapter 129 of the Florida Statutes; and

**WHEREAS**, Eastlake Park Special Dependent District conducted a duly advertised public hearing on Sept 17<sup>th</sup>, 2024 to consider the proposed re-adopted budget, presented the proposed re-adopted budget and heard public comment regarding the proposed amendments.

**NOW, THEREFORE**, be it resolved by the Trustees of the Eastlake Park Special Dependent District on this 17 day of Sept, 2024:.

**SECTION 1.** Re-adopt FY 24 budget by appropriating funds and re-aligning the amounts appropriated in the following line items:
