

**RESOLUTION FIXING SPECIAL ASSESSMENT FOR THE YEAR 2025**

Upon the motion by Trustee Elliott Liberatore, seconded by Trustee Joelene Zeman, the following Resolution was adopted by six (6) votes to zero(0) vote.

WHEREAS, EAST LAKE PARK SPECIAL DEPENDENT DISTRICT is a special dependent district duly established and operating pursuant to Ordinance # 98-53; and,

WHEREAS, Ordinance # 98-53 provided that the Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT has the right, power and authority to levy a special assessment against RESIDENTIAL PROPERTY in the district for the purpose of maintaining and improving public right of way and common property and,

WHEREAS, the Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT has determined that the assessment for the year 2025 shall be in the amount of \$ 100; and,

WHEREAS, the Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT has had a duly advertised public hearing on the first day of June, 2025; and,

WHEREAS, the Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT has presented the proposed assessment and proposed budget to the residents of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT at the public hearing; and,

WHEREAS, the Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT has heard discussion and comments from the residents.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF EAST LAKE PARK SPECIAL DEPENDENT DISTRICT, THIS 17th DAY OF June 2025;

1. That the above recitation of findings of fact is hereby incorporated into this Resolution;
2. The Board of Trustees of EAST LAKE PARK EAST LAKE PARK SPECIAL DEPENDENT DISTRICT approves the proposed budget for FY 26.
3. The Board of Trustees of EAST LAKE PARK SPECIAL DEPENDENT DISTRICT approves the proposed assessment of \$ 100.00 for 2025.
