**Cancellation Policy for Drinks at the Barre and Mini-Barre Sessions:**

Clients must notify **Barre Besties, LLC** at least 24 hours prior to the start of their class time to ensure there is no financial penalty. Any cancellation within 24 hours of the start of class or no-shows to class will result in a loss of a class from your prepaid package.
