Robert- Wasn't here the last 2 months and wanted to know if anyone took it upon themselves to pay the last months rent.

Lois- I have the key. The rent has been mailed. We are up to date on the rent. Robert- Good.

Nick- New group with regular attendance at Cornerstone baptist Church, in Inverness, meets Tuesdays and Thursdays at 5:30. GSr is Dottie.

Lois- Asked Karen who has been ordering the meeting lists to hold off until today because I wanted to make sure that we included that meeting in our next meeting list. Now I personally have read through the policy. It says "An NA group may become a member of area service by holding regular meetings for 90 days and attending 3 consecutive area service meetings and requesting area service to vote on the group's admission. Time will be allowed for this request and voted on at the end of new business." That's for voting privileges. It doesn't say anything about meeting lists. I believe, in my heart, that area service is here to serve the groups. This is a new and upcoming group that we want to welcome into our area that we want to make sure they get support. I don't see any harm in putting it into our next. I think it's the right thing to do. Anyone who disagrees can raise your hand and speak your mind. I did take it on my own to have Karen hold off on the meeting lists so that we can include it.

Second thing I wanted to say is that I fell short this past month and ask for forgiveness. I mailed the check for the check and forgot to make the deposit. I realized it when I passed the Brannen Bank. I made the deposit just not within the timeline that policy states, but the money has been deposited.

Robert- I just wanted to clarify the new meeting will be registered with world services, but it isn't yet, so the meeting should not be on our meeting list if it is not registered with world services. That's part of the process.

Barabara- first of all, this is nature coast, and I don't see a problem with them going on a meeting list because it's a new meeting. We need to support them.

Rich- I actually wrote a motion to put that meeting on the web, on our blog area. Not actually on our meeting list area. I think that will suffice until. The website has doubled in views over the last month. The website is being frequently visited, so.

Dennis- Why don't we just put it to a vote?

Chuck- What would the (new) group like to see?

Nick- I come from a bigger area where you have to sit before being added to a meeting list, so I am aware of that. I am ok with it either way. We have taken it upon ourselves to announce it at other meetings. We have made fliers. So the message is getting out there. Our attendance is averaging 15 people per meeting. Our primary purpose is to let the addict know the meeting is there. I would like to see, if possible, that the GSR's take a vote back to their Homegroups. I am cool with that. If you guys are ok with putting it on the website, great. If not, no problem. Chuck- Sounds like what he is saying is let's just follow policy and all that goes to their homegroups to mention the new meeting and move on anyway.

Shannon- It's been announced. All homegroups are announcing it at their meeting. We have fliers. We had people show up the first night that have never been to a NA meeting in our area. So, the word is out there. Like it was said, We should follow policy and sit in two more "Area's" and just go from the. The word is out there.

Lois- Should we take a vote on it? It's policy to have voting privileges. Not to be on our meeting lists.

Barabara- The meeting itself has said they want to follow policy, so why are we going to make it into a motion?

Lois- Well, we are going to be printing meeting lists this week. So, I want to know if we are going to be putting it onto there, or not.

Barabara- Um, that would be a negative.

Lois- So, everybody is saying no?

Robert- I just want to make a point that when Welcome Home was founded over 5 years ago, that we had to wait 3 months before we were put on a meeting list and we had to register with World Services first. It only take 10 minutes. It's easy, so that's not a problem.

Shannon- So, there's been a lot of confusion with H & I policy and the clean time required to go into facilities. H & I policy says something different than Area policy says. I have had a lot of people bickering and arguing over this. I feel like we should address a policy "Ad Hoc" committee to get this all figured out because policy is policy. I have people arguing with me but what do I go by because H & I policy says something different than Area policy. So, I can't bring it to the sub-committee and tell them that you have to have this amount of clean time when this says this and this says this.

Robert- I will follow up with this. H & I policy was accepted at this Area service committee, so the policy should stay in effect until a new policy is written. There should be no question about that. What policy she has should be accepted and there should be no argument about that. Chuck- *Inaudible*

Ernest- If you have two policies and they don't match up, which do you follow?

Hailey- So, from my understanding is that the H & I policy was given by another member and we may have adopted another area's policy.

Renee- An "Ad Hoc" committee needs to be assigned to put together a policy that doesn't contradict itself. We experienced that at last area where it says one thing on one line and another thing on another line which is a rebuttal. So I would like to see that happen and have Shannon go to her committee and create a guideline for them. Our policy has come from a big area, Forest Area.

Lois- So, H & I committee should be able to do that within themselves, right? Renee- Right.

Robert- I had roadblocks thrown in front of me everywhere I moved. I had to have a policy that was approved by area. And I don't think it's fair to someone that takes over a sub-committee that other people have to throw a bunch of "stuff" at them. But, that's the way it works around here. This is going to be my last area meeting. I just want to say, I love everybody in this room, but I don't love a lot of what goes on here. Ya know, if you state that it has to be a certain way, and somebody complies with what it has to be, that should be sufficient, right? So, the policy that was accepted by this committee should be in effect until such time that the new chairperson

writes a new policy and submits it to this committee. That's the way it should work, right? Or am I wrong? So let's not make it harder for her (Shannon) to be H & I chair.

Shannon- I need clarification on what to follow.

Barbara- First of all, sub-committees are sub-committees. They are their own entity. We don't run sub-committees. You have a policy. That's what H & I does. Their policy. That's as far as I know. I have never been in an area where they run the workings within the sub-committee. Lois- Thank you.

Robert- The problem we have at area, is that we have certain people who want to determine for everybody what has to be done. The same thing happens every time there's a new chairperson. Face it or not. That's the truth.

Lois- We need to make a motion to continue on Open Forum.

Barabara- I motion.

Chuck- For unity, I think that Shannon has an excellent idea that our policy is a little bit outdated from maybe, pre-Covid, than it is now. It needs to be updated as soon as possible. I would be willing to be a part of the Ad-Hoc committee to go over our policy to see what needs to be looked at and worked on.

Renee- If you look in our guide to area service it says "it's a sub". It's under area. That means that area does not run it, but area does oversee it to make sure it's run properly. But they create their own guidelines.

Lois- Thank you.

Jim- I want apologize for not being here at least area. I had food poisoning. Please forgive me. My intention was to be here.

Barabara- I want to know how the groups feel with someone taking on a sub-committee with being a GSR.

Lois- It's against policy.

Renee- That was what came up at last area. What it says in policy is that "A GSR cannot serve on the executive committee". It does not say anything about sub-committees.

Barabara- Is policy an executive position.


