<u>OPEN FLOOR COMMENTS</u> (includes all open floor comments throughout the meeting):

Dottie brought up her concern for the ZOOM website and the availability of the volunteers on there to open meetings for the chairs.

Roland mentions speaking with Bob earlier and being willing to come off as an admin since he is not as available as he was in the beginning and Bob come on.

Renee says the issue with just adding anyone as admin is because they would have access to the Area Card info. Also, the meeting chair should be responsible and CALL a good bit ahead of time and not a few minutes before each meeting. This would have the admin better prepared to let the chair in. Also, the chair should not be requesting to get in through Facebook. If they need to get in they should be calling the admin.

Renee – we should write something up and give it to the chair so they are aware of their responsibility.

Rich states it used to be assigned to a single admin for permanent days and it should go back to that because it worked.

Tommy - says he is a proud member of NA and thank you to his God for allowing him to be her. Please do not take this as a personal attack because it's not. It's been a while since I've been to area and I've asked a few people questions and they have told me that I should attend area so here I am. I am curious about the campout fund. It was mentioned last time I was at area is was around \$800 and other money has been donated since then. I would like to know exactly how much money is in the fund.

Barbara - says that will be addressed in Treasure Report

Roland - states we can do it now. First off, it's all about proper record keeping. Everything needs to be accounted for and not just accounted for but also dated with reasons and two or three copies made. We just need to do better, that's all I am saying. So what we have here from what Barbara gave us, which she needs to start dating her stuff also, is 1068.22 campout funds available.

Barbara - says that is different because when the \$133 was handed in it was not specified for campout. What happened was that the envelope was taken back and that was not included in the campout. Activities campout fund is now 1201.37, that's everything to the date.

Tommy - asked one more question, I heard we were doing an audit? Who is doing the audit?

Roland - says each 6 months the treasure is to do and audit and show it to the area. She is behind and we have discussed this, and she is supposed to be presenting that today. Tommy - the only problem he has is, how is a creditor supposed to be allowed to audit themselves? It should be the chairperson chooses two people to do it or an outside area. You cannot get a proper audit that way. Tommy, there is a few people that aren't happy with what is happening in Area, even talking about making a second area. I don't want to see that happen. I was us all to come together. Thank you for having me.

Barbara - says according to policy the treasure is to do an audit twicer a year. I was not done during the pandemic, but it is done now, and it will be given in the report today.

Roland - addresses policy, is an outside entity addressed to do this audit twice a year? Renee - (policy chair), an outside entity is not addressed in the policy at all because we are fully self-supporting and no need, unless there is a reason for an audit, like suspicion. Now, you may have someone in the area do it but in the policy, it states that LDO and Treasure do their own audit. With that being said, we are our own eyes and ears. We need our reports

in columns and better than they have been. From my understanding we have had three or four reports that have gone out that haven't even been approved. There is a question there, I love my people, but this cannot be ignored, and it needs to be addressed. According to Treasure she is going to address that today. And according to activities the new reported amount available sounds right but we need to see where it came from, who it came from, just like the reports used to look, where we can better follow it. It can't be something like it's been, just written up or thrown together.

Roland – I have to agree with what was said. There is some suspicion. Like for instance Barbara what I have here is January 2020, and the balance. I have the months here and a number to show, ect but not the details or dates of deposits or other itemizations.

Jennie – I just want to address what Tommy said, about the unity of the area. Obviously, we want us all to come together and we just had an event called Unity Day this past week and nobody from your group showed up except Kelly. I just want to say I think it goes both ways. If we're all going to come together, we are all going to have to do it, that's how it

works. Hopefully, we'll have more stuff like that throughout the months but if people don't come then it won't work because it goes both ways. We all must give 100% Roland - ultimately that is why we're all here.

Robert – I feel like every time we come to one of these meetings someone is here to attack Barbara. The statement was made that things are happening at area that are causing people to want to leave and make a new area and I would like to know what those things are because this area has ran so much smoother then is had the previous year.

Roland – When is comes to 7th tradition, that's important stuff. How many times have I looked over at Barbara and said you need to tighten up, do your job? That's not a personal attack, that's me being an adult and asking her to do what she is supposed to. Sometimes things come from different angles and different people have different ways of presenting things.

Kelly - I apologize if it has come across that way. Its not about anyone personally its just about the importance of the treasury.

Jason – I heard that other areas and region actual closed during this pandemic which is very scary to think. It is important that we stick together and help each group carry on its purpose.

SECRETARY'S REPORT

A long discussion was had about what moneys should be in activities funds. Will be discussed during treasure report. Discussion was also had about Activities needing to put in for an activities fund for the upcoming year.

POLICY: Renee gave verbal/written report. ZOOM Meeting every Wednesday from 8pm to 9pm. A half hour is Policy and a half hour is Activities.
