Renee: In policy it says that the Treasurer and the LDO are to conduct business 30 minutes prior and 30 minutes after the ASC meeting as to cut down on the distractions.

Lois: Y.A.N.A. is considering splitting groups up does anyone know if both groups would be an established group or what we have to do.

Renee: You are grandfathered in.

Christina: If you are changing the name then you do have to register with world.

Brandon: The Just For Today Group has voted to join with the Nature Coast Unity Group, so now we are just the Nature Coast Unity Group. We are the same group with two different meetings at two different places. Also I was reading in policy and we are supposed to meet on the 2<sup>nd</sup> Saturday of the month and that did not happen. We have a chain oof command if the facilitator cannot make it. Can someone explain why we are meeting on the 3<sup>rd</sup> Saturday now?

Christina: There was an unfortunate incidence where it wasn't just the Facilitator that couldn't make it. It was an emergency situation and it was talked about through the chain of command. It was decided that the meeting would be moved out one week and everyone was notified. It was only for this month.

Brandon: Thank you

Rolland: Did you get the text message?

Brandon: Yes, I just didn't know why it was changed.

Robert: I bought my own because I didn't want to have to wait and just read the readings out of the book.

Angel: Back to the Just for Today merger real quick..is the name going to be Just For Today Nature Coast Unity, or Just For Today?

Brandon: It will be Nature Coast Unity

Dominique: Obviously if a group is starting out they need a starter kit, so I was wondering, can they ask for the starter kit first or do they have to be here for three months?

Donnie: Everywhere I have ever been there has always been the three month thing; I don't think this is something unique to the area as it is in other areas as well.

Rich: Maybe we can decide to allow a person that is starting a meeting to purchase a starter kit and then after 90 days they can petition the body to be reimbursed?

Christina: This is just my suggestion, I agree that new groups should be able to get a kit right away to start their groups, what about if we give the new group a kit under the condition that the kit comes back to the area should the group close down before the 3 months? Then they can start the meeting which is carrying the message, our primary purpose, and area can have a little assurance that they get the kit back should the meeting not make it.

Robert: I agree with Christina, it is important that a group gets what it needs to function and grow.

Karen: We have had some new groups open and I have looked at the pack and it just doesn't seem sufficient. (Reads the list of inclusions) Maybe we can make up our own list of inclusions for the starter kit for our area.

Barbara: I will print my list out for you when I get home.

Renee: Reading the readings out of the book is not that bad, we have to learn to work with what we have, and we cannot continue to just give it away. There has to be some type of ground line there that says this is what we do. It is not always about a bleeding heart, we work for what we get. If that means that we have to establish ourselves in the area for three meetings, then so be it.
