

ELECTION NOTICE

ANNUAL BUDGET ELECTION SATURDAY JULY 18, 2020

Members of the Kiowa Tribe are hereby given notice that in accordance with the Constitution of the Kiowa Tribe, Article VII-Executive Branch, Section 4-Powers (a) Annual Budget, Article VI-Legislative Branch, Section 6-Powers, (b) Annual Budget (vi) If the Legislature fails to approve an annual budget within sixty days of presentment of a proposed annual budget by the Chairman to the Legislature by February 1st, then the annual budget presented by the Chairman shall be deemed approved for the purpose of placing the budget before the voters for approval or disapproval. If a new annual budget is not approved by the beginning of the fiscal year, then the most recently approved budget shall remain in effect until a new budget is approved. An Election will be held on Saturday July 18, 2020 to approve or disapprove the Annual Budget proposed by Chairman Komalty.

The proposed Annual Budget was presented by the Chairman to the Legislature on January 30, 2020. Due to COVID-19 related shutdowns, the Legislature was given until May 31, 2020 to approve the proposed budget. The Legislature did not approve the Annual Budget in the timeframe allowed, therefore according to constitutional mandate, the Chairman's proposed Annual Budget will be placed before the voters for approval or disapproval.

The Chairman's Annual Budget was completed on January 30, 2020 prior to receiving Federal funds related to COVID-19 Relief.

THE VOTING PROCESS: Voting for the Annual Budget Election will be conducted by mail-in ballot as well as on-site voting at 7 polling places:

The Polls will be open from 9:00 am until 4:00 pm on Saturday July 18, 2020.

Mail-In Ballots will be mailed to all eligible voters with a valid address on file with the Kiowa Enrollment Office. Ballots will be mailed on or before June 22, 2020.

Tribal members wishing to vote by mail in the Budget Modification Election, will need to have a current address on file with the Kiowa Enrollment Office prior to July 10, 2020. Call 580-654-6325 for assistance with address updates.

ELIGIBLE VOTERS: Members of the Kiowa Tribe age eighteen or older on July 18, 2020 shall be eligible to vote in this Election.

Election Results: The counting of ballots will begin at 4 pm on the day of the Election. Each Polling Place will conduct their own ballot count then forward their results to Election Officials at the Tribal Complex for final tabulation. All mailin ballots will be processed and counted at the Tribal Complex. If any tribal member wishes to observe the vote counting process, please contact the KEC at 580-654-6325 prior to election day. Election results will be posted at the Tribal Complex, as well as online at **kiowatribe.org** and on the Kiowa Election Commission Facebook page on Election Day.
