**SUBJECT: KIOWA INDIAN COUNCIL CONSTITUTIONAL AMENDMENT
ARTICLE VI, SECTION 4 (a), DISTRICT 1-6, SECTION 5(a),
DISTRICT 7, QUALIFICATIONS LEGISLATIVE BRANCH**

WHEREAS: the Kiowa Tribe is a sovereign nation since time immemorial and is federally recognized as a Tribal Government by the United States; and,

WHEREAS: The Kiowa Tribe is organized under a Constitution approved by tribal membership on April 17, 2017, and approved by the Secretary of the Interior, U.S. Bureau of Indian Affairs on May 5, 2017; and,

WHEREAS: Article V, section 3(b) of the Constitution grants the Kiowa Indian Council the power to set policy for the Tribe, and shall have all other powers and duties specifically provided by the Constitution

WHEREAS: We, the members of the Kiowa Indian Council of the Kiowa Tribe, under the authority granted to the Kiowa Indian Council by the Constitution of the Kiowa Tribe, in order to preserve for ourselves and our children the inherent sovereign rights of our Indian nations, governed under the laws of the Kiowa Constitution, to preserve Kiowa cultural values, and promote the health, safety and welfare of the Kiowa people, do hereby establish and submit the following resolution; and

WHEREAS: **The Legislative Branch of the Kiowa Tribal government, shall have five to 8 years work experience or Associates/Bachelor/Masters/Doctorate degree in areas of Accounting/Finance, Human Resources, Business Administration/Management, Grants Management, Medical, Education, Tribal Government, Museum, Social Services, Child Welfare, Gaming Industry and any other departments the Kiowa Tribe is involved. To insure budgets, grants, programs are monitored for internal controls, audits completed in a timely manner, working with Directors, Supervisors to provide advanced understanding complying with and**

meeting deadlines.

WHEREAS: Background checks be conducted, failure to comply candidate would not be considered.

WHEREAS: Must be a registered voter.

NOW THEREFORE BE IT RESOLVED; that the Kiowa Indian Council hereby; The Legislative Branch of the Kiowa Tribe shall have five to eight years work experience or advance degree in areas of Accounting/Finance, Human Resources, Business Administration/Management, Grants Management, Medical, Education, Tribal Government, Museum, Social Services, Child Welfare, Gaming Industry and any other departments the Kiowa Tribe is involved. To assure budgets, grants, programs, are monitored for internal controls, audits completed in timely manner, working with Directors, Supervisors to provide advanced understanding complying, and meeting deadlines.

BE IT FURTHER RESOLVED, that this resolution shall be the amendment of the Kiowa Tribe until it is withdrawn or modified by subsequent future amended resolution.
