Objection to Mr. Cruz appearing on the ballot for President of the USA.

Dear Mr. Gardener and Attorney General Foster,

My name is Chomi Prag and I'm an official candidate for President of the United States of America 2016. My "Declaration of Candidacy" was filed with the NH Secretary of State November 4, 2015.

My campaign committee, Prag for President, and I, Chomi Prag, hereby challenge Mr. Ted Cruz's eligibility to be on the ballot for Presidency since he is not a natural born citizen as the US Constitution (Article 2, Section 1) as well as New Hampshire laws (655:17-b) require.

*Article II, Section 1 of the United States Constitution*

**"No person except a natural born citizen, or a citizen of the United States, at the time of the adoption of this Constitution, shall be eligible to the office of President;** neither shall any person be eligible to that office who shall not have attained to the age of thirty five years, and been fourteen Years a resident within the United States".

Mr. Cruz signed, under oath, on his Declaration of Intent, Chapter 655:17-b of the following...

**655:17-b Declaration of Intent; Presidential Candidates Who File Nomination Papers. –**

I. Declarations of intent for each candidate for president who seeks nomination by nomination papers shall be in the form provided in paragraph II. Declarations of intent required by this section shall be filed with the secretary of state, signed by the candidate, and notarized by a notary public.

II. I, \_\_\_\_\_, swear under penalties of perjury that I am qualified to be a candidate for president of the United States pursuant to article II, section 1, clause 4 of the United States Constitution, which states, "No person except a natural born citizen, or a citizen of the United States, at the time of the adoption of this Constitution, shall be eligible to the office of President; neither shall any person be eligible to that office who shall not have attained to the age of thirty-five years, and been fourteen years a resident within the United States." I further declare that I am domiciled in the city (or town or unincorporated place) of \_\_\_\_\_, county of \_\_\_\_\_, state of \_\_\_\_\_, and am a qualified voter therein; that I intend to be a candidate for the office of president to be chosen at the general election to be held on the \_\_\_\_\_ day of \_\_\_\_\_; and I intend to file nomination papers by the deadline established under RSA 655:43. I further declare that, if qualified as a candidate for said office, I shall not withdraw; and that, if elected, I shall be qualified for and shall assume the duties of said office.

Mr. Cruz publicly admits he was born in Canada and his father was not an American citizen at the time of his birth.
