WARNING: GEOENGINEERING IS CATASTROPHIC FOR ALL LIFE ON THE PLANET AND IS A MAJOR CAUSE OF CLIMATE CHANGE!

SOLAR RADIATION MANAGEMENT also known AS STRATOSPHERIC AEROSOL SPRAYING or CHEMTRAILS is a worldwide operation, that is not just in the planning phase, as many official documents and press releases suggest, but it's been actively and intensively deployed since the '90s. The pulverized chemical trails form artificial clouds that linger in the sky for hours and spread creating a foggy whitish blanket, a so-called "sky shield". According to NASA, the world had already seen a 20% loss of sunlight, a fact that in itself, directly causes incredible damage to the entire web of life and food resources through the reduced photosynthesis, not to mention the dimished natural capacity of vegetation to capture carbon (CO2). But the increasing pollution of atmosphere is even more worrying.



According to the data offered by the most documented, independent geoengineering portals (geoengineeringwatch.org, globalskywatch.com and CarnicomInstitute.org) dangerous amounts of aluminum, barium, strontium, cadmium, sulphates, but also graphene, polymers and other synthetic toxic materials in nano and micro particle form are systematically being dispersed at high altitude from unidentifiable planes (to check this, observe the air traffic in your area with flightradar24.com).

All these elements are highly toxic for all forms of life; they gradually accumulate in air, water and soil and are now at very abnormal levels, as testified by independent lab tests. Forests, crops and all plant life are visibly declining, while dangerous molds, mildew, fungi and bacteria are proliferating due to the excessive die-off and decay of living organisms. Biodiversity on land and in waters is severely affected, and now it is admitted that we are experiencing an accelerated extinction of species. 75% of the insect population of the world has disappeared, pollinators and also much of the wildlife species on our planet have been affected by massive die-offs. The soil life is being destroyed and with this, also agriculture is severely undermined (consider that GMO crops that are damaging for health, have been engineered to resist draught and high levels of Aluminum accumulation)

According to highly respected medics such as neurosurgeon **Prof. Russell Blaylock** and **Dr. Richard Klinghardt**, the effects of these aerosols on human health are undeniable, contributing to or directly causing:

WEATHER CONTROL PATENTS and also, known and observable effects of the use of ionospheric heaters, lasers, radiofrequency/ meteorological radars and acoustic waves in weather manipulation, have been documented by independent researchers and have been practiced by the developed nations for many decades (climateviewer.com) Extreme weather events can be mitigated, but also redirected and enhanced by such technologies. Consider the obvious thing that the AEROSOL SPRAYING (CHEMTRAILS) in an area visibly destroys the natural clouds and, through the resulting persistent chemical sky blanket, always prevents rain to occur. If such installations are exposed to a fire, the special chemicals in the infrastructure can release very **toxic gases**, that may lead to the evacuation of an entire community, tells us Nobel Laureate, **Prof. Devra Davies**. Even more dangerous **are ELECTRIC VEHICLES (EV) and BATTERY STORAGE SYSTEMS**, based on **LITHIUM ION BATTERIES** - which exposed to heat or shock undergo an extremely dangerous and rapid **runaway thermal reaction**. Fires resulting from this are almost impossible to quench and release lethal gases.

The **spraying of herbicides such as ROUNDUP** (intensively practiced in agriculture, but also in communities, by Councils) severely affects all life and, gradually destroys the vitality of the trees and the bushes contributing as a major aggravating factor in the case of a local forest fire. Even more destructive and dangerous from the perspective of a **fire hazard** are the practices of completely **DESTROYING THE BUSHES AND TREES** through abusive cutting and allowing **poisoned**, **fallen and dry trees**, **cut bushes and branches and piles of grass** to accumulate in the landscape.

The presence of **LANDFILL** areas very near to communities is also a known fire hazard, due to the unavoidable **methane emissions** resulting from the decomposition of organic material and obviously, also the presence of known **deposits of coal and gas** in the area that have been or are being exploited. Almost any industrial activity is requiring high energy and various chemical substances, thus **local factories** can be very dangerous for a community in case of a serious fire

If you live in an area where any of these factors are present and where, eventually, there have been already some fires (see, for example, the town of **Cumbernauld**, which is affected by all mentioned factors), it would be advisable to ask (**FOI**) your **Council and Fire Department** about the measures in place in case of wildfires/ storms and also, about those meant for prevention. The community should demand proper actions and **council members should be made personally liable** (**Notices of liability**) for all their decisions that may lead to the potential increased destructive capacity of a wildfire in your area.

It appears that very many people in communities directly affected by devastating 'wildfires' (but not only) believe that they have been victims of attacks with DIRECTED ENERGY WEAPONS, and due to extremely strange facts such as having houses randomly turned to ashes or cars melted (which requires much higher temperatures than any natural forest fire), while nearby trees manage to resist and even to keep their foliage. In North Carolina and Tennessee, many months after the catastrophic hurricanes, people were still living in tents after being, in some happy cases, compensated with 700\$ by the government. Though promised, rebuilding did not happen in the affected areas, people being even prevented return and rebuild with their own means. Very many people and families have lost their lives in these catastrophes, while the authorities and the press presented ridiculous numbers, insisting on the material loss and blaming either the climate or the political scapegoats. No official follow up, no mourning for the victims (not even for the acknowledged 1000 disappeared children of Lahaina), no care for the survivors; instead, the nation is stunned by the political show and made to worry about immigration, wars, new pandemics, taxes, loss of jobs and inflation, so the truly, most devastating effect of these engineered cataclysms on the nation would, as much as possible, be forgotten.
