

WHEN WILL POLICE SCOTLAND STOP THE KILLING AND INJURY?

There is a live Grand Jury court investigation in The Court of Public Opinion grand-jury.net: and International Criminal Court case TP-CR-473/21 was issued in The Hague on 6 Dec 2021.

Incident 20220120-1333 was reported at Govan Police Station on 20 Jan 2022. This incident number covers the same crime being committed in all vaccination centres, and it must immediately be raised to a live criminal investigation with all experimental vaccination vials retained by the police for analysis and evidence.

On 19 March 2020, the UK Govt downgraded Covid-19 from being classified as a 'high-consequence infectious disease' (HCID). It therefore should have been treated more like a seasonal flu or common cold. The Covid-19 "virus" has yet to be isolated.
