

# Non-Refundable Deposit Agreement

This deposit agreement is between the buyer Meaghan Audet and breeder Meaghan Audet with Audet's Mini Dachshunds

## DEPOSIT TERMS

Looking for a Pup - \*\*\*\*\*

Buyer agrees to place a \$250 non-refundable deposit (down deposit) on a Dachshund puppy from Breeder.

1. Non-Refundable Deposit. Buyer acknowledges that the Deposit is non-refundable in all circumstances, including but not limited to if Buyer decides s/he does not want or is no longer looking for a puppy. Upon receipt of the Deposit, Breeder agrees to hold their spot on Breeders waiting list until a puppy is born for the Buyer. All payments under this Agreement shall be made in US dollars and paid to Breeder via Cash, USPS Money Order, or Good Dog.

2. Buyer Acknowledgements. Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the Deposit gives Buyer a pick place, but does not guarantee a puppy or that Buyers preferences will be available when it is Buyers turn to pick; (c) pick places are given on a first-come first served basis and Buyers place in line is not negotiable; and (d) Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes an adult; and (e) deposit is good for 2 years on waiting list from the date received.

3. Buyers Right to Transfer Notwithstanding the foregoing, if a puppy that meets Buyers identified preferences is not available [when it becomes Buyers turn to pick a puppy from the selected litter], Buyer will transferred to the next litter.

4. Final Purchase Price. Breeder and Buyer agree that (a) the Deposit shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is shipped and/or ownership is transferred from Breeder to Buyer. [The total purchase price for the puppy ranges from \$2,500 to \$3,800. The foregoing purchase price does not include any delivery, shipping, website charges.]

5. Governing Law. This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Vermont without regard to the conflicts of laws provisions thereof.
