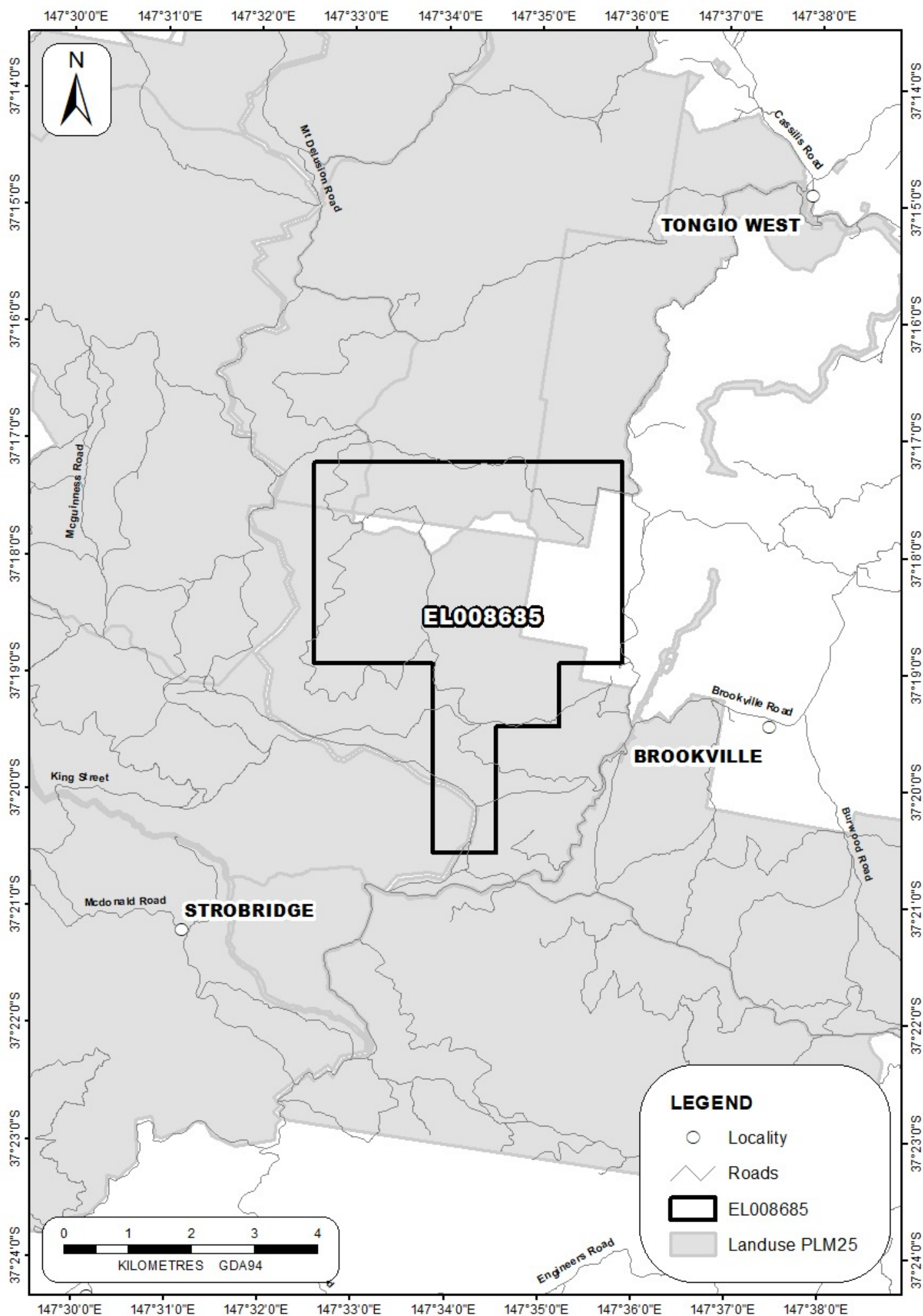

### **Year three**

Continue Sampling programs and update maps and database

Compare data to historical information

Complete basic metallurgical testing (bottle rolls / leachwell)

### **Year four**

Begin refurbishment of priority one adits for detailed underground sampling and/or drilling

Complete follow up metallurgical testing (gravity, flotation and intensive leaching of cons)

### **Year five**

Undertake bulk sampling programs underground and make application to begin mining activity work plan with conversation of license to enable this activity to take place
