Jeanne M Osborne, age 97, of Melbourne, FL.

Jeanne was born on August 22, 1926 in New York City. She grew up in the city and was known to be in the audience of more than one of Frank Sinatra's early shows. She trained as a Radiologic Technician at New York's Manhattanville College.

After moving to Hawaii on her own to organize the Queen's Hospital's nascent Radiology department, she met and married Charles Osborne, who was serving in the Navy at Pearl Harbor. Frequent moves to various naval assignments followed. The family grew to include John and Tina.

Jeanne volunteered at several organizations while raising the children, from one of the first Job Corps programs for girls to democratic political campaigns to teaching middle school religion classes, all while managing the household through many locations.

As the children grew older, Jeanne became more involved in Democratic Party activities including service on the Connecticut state central committee. Eventually, she began a career with the American Cancer Society.

She shared a love of travel, visiting Europe, North Africa, South America, Antarctica, and many other countries and parts of the world.

Jeanne and Charles decided to retire to Barefoot Bay in 1986. Here, too, her interest in community service led her to Serve as chair of the board of trustees. She was also active in establishing Serene Harbor, the South Maitland Community Center, and supporting the VNA. She also enjoyed golf, bridge, and the Irish Club in the Bay.

Charles N Osborne pre-deceased Jeanne's passing in 1996. Jeanne continued to reside and participate in activities in Barefoot Bay until moving to The Fountains of Melbourne in 2023.

On March 10th, Jeanne passed on peacefully at Holme Regional Medical Center's Heart Center. Jeanne is survived by daughter Tina of Connecticut and son John of California, and grandsons Charles and Timothy.

Out of Warranty? Doesn't hurt to ask.

My one year old dishwasher decided to stop washing dishes last month. You would turn it on and could hear it filling up and then, draining out. The sprayers would not spin. I tried doing the factory reset as described online, but nothing. I couldn't fix my dishwasher. Considering the dishwasher was practically brand new, I was a little annoyed. The previous dishwasher was 25 years old when it finally washed its last load, and other than replacing a rusty dish rack, it never gave us any problems. Naturally, my barely one-year-old dishwasher had only a 12-month warranty.

Before contacting the manufacturer, I decided I would pay to have the problem diagnosed. If it was something easy to fix, I would be done, and the dishes would be spotless once again. I gave RMJP Appliance a call. Kenichi is a new advertiser in The Tattler. We set up an appointment, and after a quick inspection, Kenichi explained that the internal pump had gone out. The part would need to be ordered, another house call to replace the part, and the total bill would come to \$400. I paid Kenichi for the house call and diagnosis, agreeing it would be a fair price but holding back on having him actually fix the problem since we both agreed that calling the manufacturer seemed... warranted. I could always have Kenichi put the part in if I couldn't get the manufacturer to cover the repair.

I have always waited before making large purchases. I consume a large portion of information identifying the best products in a category, understanding sales cycles, and swooping in for a buy when a discount is available. My wife still talks about our first major purchase, a washer and dryer combo. It took me several months, but we purchased a Maytag Neptune front loader and dryer. A \$1700 purchase in 2000. Both of those appliances survived the births of my children and loads of laundry through their teenage years before we finally replaced them. There's a reason the Maytag repairman commercials were so popular, they were true. We never had to call for service for either appliance.

The "new" dishwasher was also discounted from its \$750 price, and as a bonus, we purchased it directly from the manufacturer. I was disappointed I had to call Whirlpool about their dishwasher. Whirlpool is the world's largest appliance manufacturer and owns most of the American-built appliance manufacturers, including Maytag, which they had purchased in 2006. I wanted to know what my options were, as well as ask a few pertinent questions. I had purchased the dishwasher directly from Whirlpool, so no middleman, like Home Depot. They were the actual manufacturer and should be able to answer my questions.

My call was answered relatively quickly, and having reached a live customer service person, I explained my situation quickly. Who should I talk to? Initially, I was sent to the department for those customers who don't have a warranty. Reaching the new rep, I explained my situation again in a little more detail, adding my story about the Maytag washer and dryer I purchased 20 years ago. I was told that the repair could be fixed if I were to purchase an extended warranty. That seemed... convenient.

With regret, I am informing you of the passing of Jeanne Osborne, longtime resident, former Trustee, and Past Chair.

February 27th meeting:

Valley Bank was approved to continue as the depository for BBRD.

Flash Weather AI was approved for lightning predictions and alerting for the safety of Barefoot Bay.

All Florida Striping was chosen for the asphalt repair and seal coating for buildings "A" and "D/E" parking lots.

BBRD Volunteer Policy – Resolution 2024-03 was passed. More information on how to become a volunteer and which positions will be available is forthcoming.

If a violation is found and does not come into compliance within the timeframe allotted, it is presented to the Board of Trustees for referral to legal. The board's job, as I see it, is to evaluate the findings and decide whether the violation warrants spending the funds for legal fees. During my time on the board, the Violation Committee has done its job well, and the referrals to legal have been made.

Remember: All vehicles must obey all traffic signs. That includes anything with wheels! Pedestrians, be aware of your surroundings, don't just fixate on your phone or earbuds.

The Importance of Having an Advance Directive

In the best of circumstances, it is difficult to make healthcare decisions on behalf of another, and it is even more difficult when their healthcare wishes have not been discussed. Instituting an advance directive is a vital step in ensuring that you are in control of your healthcare needs. April 16, 2024, marks the annual National Healthcare Decisions Day, a day meant to bring to light the importance of planning for your healthcare. It serves as a reminder to us all of the importance of implementing an advance directive.

Q: I'm 70, and my doctor advised me to get an advance directive, but I don't really understand what it is, and I was too embarrassed to say so. Could you please explain it?

A: No need to be embarrassed; most people don't know what it is. An advance directive is a legal document that instructs your doctors what kind of care and treatment you would like to receive in the event that you are unable to make decisions for yourself. The advance directive will answer questions such as what kind of care you would want if you become unconscious and who is able to make your healthcare decisions for you in the state that you are unable to do it yourself. It is important to research the laws about advance directives in your own state, as they vary from state to state.

Q: Why do I need to plan for my healthcare?

A: It is important to plan for your healthcare because if you find yourself in a situation where you are unable to speak, then it is important that you are still represented in the decision-making process. You want to be able to make decisions even in your end-of-life care.

Q: My mother has expressed her wishes to my siblings and me verbally; does she still need an advance directive?

A: Yes, even if she's verbally expressed her wishes to you and your siblings, she should still execute an advance directive. By putting her wishes in a written document, it will further ensure that her wishes will be met. It will also relieve any pressure or confusion your family members might have during this difficult time.

Q: My husband talks about a living will. Is this the same as an advance directive?

A: A living will is a type of advance directive. It can express your healthcare wishes and dictate what kind of care you want. A durable power of attorney is another form

of an advance directive, which allows you to assign a healthcare agent.

Q: How do I go about getting an advance directive?

A: You can implement an advance directive in different ways. You can:

- Ask your physician if they are able to provide you with an advance directive form.
- Call a lawyer to have papers drawn up on your behalf.

- Go through your state's Department of State, Health Department, or Department of Elder Affairs.

- Write your directives yourself.
- Use Five Wishes, an advance directive available at fivewishes.org.

If you choose to write your directives yourself or use a computer program, be sure to check with a lawyer to ensure that you are abiding by your state's laws.

Q: What kind of guidelines can I put in my advance directive?

A: There are a number of requests you can make regarding your end-of-life care in your advance directive. You can:

- State whether or not you want to have a Do Not Resuscitate (DNR) order.

- Indicate who you want to have as your healthcare agent if you are unable to represent yourself.

- State If you would like to be placed on life support.

- State at what point you would like to be taken off life support.

- State the level of comfort you want to be in during treatment.

- State how you want to be treated and cared for.

- State what information you would like to share with your loved ones.

- State who should be present at your time of death.

Q: My wife wants to make an advance directive but always changes her mind. Is it possible to change your advance directive once it's made?

A: Your wife is not alone! And yes, you can change your advance directive as long as you have a sound mind and are able to think rationally for yourself. Any written changes you make should be signed to make it clear that you have changed your healthcare instructions. Destroy any previous advance directives you've instituted to avoid any confusion. Also, be sure to let your physician and family members know of the changes.

The repair and service call would be covered even for the existing issue with the water pump. Price for the extended warranty? \$34 for twelve months or approximately \$400 for the year. I pointed out that was practically the cost of getting the repair fixed. The rep mentioned I would come out ahead since I would receive an extra two years of warranty coverage for my \$400. I asked, since the warranty expired only a month ago, would Whirlpool consider covering the repair? She insisted that they could not help me in the out-of-warranty department. The way she worded that response suggested I ask who could help me. She politely suggested I should talk to the in-warranty department.

Upon being switched to the in-warranty department and my third Whirlpool representative, I further explained my situation, grudgingly going over the current problem with a dishwasher I had just bought the year before, mentioning my wife and how we always bought the best appliances and went over the story of my Maytag washer and dryer again, mentioned the 25-year dishwasher that this new dishwasher had replaced, mentioned I owned a newspaper, and asked if she could assist me in my quest to get this part covered. I then asked how long Whirlpool expected a \$750 dishwasher to last if purchased today.

After a short pause, she said that their Whirlpool brand appliances should last at least five years, if not longer. She appreciated my business and would happily schedule a call with one of their official appliance repair specialists. Whirlpool would cover the parts and service even though the appliance was out of warranty. It was the right thing to do.

Within a few days, Whirlpool's official repairman from Brandt came out and confirmed the problem was the pump. I had already relayed that diagnosis and was a little disappointed that they didn't have the part on the truck. It would need to be ordered, and I would have to wait another few days. On my next service call, a different representative from Brandt showed up with the part in hand but insisted that the pump was not likely the problem but that, in his experience, the circuit board would need to be replaced—another trip. Finally, after about ten days, my final Brandt service call and the third different representative from Brandt arrived with both parts. He was confused as to why he had two parts for the same problem but basically said we have the parts; I'll install both a new circuit board and the new pump. The problem was finally fixed. I feel that Whirlpool did not get the greatest value from their service company. I have no complaints with them; personally, they were all very nice, and I have no idea what their compensation from Whirlpool is, but three service trips, two parts, and three separate reps on a warranty repair sound expensive for someone.

In the end, this story is about taking care when buying appliances. Research your purchases (consumer reports, reviews, etc.) and buy when things are on sale, though it seems the "sale" price is the same, no matter which retailer you purchase from. Be sure to register your product purchase with the manufacturer online or by sending in the postage-paid postcard they include with your paperwork. I don't recommend extended warranties, but some do have value. Many appliances can be repaired, and companies like RMJP Appliances can tell you what your problem is, repair and extend the life of your better appliances, or recommend when you should purchase new ones instead.

Finally, even though your appliance may be out of warranty, it makes sense to call and ask what can be done. Had the purchase been over two years old, I may not have received the same discretion on the part of the Whirlpool customer service rep. It's true that the

calm, patient customer tends to get better results than someone angry and belligerent, and you don't need to own a newspaper to comment on FB and other social media platforms, whether good or bad, and companies understand that. You just need to ask, as an informed customer, for some consideration. Good companies will respect your request.

I appreciate Whirlpool covering the dishwasher even though it was out of warranty, RMJP Appliance for their prompt service call and diagnosis, (it was worth the service call to know what the problem was before talking to the manufacturer), and Brandt for their assistance in getting my dishwasher running, though three service calls seems excessive.

The State of One's Health

Those of you who have followed me know that I place great emphasis on physical fitness. If you care for your body, eat correctly, and exercise, your body will respond favorably. The best way to explain what I am saying is to share my own experience.

At age 86, which included nine years of football plus bouncing around on ships and submarines during my 38 years of Navy life, my knees gave out. After surgery on my left knee, the pain did not abate, and the knee would not support me. I have spent the past three years trying to walk again.

While I am not a therapist, I know what helps me and what does not. Often, the limiting factor is the way Medicare dictates the times and duration of weekly therapy. I started with therapy visits three days a week, then two, then one, and then it ended. I asked if I could continue at my own expense but was refused.

Medicare has a one-size-fits-all plan that includes a certain number of sessions per week for a set number of weeks based on patient progress as determined by an assessor. Compounding the problem is that every assessor visit counts as a patient care visit, thereby lessening the number of actual care visits.

It is frustrating to have effective care and then have it limited. The real problem is that the system does not work for everyone, and I happen to be one of the exceptions. Fortunately, my doctor understands the problem and is helping me get the care I need.

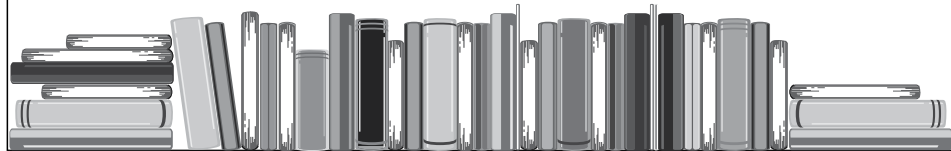

Date Night Reviews

Dune. Part Two

Dune, Frank Herbert's 1965 novel, is an opus on space travel and adventure. This 187,000-word tome, a deep, seemingly middle-eastern inspired, quasi-religious epic space fantasy, literally came with its own glossary for the hundreds of unique words created, comprising Herbert's terminology to describe the desert world and the ruling forces that came to acquire and exploit the universe's most valuable commodity, Spice, a drug that allows interplanetary travel. It was the nerdiest of science fiction novels, and I read it several times in my teens.

Many of you may remember the David Lynch version of Dune, produced by the infamous Dino DeLaurentis, from 1984 with Kyle MacLachlan as the lead, Patrick Stewart as his loyal protector, and the musician Sting as a psychotic bad guy. The film was underfunded and underwhelming, and took liberties with the source material to get in under two hours. This version of Dune deserves the terrible reviews and shouldn't be watched by mistake... on purpose; it's worth watching for its Lynch-like weirdness.

Denis Villeneuve directed the new Dune film(s) and treated the source material with the reverence, time, and budget it deserves. Dune Part One came out in 2021 and is available on streaming platforms today and worth seeing (again) before heading to the theaters to see the second film, Dune Part Two, which came out this past month. The refresher is appreciated as we are reminded of how we got to this point in the movie (and allows those of you unfamiliar with the plot to catch up.)

As is often the case, the first film, though enjoyable, ultimately left you wanting, knowing there was going to be a delay between the two films. The disappointment of our hero losing those closest to him, his legacy and control over Dune and the Spice, was certain to leave you depressed, but hope remained at the end of the first film, a lone, iconic shot of a man riding a 400-meter sandworm, slicing through the desert. So cool. Watching the first film again with close captioning on was invaluable. The movie(s)



are long, and the verbiage echoes the novel without the glossary, so it's easy to miss some details.

The second film was worth waiting for and is a thoroughly satisfying resolution of the adventure I enjoyed reading so many times back in the 70s. Starring Timothy Chalamet, Zendaya, Rebecca Ferguson, Jason Momoa, and Josh Brolin among the star studded cast, the film(s) follow the coming of age of the humble son of a great family, thrust unwillingly to accept his Messianic destiny while battling the universe's inherent evils with his only allies his pregnant mother, a powerful religious cult leader, and the Fremen of Arrakis, the actual name of the desert planet called Dune.

Frank Herbert wrote a series of novels about this world he created, and these two three-hour movies encapsulate everything I could ask for from the first book. Sadly, they do end the film implying a third film, which is apparently in early preproduction. It will not be coming out anytime soon, and possibly not even this decade. I hope the final film in this trilogy is as masterful as Dune Part One and Part Two deserve.

Flames a Hot Commodity

This month's restaurant review comes from Flames Modern Mediterranean Grill in Melbourne. Located in a strip mall at 1270 N. Wickham Rd, Ste 40, Melbourne, FL 32935.

The restaurant's interior is modern, and plenty of seating fills up pretty quickly during peak hours. On certain days, live entertainment includes musicians and belly dancers (see their website at www.flamesgrille.com for scheduled events), which draws a crowd!

The menu is a Lebanese-inspired Mediterranean offering with various dishes that are both vegetarian and protein-based.



The first dish on the table was the cold appetizer plate, which consisted of delicious, fresh-from-scratch samples of chick-pea hummus, baba ghanouj, a delightful smoky eggplant spread, tabbouleh, a bright lemon-dressed parsley-based salad, and grape leaves stuffed with a tomato rice and beef mixture (vegetarian option available) served with fresh pita wedges. Nothing disappointed! In fact, it was some of the best versions of those I have tried.

Our main meal was a triple skewer mix (beef, lamb, and chicken kabobs) over the best jasmine rice I have ever had at a restaurant, accompanied by more hummus and some grilled vegetables. Ask for an extra

EDITOR'S NOTE: In the past few months, I have received letters asking me to take on a variety of "missions." Some have asked me to get behind investigating the water company, a valid effort, and a potential story, if someone else wants to write it. I've been asked to champion the petition to have the trains stop blowing their horns past 9 pm at night, but I actually feel this effort belies the danger of people not paying attention or doing dangerous things, like driving around train barriers. I've recently been contacted about changes in government-issued loans (Fannie, Freddie, FHA, VA, etc.) that will require "replacement cost" insurance policies for any manufactured homes with mortgages. This story will be told in a future issue, but it also plays into what I see as my mission. We must reimagine what Barefoot Bay will look like after the next big storm, considering the negative effects increases in insurance premiums have had on our current residents, the increased cost of replacing your home in the event of a disaster, and how insurance companies continue to depreciate manufactured homes while promising little in the way of compensation if you actually have to file a claim.

For years, we could purchase insurance at a reasonable price for our homes. We were happy with a \$100k policy if our home was damaged or lost in a storm since many of us purchased in the "golden years" when you could buy a really nice home in Barefoot Bay for \$100k, and many could be purchased for significantly less than that. With dramatic increases in the cost of insurance in just the past few years, we're on the edge of a precipice. Many people want to blame the insurance companies. Understandable, but they're in business to make money, and they do the long math before they issue those insurance policies.

We live in Florida, which has a coastline of 1350 miles along the Gulf of Mexico and the Atlantic. Storms are bigger and more powerful, and prices have risen dramatically for everything, including building materials, appliances, infrastructure, etc. Insurance companies know the risks and charge them accordingly. We accepted those risks when we decided to live here, for all the right reasons, of course. Many of our residents are on fixed incomes, and though they may own their homes, the increase in insurance premiums (and everything else) is causing some to cancel their windstorm coverage. For those that have mortgages (I have one), the inability to find insurance coverage at a reasonable cost (especially those that will be required to have "replacement cost" insurance) could force some to sell or outright lose their homes to foreclosure. This is a serious problem. Price control is not a viable option, and the price of insurance will ceaselessly continue to rise for everyone, including those on Citizens.

Florida got lucky last year when the single storm we had in August 2023, Hurricane Idalia, a Category 3 storm with 125mph winds and a huge tidal surge, took the shortest path through the least populated part of the state. That single storm still caused \$3.6B dollars in damage. Imagine not one storm, but several like we've had many years, including 2004, when Barefoot Bay lost almost 900 homes to those back to back Category 2 hurricanes, Frances and Jeanne.

I've been told that approximately 5% of homes that are currently insured through local agents have dropped their windstorm coverage. If that were true of all homes in Barefoot Bay, we currently have almost 250 homes that are not insured for a hurricane. I believe there are many more, and expect this number to rise as insurance prices continue to go up every year.

Please send us a letter informing us of your current situation regarding insurance. You can remain anonymous, but we prefer to hear from people who currently live in Barefoot Bay. Consider answering the following questions. Do you own your home? Are you on a fixed income? Do you currently have windstorm coverage? If yes, how much is your premium, and how much coverage do you have? Do you intend to keep windstorm coverage regardless of premium increases? In the event of a hurricane and total loss of your home, what is your plan regarding rebuilding? Can you afford to clear your lot and build a brand new double-wide manufactured home with or without your current insurance? Will you need a mortgage to rebuild, and will you be able to afford the mortgage payment, taxes, and insurance premiums on a brand-new home that will easily cost \$200,000? Add any additional comments you think are pertinent to the discussion. I'll publish the results of this informal survey in a future issue of The Tattler.

creamy garlic dipping sauce; it's divine! The meat was cooked perfectly—lamb was our favorite, and there were seafood options for skewers as well.

The house salad was perfectly dressed in an olive oil and lemon-based dressing with feta cheese, tomato, and purple onion. I could have that salad every day! It was fresh, light, and perfectly balanced.

We tried two desserts, and bringing the rest home was necessary after the meal. The baklava was a sweet, rich balance of honey, flaky pastry, and nuts, and the unique Ossmalier nest of sweetened cheese, pastry angel hair, and sweet honey topped with rose water cream did not disappoint. Both are shareable, in our opinion!

The waitstaff was delightful, and this family-operated business will soon be adding a Vero Beach location as well.

We highly recommend it and look forward to our next visit!
