Fee Schedule for Services Revised January 2024

General

Our clinical nutrition and cancer coaching services are not covered by insurance. We try to keep our rates as affordable as possible and provide our clients with high value support, guidance, products and programs. We specialize in supporting cancer treatment but also offer nutritional support for other conditions such as diabetes, cardiovascular disease, digestive disorders, arthritis, obesity, autoimmune and emotional imbalance. We also offer anti-aging support through scientifically validated nutritional and lifestyle interventions. Our philosophy is minimal supplementation and we do not prescribe a shotgun approach.

Initial Consultations

NORI provides no-cost initial consultations to anyone interested in our Nutritional Support Program or other services. The consultation may last for up to 30 minutes. Consultations can be in-person, by phone or Zoom.

Nutritional Counseling/Coaching

Nutritional counseling for cancer patients and for individuals with other conditions is offered at an hourly rate of \$125 USD or 30 minutes at \$75 USD. Adjustments to this fee can be made for those with limited income. Billing is in one hour or 30 minute increments.

Nutritional counseling is conducted in-person, by phone or over Zoom. Payment may be submitted through the NORI website DONATE page using any credit or debit card, Zelle or paid at the time of service by cash or check for in-person consults.

All counseling and coaching is provided by Mark Simon, Director, NORI.

Home-Based Nutritional Support Program

NORI offers a comprehensive home-based nutritional support program that includes all the necessary supplements and nutraceuticals with the exception of natural hormone blockers. The program does not include OTC or off-label drugs. All supplements are formulated and manufactured in-house by NORI Nutraceuticals.

Our program does not include methioninase which is an optional supplement to support a methionine restricted diet. Methioninase can be obtained from Dr. Robert Hoffman, AntiCancer, Inc. Dr. Hoffman can be reached at 619-885-2284.

The NORI Nutritional Support Program includes:

- Unlimited nutritional counseling, coaching and general support provided by Mark Simon, Director.
- Access to our private online support group.
- All necessary supplements and nutraceuticals required for the home-based nutritional support program. NORI will provide new nutraceutical products at no extra charge as they are developed. The NORI protocol has recently evolved into a ferroptosis inducing protocol which is believed to be more effective in killing cancer stem cells.

Plan A- Lifetime Unlimited

NORI offers the complete nutritional support program for a one-time fee (donation) of \$12,000 USD. The program is home-based and available worldwide. This is a lifetime program with no additional fees for NORI products and services. Clients outside the United States will be responsible for shipping charges. Nutritional counseling and general support is fully covered and unlimited. Other family members within the home may receive nutritional counseling at no charge.

Plan B- Yearly

NORI offers a yearly option for a one-time fee (donation) of \$4,950 USD. Everything in Plan A is covered. After one year, one may choose a monthly payment of \$495 USD for continued support, supplements and nutraceuticals. Installment payment plans can be arranged. Clients outside the United States will be responsible for shipping charges.

Plan C- Monthly

A monthly plan is available for \$495 USD per month. The first month is \$795 USD to cover extra consulting time for diet coaching and staring phase of the nutraceuticals. An additional shipping charge will be billed for clients outside the United States. This plan covers all supplements and nutraceuticals plus unlimited nutritional counseling and coaching.

Plan D- Nutraceutical Kit

This is our lowest cost option to implement the NORI protocol. We offer a Ferroptosis Induction Nutraceutical Kit for \$295 USD including domestic shipping. International shipping is an additional charge. The kit includes all nutraceuticals necessary to implement our ferroptosis protocol for 1 month. Detailed instructions are included.
