#### **SNOW REMOVAL**

Reminder - there will not be any snow removal for snow two inches or less. There are two containers by the mailbox that will have ice melt, not only for the area around the mailboxes but also for steps and driveways. Ice melt should not be used on brick. It will degrade the brick.

Steps and sidewalks will not be shoveled unless they are accessible....

Section 7(b) Yard Signs:

One Political yard sign per unit may be displayed within two weeks of a primary, general or special election provided it is removed within 48 hours after the election is held. A "political yard sign" is a sign that endorses a specific candidate, political party or ballot initiative. NO POLITICAL FLAGS ARE APPROVED IN THE ASSOCIATION AND NO OTHER FORMS OF POLITICAL ADVERISEMENT OTHER THAN A SIGN ARE PERMITTED. The sign may not be larger than 18x24 and must be confined to the Unit owner's front yard.
