- I. Special Presentation by Corey Nelson, owner of Bats and Bugs.
  - The Board invited Bats and Bugs to address the issue of bat mitigation. Several owners had bats removed from their attics at a considerable expense. The Board felt it prudent to advise owners of alternative solutions and invited Bats and Bugs to address the issue and provide solutions. See attached email to owners from Jeff Horner recapping the meeting/presentation.
- II. HOA Dues: The Board asked Jeff to analyse the budget and determine if the projected HOA dues were sufficient to meet the budget. The HOA reserve account has been decreasing and based on projected expenses would fall short of the desired goal of maintaining a reserve account equivalent to one years operating budget.

The Board agreed that an increase in HOA dues was preferred verses an assessment. An increase of HOA dues effective July 1,2025 to \$300 per month from \$275 per month was proposed.

A motion was made and seconded and approved. It was noted that the Board had authorization to increase the dues as it was less than a 10% increase, per the Covenants.

- III. Agenda for the Annual Meeting: Ron submitted the Annual Meeting Agendas for the past 3 years and asked for comments regarding the content and format. Included in the Agenda was Board term expirations. Carol Fisher and Art Holcomb terms expire.
- IV. Adjournment: A motion was made to adjorn, it was seconded and approved.
