ANNUAL MEETING MINUTES
Date: September 30, 2025**

CALL TO ORDER: 7 p.m.

ATTENDANCE: Board Members Janet Johnson, Charles Keith, Keith Sandvig, Karen Douglas, Ellen Vanderhoff, Property Manager, Jeff Horner Homeowners: 42 units in attendance plus 1 guest.

PROPERTY MANAGER: Introduction of Jeff Horner, Property Administrator by Keith. Jeff provided a short history about himself, his partner, and company. An explanation of the Board of Directors was made describing how to access, and set-up, pertaining to maintenance notices, maintenance work orders, etc. Forms were distributed addressing how the portal appears once set-up individually by homeowners.

TREASURERS REPORT: Keith reported \$56,000+ in checking, \$83,000+ in savings at the end of August. Jeff pulled a combined cash balance and reported \$156,000 total, that is before new bills were paid.

RETAINING WALL: A preliminary survey basically laid out where utilities, etc. are located. Forms were available. Next process will be getting soil samples. This will be a long, on-going process.

PROPOSED AMENDMENTS CHANGES:

COVENANTS: Article 13 Section 2:

No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any Lot except for no more than two (2) pets: one (1) dog & one (1) cat, two (2) cats, or two (2) dogs. Pets may be kept provided they are not kept, bred, or maintained for any commercial purposes. The association may, by rules and regulation, prohibit or further limit the raising, breeding, or keeping on any lot, front lot, or rear lot, of any pet. Dog breeds need board approved and can be excluded if they pose potential risks. Discussion and debate held. Vote taken by show of hands. Motion Passed.

COVENANTS: Article 13, Section 4:

The owner of each unit shall keep the same free of weeds and debris within five (5') feet of said structure (units, deck/patio). If not adhered to, a 30-day notice will be sent to complete. If not accomplished in the 30-day period, the association will finish and unit owners will be assessed the final charge. Discussion and debate held. Vote taken by show of hands. Motion Failed.

ELECTION: Nominations were asked for from the floor, no additional names were added to the ballot. Keith Sandvig running for re-election. Motion made to accept Keith for a 2-year term. Passed.
