NOW, THEREFORE, IT IS HEREBY RESOLVED THAT the Board of Directors duly adopts the following policy:

All homeowners will be required to attend the Annual Members meeting or Special Meetings. If homeowner is unable to attend such meeting, a proxy must be signed and presented to the association no later than 24 hours before the meeting is called to order. Failure to attend meeting or submit a proxy for attendance will result in a \$100.00 fine, payable within 30 days. Late fees may apply.
