ANNUAL MEETING MINUTES May 5, 2025 TRADITION CLUBHOUSE

CALL TO ORDER: 7:30 PM

BOARD MEMBERS PRESENT: Nate Burnham, John Collins, Jim

Hoffmann, Dennis Pate and Debbie Ver Ploeg.

QUORUM: 31 Owners, 8 Proxies, Total 39 = 57.3%

MINUTES: The minutes from the last annual meeting have been received and filed. The minutes were previously sent via email to the Association residents. It was moved and seconded to approve the minutes from the 2024 annual meeting. Motion passed by voice vote.

ELECTION OF BOARD MEMBERS FOR ONE POSITION:

Dennis Pate was the only candidate. Motion and second to elect Dennis was made. Motion carried by unanimous voice vote.

FINANCIAL REPORT:

Nate Burnham reviewed the Financial Report pointing out several important areas, such as reserves, and insurance. Cash on hand is \$145,187.

WORK ORDER UPDATE:

Jeff Horner reviewed all the work orders now waiting to be handled by vendors. They are: Replace poolhouse doors, replace back door of clubhouse, and repair fountain. Anyone needing **mudjacking**, please contact Jeff Horner.

CLUBHOUSE:

Thanks to the volunteers who keep the clubhouse clean.

GROUNDS & LANDSCAPING:

Trees and bushes in the stones are the responsibility of the homeowner. Contact Debbie Ver Ploeg if you are interested in having Matt Umland from Urban Farmer help you with landscaping needs.

There is a fungus on the Ash and Maple trees due to the warm weather this winter. It will be killed off with hot weather.

LAWN MOWING:

We are trying to improve our lawns. The target height for mowing is 3 ½ to 4 inches tall after mowing. The current robotic mowers cut off approximately 1/8 inch each pass. Over time this will allow deeper, healthier root systems and better natural weed control. Please **do not mow** yards. Please do **not** pick up or move any of the robotic mowers. They will over time "learn" their routes.

IRRIGATION:

Irrigation will begin this coming week. On days of irrigation, the lawns will not be mowed.

POOL:

Repairs to one pool gate was done by several Board members for a fraction of the quoted price for repair. We thank you for your good deed. Barring other problems, the pool should open by Memorial Day. New signage will be put up. These include Pool Rules, Private Pool, and warning signs on Pool House doors.

All restrictions on the usage of the pool by guests on certain days of the week or times of the day are lifted. We encourage you to use the pool, but please remember all guests must be accompanied by a resident when in the pool area.

INSURANCE UPDATE:

The Board continues to evaluate the best options for our needs. With moving to a 5% deductible on insured value for wind/hail coverage, the Board is strongly encouraging all homeowners to have at least a \$20,000 loss assessment rider on their house insurance.

It was moved and seconded to adjourn the meeting at 8:50. Motion carried by unanimous voice vote.
