I accept liability for all damage, injury, loss or loss of life (present or future) that may be caused by my negligent and/or intentional conduct during the event, to any person or property and undertake to pay all claims on demand. In the case of a minor in my company (or in my absence), participating in the event, I give him or her unconditional consent by my and his or her signature as may be required by law to sign this disclaimer and to participate in the event.
