LIFE DOLLAR

When we realize the root of a poison weed which grows in our garden is humanity's true ailment, one eventually refuses to yield to a system which aims to enslave every man and woman on God's green earth. This work is my passion. I fully intend to refine the idea fuel that powers the motor of self determination.

I am Henry Slater Clifton and I am a working man living on the land. This is my testimony.

The Life Dollar, Pound, Peso, Yen etcetera should be a unit of base labor in comparison with the numerous elements of an economy within historical ratios of comparison within the market of trade.

A single unit of base labor of one hour establishing the recognizable value of each single fungible unit is the stable standard. This value should be maintained by regulating the aggregate unit's supply within the float of the active marketplace wherein true tangible price discovery takes place.

This work will fully explain how we as honorable people deserve an honorable just currency which rises to the level of sound money.

Currency and money are not the same. A currency is a fungible unit of exchange. It is a proxy for time, commodity and energy. Money is all of this with the added bonus of retaining it's purchasing power for long periods. The key aspect of a currency maintaining a status of true money relies on the people's faith and trust being fully earned by it's managers.

This is achieved by maintaining a stable aggregate supply in ratio with the population, it's energies and conceptions. No tax is required to fund the creation of money. Money is earned by merit against risk. The solution to usury is transparent future profit agreed to by the borrowers.

The Federal Government should be fully funded by issued currency without bondage. The people should borrow their future money which can fund local and state government by principal payments to state Treasuries.

Excess currency is returned to Federal Treasury and either deployed or destroyed in order to restrict the growth of the money supply. This feature allows the currency to maintain a stable value against the ratio of goods and services within the greater vibrant economy.

There are no direct taxes needed within this system's structure. The chartered Banks provide the service of ledger entry and account record with no risk of failure.

This plasma money engine is called the "Helios Mechanism".

All current unfunded liabilities are funded in the future by recycling existing money or issued new money. Money returning to source before flowing back through the vibrant market prevents price inflation by restriction.

This ends the forced growth for growth's sake of our current condition which results in massive misallocation of resources. The Usurus Mandrake Mechanism is a moral hazard which is a form of slavery. Money creation is to benefit the people directly which will end manufactured scarcity.

Humans require meaning. The source of meaning is perceived value from participation.

When one contributes to an economy the reward is in the greater knowing of others benefitting from one's participation. This is being part of something greater than one's self.

Labor and conception are the basis for meaningful existence. Humans need to physically be a part of the established value. Humans require property which is earned. We also require victories.

Humans also require the universal understanding that they own the first property which is their physical existence. Nature's God has granted them this and is therefore their absolute right.

The Human body is the property of the soul born within it. Any alteration or external occupation is a crime against humanity. The first property is sacred and must be protected by government and its monopoly of violence.

A commercial property tax is allowable as well as sales taxes which may be used by states and their counties to supplant infrastructure.

Commercial bank depositors may choose to purchase Sovereign Trust bonds which fund Supplemental Solvent Retirement Fund personal accounts. Individuals should be permitted to augment their personal retirement. Sovereign Wealth Trust bonds are an internal domestic social safety net. This program is to be isolated from speculators.

LAW

Law is an acronym meaning Land, Air and Water. Most lawyers and law professionals recognize two. I intend to establish the need for a third which is Air.

Law of the land jurisdiction apply to criminal activities which injure or violate natural rights. Law of Water jurisdiction applies to commerce and entities of fiction. Law of water uses language of shipping. This jargon describes contracts. Law jurisdiction of Air deals with concepts and broadcast or media. With so many aspects now being digital we require this third jurisdiction which may overlap into each jurisdiction.

The rule of law must be restored fully in order to attain a just existence. We all must fully comprehend all three jurisdictions. Law is what separates our species from the savagery of the animal kingdoms.

Every human being deserves a climate in which they can exist with self determination and self ownership. No man or woman may ever sink to a level of another's property. This fact must be fully comprehended and maintained by all governing bodies.

No government has a right to compel a living man or woman to adhere to any color of law at odds with their owned existence.

HELIOS MECHANICS

The Life dollar's plasma like structure allows it's managers to restrict it's creation in order to retain purchasing power stabilizing price discovery. The Helios Mechanism creates new money by issue allowing it to recycle through the economy eliminating the need for exponential increases in aggregate number.

Treasury will have power to destroy units as needed eliminating usury and distortions caused by excesses of borrowing. When government orders new infrastructure it simply issues new currency which pays contractors and vendors. This currency enters the economy and banking systems.

The Commercial Chartered Banks create new currency by ledger entry through loans or credit. The debt is not their property. Commercial Banks provide a service. They do not risk assets. All risk is the borrower's.

When the Life Dollar is created the borrower enters a contract based on their Merit which is an assessment of their history. Each debtor earns a merit score assigning a percentage to be added to their debt principal to be payed back within a term of time.

The lower the merit score the lower added profit is payed. The bank and it's depositors are awarded the contracted profit while principal is sent to state treasury.

The state treasuries supply currency for infrastructure. The state treasuries send excess currency to the Federal Treasury wherein the units are deployed or destroyed.

Through this mechanism the aggregate supply of money within the open market will run within a channel providing price stability.

The House of Representatives has oversight power over the Treasury Department to ensure lawful enactment.

The Internal Revenue Service will audit all levels of government in real time ensuring accountability and integrity maintaining faith.

GLOBAL RESERVE

The current paradigm's debt can be made into a global trade currency or declared fraud and eliminated. If the trade currency is chosen participation requires a navy to patrol shipping lanes and a frozen bond complex with a 2% yield to be payed to service out the legacy debt of each participating nation.

The Global Reserve will be a 30 year pact to manage international trade while converting today's debt into a service asset that benefits humanity.

The entire planet can abolish usury and cooperate instead of war over resources.

Debt is not money. This concept is completely repugnant and belongs on the scrap heap of history. Debt currency is public slavery and only benefits the central banker.

Don't think this concept of liberation is unachievable. Everything is possible. The people ultimately decide what money is acceptable. When given a choice the people will choose a money that serves them justly over a system that forces them to pay for their mere existence.

This concept is not Marxist or Fascist in any way. In fact the Sovereign Trust Paradigm breaks the Marxist cycle which is Free Markets leading to Socialism which erodes into communism.

Once communism fails the people rise to establish free markets.

Communism has a history of murdering many to establish its extortion. The Sovereign Trust Paradigm breaks this cycle by outlawing usury and abolishing any taxation on private property.

By offshoring Sovereign debt the world can isolate the owners of current debt and assess if that ownership was achieved through legitimate natures. Any evidence of past fraud or profiteering from unlawful activities will result in the prosecution. The current paradigm is the largest RICO case in human history.

The planet's banking families who sit in anonymity won't have the luxury of opaque existence. All will be revealed.

The crimes against humanity will be exposed for all to see.



A JUST EXISTENCE

The Trust Dollar or what I personally call the "Life Dollar" is a pro-life concept. When money literally is the energy of existence our meaning is allowed to shine through.

Our true meaning is to achieve better tomorrows for those not yet born. This idea is an action of love. Our duty as individuals is to overcome and experience victory over unjust features of our personal lives. This requires thoughts and labor. This truly is the meaning of life.

I fully intend to forward the liberation of humanity by promoting the abolition of usury.

We must stand and demand the end of barbarism.

We must adopt restrictions to prevent abuses. When one borrows into their future they mustn't exceed 75% debt payments to income ratio.

Within this new monetary paradigm is the tendency to create excessive amounts of new currency. The remedy for this is to eventually recycle excess currency from holding account which will prevent the creation of new currency that will cause price distortion by inflation of the currency supply.

This is the essence of plasma mechanics. Once price stability is achieved the currency supply is made stable by the recycling system.

In the near future the economy will experience exponential efficiencies caused by Artificial General Intelligence. This will lead to imposed Moore's Law.

A Just solution for this negative is not a Universal Basic Income. Companies utilizing technology which replaces people must pay for this luxury by funding the former employed at 60% value.

The replacement insurance deploys existing currency. The compensation prevents devastation but incentivizes the formerly employed to seek new employment.

Companies may choose to employ organic Intelligence over Artificial Intelligence.

Within the Sovereign Trust Paradigm exists the ability to fully fund and make solvent currently unfunded liabilities which are inflationary.

When depositors are awarded bank profit their awards can be diverted to a Sovereign Wealth Fund which pays for programs like a Supplemental Solvent Retirement Fund and Health Assisted Life Obligation Fund. The recycled bank profit awards serve the contained socialist contract which is voluntary.

The Health Assisted Life Obligation Fund would pay for every American's emergent necessary medical procedures which removes risk from health insurance providers. This drives down prices making insurance affordable.

So both banks and insurance companies have virtually zero risk while the people are no longer preyed upon by a parasitic banking cartel.

Many things that plague our nation are born within the monetary paradigm. It is well past due we abandon easy money for accountable and lawful systems.

These systems are becoming the instruments of enslavement.



SATURATION

There will come a point where enough currency has been created to have a complete loop of cycling currency entering and leaving the market to create a balanced flow.

The payouts from Sovereign Trust funds will enter and flow in and out of the economy. Borrowing will come from formerly borrowed currency re-entering the economy on demand.

This is when new money creation will be limited to increases in population. Contractions may also naturally happen. The Treasuries will have stowage accounts which are made up of the excess currency units not needed.

The key to any currency maintaining its value and or purchasing power is its supply in ratio against the goods and services within the economy.

New products, inventions, innovations, efficiencies or rises in quality also are factors in the price discoveries. Markets are ultimately in charge of true price discovery.

This construct is not a Utopian model. it is merely a basis for an engine to coexist without intrusion into the individual's decisions. You deserve a money that isn't a construct of enslavement. It's concept is the results of an unjust condition. It is an attempt to apply the spirit of the 4th Amendment.

You deserve to exist without compulsion or manipulation. Your merit score determines your risk profile.

Your deposit and payment history as well as your employment climate determine profit added and length of term. Compounding interest or usury undermines both you as an individual and your current currency's value.

Usury is enslavement. It must be abolished. It's beneficiary must pay back with damages the harms their system of inequities have caused.

Declaration of Sovereignty

When in the course of human events, it becomes necessary for a people to reassert the rights which the Author of Nature and Nature's God has endowed them, and to dissolve the fictitious powers which trespass upon those rights, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to such separation.
