

SOVEREIGN TRUST PARADIGM PRINCIPLES



Preface

National Usury is not Capitalism. The accepted status quo as a free market is nothing more than a scheme to fleece the population of it's ability to function as valueable entities.

Human beings are meant to live free and have complete mastery of their condition. Private property and personal agency are primary staples of a free people. Any instrument that undermines the self determination of individuals is repugnant. We must be protected against the insidious constructs of compulsion usury causes.

The self determination of every soul must be fully realized. We must therefore abandon the false markets of Bondage. Debt is not money. Debt money is an impossibility and is destructive to humanity.

This document will explain the principles of Proprietarianism. You are born sovereign. Your body is your first property. All other earned possessions are extensions of that first property.

This document will fully explain a new monetary possibility which frees the population to become masters of their collective destiny. America has been controlled by a small number of evil organized individuals. Your new trust dollar and it's mechanics will liberate your earned condition.

The time has come to safeguard our future by defining the crimes of treason and their funding. This largest RICO case in human history will be unwound for all to see. Our money needs to be restored to it's status as a rightful true measure. No longer shall our standard be a shrinking distance withering against time.

Trust Dollar

The new trust dollar must be based on one hour of entry level basic labor in comparison of the economic ratios of commodities, energies and properties. It's supply must be managed in a way as to ensure true market price discovery. Management of our currency supply will establish a perceptive truth causing the dollar to rise to a just level of sound money.

The dollar shall be created by the public's demand borrowing into their future entered by ledger entry. Eventually a sufficient supply will be realized as to borrow old money which is then recycled into the market as to not increase supplies preventing price rise by inflation. New Capitalization will always require new currency be created while simple credit can be supplied through Treasury to the banks directly. Thus is the mechanics of Helios plasma.

Meritocracy

All demand side economics requires risk assessment be the arbiter for our money creation. A Merit Score must determine the level of risk along with a set profit award to be payed first to the bank which is the chartered entity who provides the service for both Sovereign National and commercial enterprises.

A Merit Score shall reflect a status capped at 50% added to any loan or credit for highest risk. A low risk score is limited to 5% added to a loan. Terms are set by banks and state Treasuries.

Individuals currently paying 75% of their deposit income as debt will have reached their allowable limit. The public must be protected from a predatory over leverage. Commercial entities may have limits of 100% added to loans or monthly revolving credit.

The House of Representatives shall oversee and create basic laws for the Treasury to benchmark. States will meet Federal base laws and have power and flexibility to exceed Federal regulations.

Giving states the power to charter banks and set rules governing risk assessment and profit award standards which pay depositors allows each state to compete against each other.

Each state has varying needs based on climate, land type and population mores. What's good for Rhode Island may not be favorable in Kansas. etc.

States may have allowances for various regions within a state based on land type and favorable activity.

A stable existence within a system that doesn't require growth due to a debt accrued by government is the goal as to limit the size and scope on a federal level.

Taxation

The need for property and income taxes are nullified by principal payments being sent to State Treasuries. Municipal fiscal requirements are submitted monthly to the State's Treasury for distribution. The County's requirements are also submitted by quarter. This is a suggested structure. Each state may vary.

The state's budget requirements are also set on a yearly basis wherein moneys collected are sent to fund each department. All budgets are submitted in digital ledger to the Federal Treasury. All overages are Federal accounts. Any overage is then held by Treasury to fund directly the needs of public and commercial lending. New currency is created when Treasury's stowage accounts are depleted. Once sufficient lending and payments have caused an equilibrium, no new money creation is needed. Old paid money then recycles through the system creating a feedback loop.

This feedback loop is a plasma like structure known as the Helios Mechanism. There will be times when the Federal government will run short of currency due to a lack of borrowing. A sales tax must be adopted in order to create negative drag causing some lending to occur. The National sales tax may be set to an automatic trigger creating a temporary stop gap feature to bridge near term shortages.

The House of Representatives must therefore reassess the need for government programs in order to prevent misallocation of government and moral hazards.

Once 95% of Americans own their familial dwelling outright a wealth effect will take place. We today are in danger of dooming large percentages of the population to a loss of faith in the dollar by over leverage. When a population reaches a point wherein they must decide between a dwelling or food. This is when people in mass revolt.

When a home cost exceeds 40% of overall income the people will need to decide whether to eat or lose energy, transportation and or fail on other obligations once affordable.

Under today's conditions American Commercial entities and the population at large owes \$52 trillion. The principal payments on this debt would equate to \$16 trillion this next year. All government, Municipal, County, State, Federal including Social Security and Medicare will spend \$14.1 trillion. This fact makes it possible to outlaw usury and or compounding interest in favor of a debt free currency. There is no need for a central bank, national debt or debt currency. Sovereign Usury is then replaced by a Sovereign Trust. The banks are then a storage facility and ledger recording body accountable to the state and federal government. The people or Sovereign Nationals are borrowing their own money in the future with set coherent restrictions protecting their interests.

The Helios Mechanism breaks the Marx cycle wherein Capitalism erodes into Socialism due to the unproductive voting themselves money through a pandering political class. Corporate welfare is also eliminated by our construct. White collar crime becomes visible to every level of oversight. This system will save the public \$500 billion every year in compliance costs alone.

Corrupt money laundering institutions like tax free foundations will be abolished in favor of fully transparent crowd funding entities.

Organized crime has nowhere to hide within our system. Every part of banking is transparent at all levels. Internal Revenue will audit all government departments and agencies at all levels in real time. Artificial General Intelligence will make this possible and effective. Using A-I correctly and honesty can improve our lives. Today safeguards are lacking which may lead to our extinction.

Current unfunded liabilities like Social Security and Medicare will be fully solvent. Each are \$100 trillion with no method for future funding other than debasement. The Helios Mechanism along with efficiencies found when eliminating fraud, waste and abuse by government will be discovered and done away with. This concept is a radical well needed change. Our current leadership is void of proposing limitations of grotesque natures upon our people. They call us useless eaters.

When borrowing slows due to mass ownership, a Federal retail sales tax will be adopted to bridge the gap and fill overage for the recycling of currency replacing new money creation.

Discharging Bondage

In order to make right, a settlement must be made to the domestic bondholders. The assets of the Cartel known as the lender of last resort and its shareholders must be seized and set to auction eligible of purchase by Sovereign Nationals only.

Foreign bond holders shall be made full on the remainder of former national debt. The Federal Reserve note shall be made an international trade instrument.

The former national debt is then off shored. Bond issuance is permanently suspended. Participation by international trade entities shall pay a 2% yield on all outstanding Federal Reserve debt.

The trade participants shall enjoy the protection of the United States Navy. The United States navy shall patrol all shipping lanes in exchange for the debt being payed over the next thirty years.

Trade partner nations also will have the option to dump their debt and assist the United States Navy creating an international treaty of trade. This Jubilee on the High Seas will usher in a new age of peace and cooperation.

This international cooperation will eliminate wars, end scarcity and wipe out poverty currently plaguing humanity at large. We can have a better world.

Framework

- Compounded Interest is abolished in favor of transparent profit awarded to banks.
 - Bank Awards are payed first.
 - Bank Awards are split with depositors.
- States set minimums awarded to depositors.
- Banks compete for depositors and loans.
- Principal on loans and credit are surrendered to State Treasuries.
 - State Treasuries dispurse principal to Counties and Municipalities as well as state departments.
 - United States Treasury overseas and audits all lower entities.
 - Federal Treasury receives overages from states funding Federal Government.
 - Internal Revenue Audits all levels of Monetary Infrastructure and Federal Government.
 - Terms of endebtedness is cut by two thirds on average.
 - Federal Sales Tax is implemented to fill gaps and fund Sovereign wealth fund paying current unfunded liabilities.

Jurisdictions of Law

A new Accredited Registry shall establish three jurisdictions of Law. Land jurisdiction applies to the physical man or woman. Air jurisdiction applies to Data, Broadcast, Intellectual Property and Copyright. Water jurisdiction applies to commercial code and contracts both corporate and government exposures.

The general public is required to comprehend which jurisdiction applies to any and all situations. This is imperative to a nation with ownership.

The protection of clear understandable law in charge of the protection of private property is the essential tenant of a free and prosperous people. Our laws must be enforced with vigor and fairness.

All Sovereign Nationals must enjoy the fruits of our land yield and resources. The protection of which is paramount to a future filled with prosperity.

Earned Voting

Declaration of Sovereignty

Sovereign Trust.
